#### RESOLUTION 1/45-POA ON THE OIC-2025: PROGRAMME OF ACTION

The Forty Fifth Session of the Council of Foreign Ministers, (Session of Islamic Values for Sustainable Peace, Solidarity and Development), held in Dhaka, People's Republic of Bangladesh, from 19-20 Sha'ban 1439 H (5-6 May 2018),

*Referring* to the objectives and principles enshrined in the Charter of the Organisation of Islamic Cooperation;

**Recalling** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia, on 6 to 7 Dhul Qeadah 1426H (7-8 December 2005) adopting the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21<sup>st</sup> Century;

**Recognizing** the support and assistance extended by the Member States, institutions in the OIC system including Standing Committees, international partners and other relevant bodies in the implementation of the TYPOA which concluded in December 2015;

**Further recalling** the Final Communique and the Declaration of the 13<sup>th</sup> Islamic Summit Conference (Istanbul, 14-15 April 2016) adopting the OIC-2025 as the Programme of Action for the next decade (2016-2025) elaborating a comprehensive agenda for cooperation and partnership in various priority areas to achieve in the next ten years;

**Appreciating** the Implementation Plan detailing programmes and activities in terms of 107 goals identified under 18 priority areas to be carried out in 2016-2025, which was presented to the 44<sup>th</sup> session of the Council of Foreign Ministers (Abidjan, 10-11 July 2017);

**Having considered** the Report of the Secretary General on the subject and taking note of the updated Implementation Plan 2016-2025 and the Progress Report on the Implementation of the OIC-2025 for the period 2016-2017;

- 1. **Calls upon** the Member States, the OIC organs and institutions, international partners as well as other stakeholders to undertake all necessary measures for effective implementation of the Programme of Action;
- 2. Further calls upon the Secretary General:

- (a) to widely disseminate the three key documents, namely (i) OIC-2025: Programme of Action,(ii)Implementation Plan 2016-2025 and (iii) Progress Report 2016-2017 to all stakeholders, relevant international organizations, regional bodies, UN specialized agencies as well as national authorities in the Member States inviting them to contribute in realizing the overall goals of the OIC-2025 and indicate specific activities, programmes and projects they wish to undertake ,independently or jointly, for carrying forward the stated goals and objectives of the OIC-2025 in the coming years.
- (b) to coordinate with the relevant OIC institutions including the Standing Committees and prepare annual progress report on the implementation of the OIC-2025 for the year 2018;
- (c) To give due regard to the views and observations of the Member States during the implementation of the OIC-2025.
- 3. **Requests** the Secretary General to propose mechanism for promoting effective partnership and intensive global engagement for successful realization of the goals and targets of the OIC-2025 and the 2030 Agenda for Sustainable Development for the collective good of all people.
- 4. **Further requests** the Secretary General to report on the implementation of this resolution to the 46<sup>th</sup> Session of the Council of Foreign Ministers for Consideration.
