*The Forty-third Session of the Council of Foreign Ministers (Session of Education and Enlightenment-Path to Peace and Creativity), held in Tashkent, Republic of Uzbekistan from 17-18 Muharram 1438H (18-19 October 2016);*

**Recalling** Financial Regulations of the OIC, according to which, the CFM has the authority to decide on the budget and other financial and administrative issues proposed by the PFC,

**Taking into Consideration** the fact that the last quarter of the financial year is the most appropriate time to submit the proposed annual budgets in with the new OIC financial year which coincides with the calendar year;

**Taking into consideration** the recommendations of the Special Committee Preparatory Meeting to the 43<sup>rd</sup> CFM on the General Secretariat's request to the latter to authorize the 45<sup>th</sup> PFC to approve the proposed budgets of the General Secretariat of the OIC and its subsidiary organs and IPHRC for the financial year 2017 as well as any financial and administrative issues referred to it;

1. **Decides** to grant an exceptional mandate to the 45<sup>th</sup> PFC to examine and approve, on behalf of the Council, the 2017 proposed budgets of the General Secretariat of the OIC and its Subsidiary Organs and the IPHRC; as well as all administrative and financial issues referred to it.
2. **Requests** the OIC General Secretariat to convene the 45<sup>th</sup> PFC in December 2016.
