## RESOLUTION NO. 1/42-POA ON DEVELOPING THE OIC-2025: PROGRAMME OF ACTION

The Forty-Second Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of joint vision to strengthen tolerance and reject terrorism) held in Kuwait, on 27-28 May, 2015 (9-10 Shaban 1436H);

**Referring** to the objectives and principles enshrined in the Charter of the Organization of Islamic Cooperation;

**Recalling** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia, on 6 to 7 Dhul Qeadah 1426H (7-8 December 2005) adopting the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21<sup>st</sup> Century;

**Bearing in mind** the Resolution 1/41-TYPOA on the Status of Implementation of the OIC Ten-Year Programme of Action adopted by the 41<sup>st</sup> Session of the Council of Foreign Ministers held in Jeddah, Kingdom of Saudi Arabia, from 18 to 19 June 2014;

**Recognizing** the significance of the TYPOA in providing the Islamic Ummah with a forward-looking blueprint with a view to enhancing joint Islamic action;

**Appreciating** the support and assistance extended by the Member States, OIC Institutions including subsidiary, specialized, affiliated, Standing Committees, international partners and other relevant bodies in the implementation of the TYPOA which concludes in December 2015;

**Further appreciating** the steps taken by the OIC General Secretariat including the holding of the Consultative Meeting of the OIC Institutions (Jeddah,7-8 December,2014) and the Intergovernmental Experts Group Meetings (Jeddah ,18 March 2015 and 6-7 May 2015 ) for the purpose of elaborating the new OIC Programme of Action (2016-2025);

**Taking note** of the outcomes of the above mentioned Intergovernmental Experts Group meetings requesting for more time to finalize the draft OIC-2025: Programme of Action;

**Having considered** the Report of the Secretary General (OIC/CFM-42/2015/POA/SG-REP) on the subject;

1. **Calls upon** the Secretary General to continue to facilitate the ongoing work of the Intergovernmental Experts Group for finalization of the new Programme of Action as soon as possible;

2. **Requests** the Secretary General to report on the implementation of this resolution to the 13<sup>th</sup> Islamic Summit Conference scheduled to be held in Istanbul, Turkey in 2016 for consideration.
