

Resolution
on the report of the ISSF Secretary-General on
the activities of the Federation between the second and the third session of the ICYSM

The 3rd Session of the Islamic Conference of Youth and Sports Ministers, held in Istanbul, the Republic of Turkey, on 3-5 Muharram 1438 A.H., corresponding to 5-7 October 2016

- **Having considered** the report of the Secretary General of the Islamic Solidarity Sports Federation about the activities of the Federation between the second and third sessions of the ICYSM;
- **Taking into consideration** the discussions and views expressed on the subject;

Decides as following:

1. To note the report of the secretariat of the Islamic Solidarity Sports Federation and all the activities organized during the previous period including sports tournaments and technical training and activities that aim to bring together sporting youth in the Islamic countries.
2. To welcome the hosting of the Republic of Azerbaijan for the 4th Session of the Islamic Solidarity Games during the period from May 12 to 22, 2017 in Baku and wishes of the Republic of Azerbaijan every success in organizing this great sporting event, and appreciate the Islamic Solidarity Sports Federation 's efforts to communicate with the Islamic Member States represented by the Olympic Committees of Islamic countries and urges Member States to for an active and strong participation in this session so as to achieve the desired goals of solidarity and fraternity between sporting youth on the land of the Republic of Azerbaijan.
3. To thank and Appreciation to The Government of the Republic of Azerbaijan first and foremost H.E the President of the Republic on the full support of the organizing committee and its keenness to provide the facilities and assistance to ensure the participation of all Islamic states in the session and the efforts of H.E Minister of Youth and Sports of the Republic of Azerbaijan for the success of the session.
4. To thank His Royal Highness Prince Abdullah bin Musa'ed bin Abdul Aziz, President of the Sports Federation for Islamic Solidarity for his support and his eagerness to communicate and coordinate with the organizing committee for the session in order to achieve success and excellence for this session.
5. To Invite the OIC and its affiliated bodies Organization to provide a fixed material support (million dollars) for the Islamic Solidarity Sports Federation every four years to contribute to the good preparation for the sessions of the Islamic Solidarity Games and to support all Muslim countries to participate.
6. To appreciate the Federation Council administration's efforts in cooperation with the various sports bodies related to organizing and hosting the activities of the Federation and urges the member Olympic Committees to actively participate in such activities,

which also help it to achieve its objectives in all sports fields to serve the largest segment of sporting youth in the Islamic countries and organizing tournaments and courses that work on the rehabilitation of outstanding players in various games with the importance of adhering to joint Islamic action.

7. Welcomes the joint proposal of the Islamic Centre for Development of Trade (ICDT) and the Islamic Solidarity Sports Federation (ISSF) to organize the “1st Exhibition of Equipment and Sports of the OIC Member States” from 12th to 15th May 2017 in Baku, concomitantly with the 4th edition of the Islamic Solidarity Games, in collaboration with the Organize Committee.
8. To urges the Board of Directors of the Federation to conclude agreements with specialized companies to organize and support the activities of the Islamic Union in order to ensure the continuity of the federation and the provision of financial resources to achieve its objectives for the benefit of sporting youth in the Islamic countries.
9. To take note of application to host the fifth session of Islamic Solidarity Games in 2021 by the Republic of Turkey and request Turkey and ISSF to finalize relevant procedures for holding this important sporting event in Turkey in 2021, which helps to achieve the objectives of the federation in the continuity of the joint action sports in favor of sporting youth in the Islamic countries;
- ~~10. To request the Ministry of Youth and Sports of the Republic of Turkey to organize in cooperation with ICYF-DC youth festival on the sidelines of the Games; [Deletion Proposed by UAE]~~

9. Requests the ISSF to cooperate with the Turkish Ministry of Youth and Sports and the ICYF-DC in holding youth-related activities alongside the Islamic Solidarity games tournaments. [Proposed by UAE]

11. To invite the Member States to host conferences and embrace the programs and activities of the Islamic Solidarity Sports Federation, including the Islamic Solidarity Games.
- ~~12. To mandate the ISSF to carry out the functions of the Secretariat of the ICYSM (on sports related matters); [Deletion Proposed by UAE]~~

11. Emphasizes that the ISSF should continue to serve as the Secretariat of the Islamic Conference of Youth and Sports Ministers, in coordination with the OIC General Secretariat. [Proposed by UAE]

13. To welcome the close cooperation between the Islamic Solidarity Sports Federation and ISESCO and the Islamic Conference Youth Forum for Dialogue and Cooperation to serve the youth and sports in the Islamic world in cooperation with the General Secretariat of the Organization of Islamic Cooperation.
14. To thank the Sports Federation of Islamic solidarity and Islamic Conference Youth Forum for Dialogue and Cooperation in coordination General Secretariat of the Organization of Islamic cooperation and good preparation for the third session of the Ministers of Youth and Sports in collaboration with the Ministry of Youth and Sports of the Republic of Turkey.
15. To expresses its gratitude to the Secretariat of Islamic Solidarity Sports Federation to prepare for the implementation of all the different activities of the Federation, which contributed to achieving its objectives.

16. To invite the President of the Federation to report on the Federation's activities and programs to the next session of the Conference.
17. To express its gratitude to the Government of the Kingdom of Saudi Arabia , led by Custodian of the Two Holy Mosques King Salman bin Abdul Aziz and His Royal Highness Prince Mohammed bin Nayef, Crown Prince, Deputy Prime Minister and His Royal Highness Prince Mohammed bin Salman bin Abdul Aziz, to embrace the Federation's headquarters and the material and moral support of the Union in terms of the faith of the kingdom of Saudi Arabia, to the full attention of all issues related to the youth of the Islamic Ummah.

Resolution
on the OIC Strategy for the development of sports in the OIC Member States
(2017 – 2025)

The Third Islamic Conference of Ministers of Youth and Sports, held on 3-5 Muharram 1438 A.H., corresponding to 5-7 October 2016, in Istanbul, the Republic of Turkey,

- **Considering** the outline of the draft strategy submitted by the Islamic Solidarity Sports Federation (ISSF) for the development of sports in the OIC Member States 2017 - 2025
- **Taking into consideration** the discussions and views expressed on the subject;

Decides as following:

1. **To adopt** the OIC Sports Strategy 2017-2025 (Doc. No.: OIC/ICYSM-3/2016/S-Strategy/Rev1);
2. **To invite** the OIC Secretary General to take action towards implementation of the OIC Sports Strategy by the OIC Member States;
3. **To establish** the ICYSM Permanent Ministerial Council on Sports, and to request the Republic of Turkey, in its capacity as the 3rd ICYSM Chair, in coordination with ISSF and in cooperation with the OIC General Secretariat to initiate required steps towards inviting active OIC Member States to ensure fruitful implementation of the OIC Sports Strategy;
4. **To commission** the ISSF to establish the Executive Office of the OIC Sports Strategy with the following functions:
 - a) To coordinate and follow up the implementation of the OIC Sports Strategy.
 - b) To guide the operational units in the OIC Member States responsible of implementing the Strategy;
 - c) To study and evaluate the obstacles faced during the implementation and coordination of the Strategy by the concerned stakeholders and to accordingly recommend possible remedies;
 - d) To submit periodical reports on implementation of the OIC Sports Strategy to the ICYSM Permanent Ministerial Council on Sports and ICYSM sessions;
5. **To entrust** the ISSF to lead the establishment process of operational units in the OIC Member States to follow up and coordinate the implementation of the OIC Sports Strategy as well as:
 - a) To evaluate the potential and facilities of each Member States towards implementation of the OIC Sports Strategy;

- b) To coordinate with the Executive Office of the OIC Sports Strategy in conforming the national plans on sports with the OIC Sports Strategy;
 - c) To submit the periodic reports to the Executive Office of the OIC Sports Strategy.
6. To adopt the proposed estimated budget of the Executive Office of the OIC Sports Strategy (Doc. N.: OIC/ICYSM-3/2016/S-B/rev1) and to call on ISSF and OIC General Secretariat to coordinate the development of the mechanism and budgetary plan to provide the financing by OIC Member States and concerned OIC institutions for the implementation of the OIC Sports Strategy;
7. To call on the concerned ministries of the OIC Member States to interact and cooperate with the ISSF and OIC General Secretariat to put this Strategy into practice for the benefit of youth and sports in the Member States.
