**RESOLUTION ON  
THE MID-TERM REVIEW OF THE OIC TEN-YEAR PROGRAMME OF ACTION**

*The 9<sup>th</sup> Session of the Standing Committee for Information and Cultural Affairs(COMIAC) held in Dakar, Republic of Senegal on 3-5 Dhul-qada, 1431H (11-13 October, 2010),*

**Considering** the Declaration of the Third Extraordinary Summit of the OIC, which was held in Makkah Al Mukarramah from 5 to 8 December 2005;

**Considering** the adoption of the OIC Ten-Year Programme of Action with a view to preparing the Islamic Ummah to meet the challenges of the 21<sup>st</sup> century;

**Referring** to the relevant resolutions of the 36<sup>th</sup> and 37<sup>th</sup> sessions of the Council of Foreign Ministers of the OIC Member States on the mid-term review of the Programme;

**Noting with appreciation** the report of the Secretary-General on the matter:

1. **Pays tribute to** Maitre Abdoulaye WADE, President of the Republic of Senegal and Chairman of the COMIAC, for his support for joint Islamic action and for the initiatives that he has kindly taken in order to ensure the implementation of the Ten-Year Programme of Action, particularly in the fields of information and culture.
2. **Commends** the Secretary-General for his praiseworthy efforts to enhance the Organisation's visibility, influence and responsibility at the international level.
3. **Also commends** the support extended by various Member States in successfully organizing activities and the active role played by subsidiary organs and specialized institutions of the OIC in the implementation of the Programme of Action.
4. **Underscores** the important role of cultural exchange and the media in reaching the objectives of the OIC Ten-Year Plan of Action.
5. **Invites** the OIC Member States, Subsidiary organs and institutions concerned to utilise the all the necessary information tools in order to publicise the objectives of the Ten-Year Programme of Action as well as its advantages for the Muslim world populations.
6. **Requests** the Member States to increase their support for the OIC organs and institutions active in the domains of information and culture, as well as for the COMIAC, in order to allow them to play their part fully in attaining the objectives of the OIC Ten-Year Programme of Action.

9. **Requests** the Secretary-General to ensure the implementation of this resolution and to report thereon to the 12<sup>th</sup> Islamic Summit and to the other relevant fora of the Organisation.
