RESOLUTION NO. 1/42-IBO
ON
THE ISLAMIC OFFICE FOR THE BOYCOTT OF ISRAEL

The Forty-second Session of the Council of Foreign Ministers (Session of Joint Vision for the Promotion Tolerance and Rejection of Terrorism), held in Kuwait City, State of Kuwait, from 28 to 29 Rajab 1436H (27-28 May 2015),

Proceeding from the principles and objectives enshrined in the Charter of the Organization of the Islamic Cooperation,

Mindful of the existing cooperation and coordination between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States, in favour of an optimal implementation of the principles and provisions of the Boycott of Israel,

Based on all the relevant Islamic resolutions, in particular Res. No. 1/41-IBO adopted by the 41st Session of the Council of Foreign Ministers, held in Jeddah, Kingdom of Saudi Arabia from 20 to 21 Shaaban 1435H (18 – 19 June 2014),

Having considered the report of the Secretary General on the Islamic Office for the Boycott of Israel,

Decides to:

1. **Invite** Member States that are yet to establish regional Islamic boycott offices in their countries to do so, to designate directors for these offices, and to nominate liaison officers with the Islamic main Office of the Boycott at the General Secretariat.
2. **Appeal** to competent authorities in the Member States to avail the Islamic regional offices in their countries of the necessary support for them to perform the tasks assigned to them, considering that these offices form the executive tool for the provisions of the boycott.

3. **Invite** the Member States to commit to the implementation of the provisions of the Islamic Boycott of Israel and to consider the legislations and the rules and regulations governing the boycott action (general principles of the boycott, the Islamic law, the OIC Summit and CFM resolutions on the boycott of Israel, the internal regulations of national offices and their periodic meetings) as part of their national legislations in force.
4. **Commend** the existing cooperation between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States in favour of an optimal implementation of the principles and provisions of the Boycott of Israel.
5. **Emphasize** support for the Office for the Boycott of Israel to enable it to perform its duties and tasks aimed at increasing the efficiency of the boycott of Israel in Islamic States.
6. **Request** the Secretary-General to follow up the implementation of the present resolution and report thereon to the 42nd Session of the Council of Foreign Ministers (CFM).
