**STATUTES OF IMPLEMENTATION OF THE**  
**OIC TEN YEAR PROGRAMME OF ACTION**

*The Fortieth Session of the Council of Foreign Ministers of the Organization of Islamic Cooperation (Session of Dialogue of Civilizations, Factor for Peace and Sustainable Development), held in Conakry, Republic of Guinea, on 9-11 December 2013 (06-08 Safar, 1435H)*

**Affirming** the provisions of the OIC Charter concerning enhancing the bond of unity and solidarity among the Muslim peoples and member states;

**Recalling** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia on 6 to 7 Dhul Qaidah 1426H (7-8 December 2005) adopting the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21<sup>st</sup> Century;

**Also recalling** resolution No. 5/4-EX (IS) on enhancing Islamic solidarity adopted by the Fourth Extraordinary Islamic Summit Conference held in Makkah AlMukarramah, Kingdom of Saudi Arabia, from 26 – 27 Ramadan 1433H (14 – 15 August 2012);

**Re-iterating** the relevance of TYPOA in providing the Islamic Ummah with a forward-looking blue print to effectively implement the various resolutions of the OIC with a view to enhancing joint Islamic action;

**Cognizant** of the various achievements highlighted in the relevant reports of the Secretary General on political affairs; economic affairs; science & technology; cultural & social affairs; and humanitarian affairs respectively;

**Also Cognizant** of the outcome of the Mid-term review of TYPOA carried out by COMCEC, COMSTECH and COMIAC in 2010 which recommended additional activities in the area of increased ownership by member states, elaboration and funding of projects, identification of targets and benchmarks;

**Underlining** the pivotal role of the OIC General Secretariat, Standing Committees, Subsidiary Organs, Specialized and Affiliated Institutions in the implementation of the TYPOA and in creating the requisite synergy towards achieving the set targets under the Programme;

**Considering** the imminent expiry of the TYPOA in December 2015 and the need to take stock of all achievements realized under this Programme;

1. **Expresses** satisfaction with the progress made in the implementation of TYPOA since its inception.
2. **Commends** the support and goodwill extended by member states towards the implementation of the Programme.
3. **Also commends** the efforts of the outgoing Secretary General Prof. Ekmeleddin Ihsanoglu in providing the requisite leadership and his total commitment to the effective implementation of the programme.
4. **Requests** the Secretary General to continue to mobilize actions for effective conclusion of the Programme.
5. **Also requests** the Secretary General to initiate actions on a comprehensive and inclusive review of the Programme with a view to making necessary proposals for a possible successor programme.
6. **Decides** to devote a special meeting to this issue during the 41<sup>st</sup> CFM and **requests** the General Secretariat to make report thereon.
7. **Invites** the Secretary General to follow up the implementation of the present Resolution and Report thereon to the 41<sup>st</sup> Session of the Council of Foreign Ministers.
