**RESOLUTION NO. 1/39/POA  
ON THE  
IMPLEMENTATION OF THE OIC TEN-YEAR PROGRAMME OF ACTION  
(TYPOA)**

*The Thirty-Ninth Session of the Council of the Foreign Ministers of the Organization of Islamic Cooperation (Session of Solidarity for Sustainable development), held in Djibouti, Republic of Djibouti, on 15-17 November 2012 (01-03 Muharram, 1434H).*

**Considering** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia on 6 to 7 Dhul Qaidah 1426H (7-8 December 2005),

**Welcoming** the adoption of the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21<sup>st</sup> Century;

**Re-affirming** the relevance of TYPOA in providing the Islamic Ummah with such a new forward-looking vision as to enable the Islamic world to address the challenges of the Twenty-first Century by leveraging on the collective will and joint Islamic Action.;

**Considering** the call by Makkah Declaration in its preamble for a Mid-Term Review of TYPOA;

**Considering** the resolutions No. POA-36/1 of the 36<sup>th</sup> Session of the Council of Foreign Ministers of OIC Member States held in Damascus, Syrian Arab Republic on 23-25 May 2009 and No. 1/37-POA of the 37<sup>th</sup> Session of the Council of Foreign Ministers held in Dushanbe, Republic of Tajikistan on 18-20 May 2010;

**Having** regard to the resolution of the 26<sup>th</sup> Session of the OIC Standing Committee for economic and Commercial Cooperation (COMCEC) held in Istanbul, Turkey on 5-8 November 2010;

**Considering** the resolution No. 1/38/POA adopted by the 38<sup>th</sup> Session of CFM held in Astana, Republic of Kazakhstan on 28-30 June 2011;

1. **Takes note**, with appreciation, the outcome of the Mid-Term Review exercise carried out by OIC Standing Committees i.e. the Standing Committee for Economic and Commercial Cooperation (COMCEC), the Standing Committee for information and Cultural Affairs COMIAC), and the Standing Committee for Scientific and Technological Cooperation (COMSTECH).

2. **Further notes**, with satisfaction, the progress made in the implementation of TYPOA during the past six years and commends the efforts of the Secretary General in this regard.

3. **Invites** the Member States to continue their contribution to the implementation of the OIC Ten-Year Programme of Action, and to take full advantage of the opportunities afforded by the Programme and its various projects.

4. **Calls on** all Member States, in accordance with the vision and mandate of the TYPOA, to expedite the signing and ratification of Agreements and Protocols, aimed at fostering joint Islamic action and cooperation within the OIC Member States with a view to preparing the Muslim Ummah to face effectively the challenges of the 21<sup>st</sup> century.

5. **Underlines** the pivotal role of the OIC General Secretariat in the implementation of the TYPOA and appreciates the progress achieved so far through the actions taken by the OIC General Secretariat, Standing Committees, Subsidiary Organs, Specialized and Affiliated Institutions and invites them to exert more concerted efforts for a speedy implementation of the TYPOA and in the same context, pays tribute to the Secretary General for his leadership and distinct contribution in the implementation of this programme.

6. **Also commends** the role played by the OIC subsidiary organs, specialized and affiliated institutions in the implementation of TYPOA and called on them to continue their efforts.

7. **Appeals** to Member States and OIC institutions to work towards bringing synergy in their efforts to obtain the targets contained in the Millennium Development Goals, the Plan of Action for strengthening Economic and commercial Cooperation among OIC Member States and the Ten-Year Programme of Action.

8. **Calls on** Member States, OIC Standing Committees (COMCEC, COMIAC and COMSTECH) and OIC institutions to undertake, at appropriate time, preparation for final evaluation of the OIC Ten-Year Programme of Action with a view to drawing necessary lessons for future action.

9. **Invites** the Secretary General to follow up the implementation of the present Resolution and report thereon to the 40<sup>th</sup> Session of the Council of Foreign Ministers.
