**RESOLUTION NO.1/39-IBO**  
**ON**  
**THE ISLAMIC OFFICE FOR THE BOYCOTT OF ISRAEL**

*The Thirty-ninth Session of the Council of Foreign Ministers (Session of Solidarity for Sustainable Development) held in Djibouti, Republic of Djibouti from 15 to 17 November 2012 (1-3 Muharram 1434H),*

**Proceeding from** the principles and objectives enshrined in the Charter of the Organization of the Islamic Conference,

**Mindful of** the existing cooperation and coordination between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States, in favour of an optimal implementation of the principles and provisions of the Boycott of Israel,

**Based on** all the relevant Islamic resolutions, in particular Res. No. 1/38-IBO adopted by the 38<sup>th</sup> Session of the Council of Foreign Ministers, held in Astana, Republic of Kazakhstan from 26 to 28 Rajab 1433H (28-30 June 2011),

**Having considered** the report of the Secretary General on the Islamic Office for the Boycott of Israel,

**Decides to:**

- 1. Invite** the Member States to commit to the implementation of the provisions of the Islamic Boycott of Israel and to consider the legislations and the rules and regulations governing the boycott action (general principles of the boycott, the Islamic law, the OIC Summit and CFM resolutions on the boycott of Israel, the internal regulations of national offices and their periodic meetings) as part of their national legislations in force.
- 2. Invite** those Member States that have not yet set up regional Islamic boycott offices in their countries to do so, to designate directors for these offices, and to nominate liaison officers with the Islamic main Office of the Boycott at the General Secretariat.

3. **Call on** competent authorities in the Member States to avail the Islamic regional offices in their countries of the necessary support for them to perform the tasks assigned to them, considering that these offices form the executive tool for the provisions of the boycott.
4. **Commend** the existing cooperation between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States in favour of an optimal implementation of the principles and provisions of the Boycott of Israel
5. **Stress** the support to the Office for the Boycott of Israel to enable it to perform its duties and tasks aimed at increasing the efficiency of the boycott of Israel in Islamic States.
6. **Request** the Secretary-General to follow up the implementation of the present resolution and report thereon to the 40<sup>th</sup> Session of the Council of Foreign Ministers (CFM).
