#### RESOLUTION NO.1/38-S&T ON SCIENCE AND TECHNOLOGY MATTERS

The Thirty-Eighth session of the Council of Foreign Ministers (Session of Peace, Cooperation and Development), held in Astana, Republic of Kazakhstan from 26 to 28 Rajab 1432H (28 to 30 June, 2011);

**Referring** to the OIC Vision 1441 H for Science and Technology adopted by the Tenth Islamic Summit Conference held in Putrajaya in October 2003 and the OIC Ten-Year Programme of Action adopted by the Third Extraordinary Islamic Summit Conference held in Makkah Al-Mukarramah in December 2005;

**Mindful** of the Resolution No 1/37 - S&T on Science and Technology Matters adopted by the  $37^{th}$  session of Council of Foreign Ministers of the Organization of the Islamic Conference held in Dushanbe, Republic of Tajikistan on 18 - 20 May 2010;

**Bearing in mind** the Resolution No. 2/11-S&T(IS) on Atlas of Islamic-World Innovation adopted by the Eleventh Islamic Summit held in Dakar in March 2008;

**Referring** to the Resolution No. 4/35-S&T on the OIC Centers of Excellence adopted by the 35<sup>th</sup> session of Council of Foreign Ministers of the Organization of the Islamic Conference held in Kampala, Republic of Uganda on 18-20 June, 2008.

**Recalling** the Resolution No. 5/35-S&T on the OIC Prestigious Awards on Science, Technology and Innovation adopted by the 35<sup>th</sup> session of the Council of Foreign Ministers of the OIC held in Kampala, Republic of Uganda on 18-20 June, 2008.

**Commending** the role of the COMSTECH and the contributions of SESRIC, IDB, ISESCO and ICCI in the field of the development and promotion of science and technology in the Islamic World;

**Having considered** the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/38-CFM/2011/ST/SG-REP):

1. Approves the expansion in the membership of the Task Force of the OIC Vision 1441 H to include three Member States from the three OIC regions, mandates the Task Force to monitor of implementation of the Vision 1441 H and Ten Year Programme of Action and agrees transfer of the Secretariat of the Task Force to the COMSTECH;

- **2.** Looks forward to the launching of the country report on the Atlas of Islamic World Innovation for Malaysia and requests the project managers to expedite finalization of the remaining country reports;
- **3. Calls upon** the Member States and the OIC institutions to extend generous financial support to the project on Atlas of Islamic World Innovation and requests the Joint Management Team to take all necessary measures for its early completion;
- **4. Commends** the Kingdom of Saudi Arabia, Syrian Arab Republic, Islamic Republic of Pakistan, and Islamic Republic of Iran for pledging US \$ five million each for the Science, Technology and Innovation Organization (STIO) for 2011;
- **5.** Welcomes the commencement of the project by STIO for the establishment of Cellular and Molecular Therapeutics Research Unit (CAMTRU) in Syria;
- 6. Commends the selection of i) International Center for Diarrheal Disease Research (ICDDRB), Dhaka, Bangladesh; ii) International Center for Chemical and Biological Sciences (T-IEJ Research Institute of Chemistry), Karachi, Pakistan; iii) Department of Physics, Middle East Technical University (METU), Ankara, Turkey; iv) Institute of Advanced Studies in Basic Sciences, Zanjan, Islamic Republic of Iran and v) National Institute of Agronomy Research (INRA), Rabat, Morocco as the first five (5) OIC Centers of Excellence;
- **7. Requests** the Islamic Development Bank to support the selected S & T Centers of Excellence in the Islamic world to achieve the world-class standards.
- **8.** Congratulates the winners of the COMSTECH awards for prominent Muslim Scientists; IDB awards for prominent scientific and research institutions and ISESCO awards for Muslim scientists and technologists;
- **9. Requests** the Government of the Republic of Djibouti to organize and host Exhibition and Conference on Science and Technology parallel to 39<sup>th</sup> CFM in conformity with one of the recommendations of the OIC Vision 1441 H for Science and Technology;
- **10. Requests** the Secretary General to take appropriate steps for the implementation of these recommendations and submit a report thereon to the next Session of the Council of Foreign Ministers.

**Recalling** the Resolution No 2/34–S&T on ranking of universities in OIC Member States adopted by the  $34^{\text{th}}$  session of Council of Foreign Ministers (CFM) of the Organization of the Islamic Conference held in Islamabad, the Islamic Republic of Pakistan on 15 - 17 May 2007;

**Further recalling** the decisions on this subject by the 35<sup>th</sup>, 36<sup>th</sup> and 37<sup>th</sup> sessions of the Council of Foreign Ministers and the 4<sup>th</sup> Islamic Conference of Ministers of Higher Education and Scientific Research (ICMHESR) held in Baku, Republic of Azerbaijan on 6-8 October 2008.

**Taking note** of the report of the Technical Meeting of Experts held in Riyadh, Kingdom of Saudi Arabia on 24 - 25 April 2010 in preparation for the Extra-ordinary meeting of the Ministers of Higher Education and Scientific Research amending the existing document on the ranking of universities from the OIC region as "Key Performance Indicators for Universities in the Islamic World".

**Appreciating** the generous grant of scholarships through the OIC General Secretariat by the Governments of the Republic of Turkey, Republic of Yemen and Brunei Darussalam for students from the Member States to study in their respective universities;

**Commending** the role of the COMSTECH and the activities undertaken by ISESCO, SESRIC and IDB towards the promotion of higher education and scientific research in the Member States;

**Bearing in mind** the important role of the IUT, IUIU, IUN and IIUM in promoting higher education, research and development in various disciplines in furtherance of the OIC objectives;

**Having considered** the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/38-CFM/2011/ST/SG-REP):

Urges the OIC General Secretariat and ISESCO to finalize "Key Performance Indicators for the Universities in the Islamic World" and present it to the Extraordinary Islamic Conference of the Ministers of Higher Education and Scientific Research, to be hosted by the Kingdom of Saudi Arabia in 2011;
- 3. **Congratulates** the International Islamic University Malaysia (IIUM) for successful organization and hosting of the first inter OIC-University Debate in December 2010 and requests IIUM to organize the event annually;
- 4. **Requests** the OIC General Secretariat in collaboration with the related OIC institutions to keep the performance of the OIC-affiliated universities under review;
- 5. **Invites** the OIC Member States to convey nominations of eligible students for the scholarships offered by the Republic of Turkey, Republic of Yemen and Brunei Darussalam and calls upon other Member States to offer scholarships/training facilities in their respective institutions;
- 6. **Requests** the OIC General Secretariat and other related OIC institutions such as IDB and ISESCO to coordinate their efforts in the provision of scholarships;
- 7. Welcomes the offer of the Government of Sudan to host the Sixth Islamic Conference of Higher Education and Scientific Research in 2012;
- 8. **Requests** the Secretary General to report on the implementation of these recommendations to the next Session of the Council of Foreign Ministers.

**Referring** to the OIC Ten-Year Programme of Action adopted by the Third Extraordinary Islamic Summit held in Makkah Al-Mukarramah in December 2005;

**Recalling** the Resolution No.4/11-S&T(IS) on the Global Cooperation for Combating Diseases and Epidemics adopted by the Eleventh Islamic Summit Conference held in Dakar in March 2008;

**Further Recalling** the Resolution No. 3/37 - S&T on Health Matters adopted by  $37^{th}$  session of Council of Foreign Ministers of the Organization of the Islamic Conference held in Dushanbe, Republic of Tajikistan on 18 - 20 May 2010;

**Bearing in mind** the Declarations and Resolutions adopted by the First and Second Islamic Conference of Health Ministers held in Kuala Lumpur in June 2007 and Tehran in March 2009;

**Welcoming** the Third meeting of the Steering Committee on Health held at the OIC Headquarters in Jeddah from 22-23 January, 2011 to effectively and efficiently follow-up and monitor the implementation of the decisions and recommendations of the Health Ministers Conferences.

**Appreciating** the close coordination between the OIC General Secretariat and the Global Polio Eradication Initiative (GPEI) and the financial contribution by the OIC Member States and other international donor agencies to the global efforts to eradicate polio;

**Welcoming** a joint event on combating polio organized by the OIC and GPEI at the sidelines of the annual session of the UN General Assembly in September 2010;

**Appreciating** the contribution of the Islamic Development Bank (IDB) for the procurement of polio vaccines for Afghanistan;

**Taking into consideration** a Memorandum of Understanding (MoU) between the OIC General Secretariat and the Global Fund to Fight HIV/AIDS, Tuberculosis and Malaria signed during the 36<sup>th</sup> session of the Council of Foreign Ministers (Damascus, 23-25 May 2009);

**Appreciating** the ongoing cooperation between the OIC General Secretariat and the Global Fund to fight AIDS, Tuberculosis and Malaria;

**Noting with satisfaction** the efforts made by the General Secretariat in sensitizing the Member States, generating greater awareness, effective advocacy and contributing to the global efforts for elimination of polio, AIDS, tuberculosis and malaria in the OIC Member States;

**Appreciating** the offer made by the Republic of Turkey to share expertise and cooperate with Member States in the control of tuberculosis and in the production of pharmaceuticals;

**Welcoming** the partnership between OIC-US and the Government of Mali to reduce mortality rate of mothers during delivery and infants during first 4 weeks launched on 4 November 2010 as well as involvement of the Islamic Fiqh Academy in a workshop organized in Bamako for religious/cultural leaders, women associations leaders, and other stakeholders to discuss and advocate child spacing;

**Further welcoming** the preparation of action plan of the OIC-IDB-USG Mother and Child Health care project in Dhaka (Bangladesh) on 8 – 10 February 2011;

**Taking into consideration** the trilateral meeting of the OIC, IDB and the International Atomic Energy Agency (IAEA) held on 31 May - 1 June 2010 in Jeddah and its recommendations to launch joint projects in the health sector in the OIC Member States in Africa;

**Appreciating** the IDB for releasing funds to support the project of the IAEA "Investigating the Use of the Sterile Insect Technique for Controlling Mosquitoes in Northern Sudan";

**Having considered** the report of the Secretary General on Science and Technology, Higher Education, Health and Environment Sectors (OIC/38-CFM/2011/ST/SG-REP):

- 1. **Reiterate** the crucial role of the Islamic Conference of Health Ministers in promoting the common OIC health Agenda;
- 2. **Calls upon** the Member States to implement the Resolutions and Declarations adopted by the First and Second Islamic Conference of Health Ministers held in Kuala Lumpur in June 2007 and Tehran in March 2009 respectively;
- 3. **Requests** the Steering Committee on Health to prepare 'Strategic Health Program of Action of the OIC Member States for 2012-2022' to be presented for adoption by the Third Islamic Conference of Health Ministers in Astana in September 2011;
- 4. **Requests** the IDB to consider providing additional financial assistance to procure polio vaccines for Afghanistan;

- 5. **Appreciates** the efforts of Afghanistan, Nigeria and Pakistan to eradicate polio and calls on other OIC Member States to continue their efforts to immunize children against polio;
- 6. **Underlines** the importance of cooperation among the Central Asian countries with re-established transmission of poliovirus;
- 7. Urges the Member States affected by polio, AIDS, tuberculosis and malaria to undertake necessary steps to fight these dangerous communicable diseases and requests the potential donors to contribute generously to the GPEI and Global Fund.
- 8. **Requests** the Government of Bangladesh and Mali to cooperate with the OIC General Secretariat, the IDB and the USAID to implement activities under the joint projects on Mother and Child Health Care in their respective countries;
- 9. **Encourages** the OIC General Secretariat to develop collaboration with the Member States, IDB and ICCI projects for production of vaccines and drugs;
- 10. Calls upon the IDB to favourably consider providing grants to support the African regional technical cooperation programme on cancer control and cancer management in the framework of the AFRA regional Agreement: RAF/6/031 "Medical Physics in Support of Cancer Management (AFRA II-8)" and RAF/6/035 "Enhancing Accessibility and Quality in the Care of Cancer Patients (AFRA II-10)";
- 11. **Encourages** the OIC and the IDB to participate in the 3<sup>rd</sup> Coordination Meeting to be organised by the IAEA in November-December 2011 in Egypt in the framework of the regional project RAF/6/041 "Supporting the Development of Comprehensive National Cancer Control Programmes" and to co-organize a Seminar for Awareness Raising on Cancer Control Programme targeting highlevel policy makers;
- 12. **Invites** all Member States to actively participate in the Third session of Islamic Conference of Health Ministers (ICHM) to be held on 29 September 1 October 2011 in Astana, Republic of Kazakhstan;
- 13. **Requests** the Secretary General to take appropriate steps for the implementation of these recommendations and submit a report thereon to the next Session of the Council of Foreign Ministers.

**Welcoming** the offer of the Government of the Kazakhstan to host the Second Meeting of Advisory Panel of Experts to finalize OIC Water Vision in Astana in 2011;

### RESOLUTION NO. 11/38-S&T ON

## the 20<sup>th</sup> Anniversary of the Closing of the former Semipalatinsk Nuclear Test Site and the International Day against Nuclear Tests and rehabilitation of the Aral Sea region

The Thirty-Eighth Session of the Council of Foreign Ministers (Session of Peace, Cooperation and Development), held in Astana Republic of Kazakhstan, from 26 to 28 Rajab 1432H (28 to 30 June, 2011);

**Taking into consideration** United Nations General Assembly resolution 63/279 "International cooperation and coordination for the human and ecological rehabilitation and economic development of the Semipalatinsk region of Kazakhstan", inviting Member States to observe, in 2011, the 20<sup>th</sup> Anniversary of the closure of the Semipalatinsk nuclear test site by conducting appropriate events;

**Taking into consideration also** United Nations General Assembly resolution 63/279 "International Day against Nuclear Tests", declaring 29 August as the International Day against Nuclear Tests;

**Recalling** resolution No.4/33-S&T on environmental issues adopted by the 33<sup>rd</sup> Session of the Council of Foreign Ministers, requesting the Islamic Development Bank and charity foundations of the Muslim countries to explore ways and means to evolve a programme providing support to the regions of the Aral Sea and Semipalatinsk in coordination with existing international, regional and national programmes;

**Expressing** serious concern over the consequences of ecological problems of the Aral Sea and former Semipalatinsk Nuclear Testing Site;

**Taking note** that by the President of the Republic of Kazakhstan Nursultan Nazarbayev's decree of 29 August 1991, the Semipalatinsk Nuclear Test Site had been shut down, having functioned from 1949 to 1991 and produced 456 nuclear tests;

Acknowledging that the former Semipalatinsk Nuclear Test Site remains an issue of serious concern for Kazakhstan, in view of its long term hazardous effects on the lives and health of the region's inhabitants and the environment;

- 1. **Welcomes** Member States to observe the International Day against Nuclear Tests on 29 August in order to increase awareness of the effects of nuclear weapons test explosions;
- 2. **Calls on** Member States to commemorate the 20<sup>th</sup> anniversary of the closing of the former Semipalatinsk Nuclear Test site through the holding of events aimed at informing the public about the consequences of nuclear tests for the lives and health of people and the state of the environment;

- 3. Welcomes elaboration and adoption of Third Aral Sea Basin Program-3 (ASBP-3) at the Donor Coordination Conference held on December 9, 2010, in Almaty, Kazakhstan;
- 4. **Welcomes** adoption by the Government of Kazakhstan the Field Program "Zhasyl Damu" (Green Development) for 2010-2014 directed to comprehensively resolve the issues of region of the former Semipalatinsk Nuclear Testing Site;
- 5. **Urges** the Islamic Development Bank, the OIC Member States and international donor organizations to continue providing necessary technical and financial support in implementation of Programs directed to address the issues of the Aral Sea and region of the former Semipalatinsk Nuclear Testing Site;
- 6. **Requests** the Secretary General to follow up the implementation of this resolution and to submit a report thereon to the 39<sup>th</sup> Session of the Council of Foreign Ministers.

#### RESOLUTION NO. 12/ 38-S&T ON MAINSTREAMING EFFORTS TO COMBAT THE SAND AND DUST STORM IN SOME MEMBER STATES

The Thirty-Eighth Session of the Council of Foreign Ministers (Session of Peace, Cooperation and Development), held in Astana, Republic of Kazakhstan from 26 to 28 Rajab 1432H (28 to 30 June, 2011);

**Referring** to the objectives and principles of the Charter of the Organization of the Islamic Conference where it demands the Member States to Endeavour to protect and preserve the environment;

**Having** considered the OIC Ten-Year Program of Action calling upon Member States to coordinate their environmental policies and positions in international environmental fora so as to prevent adverse effects of such policies on their economic development;

**Recalling** Resolution No.1/36-POA on the implementation of the OIC Ten-Year Progamme of Action, underlining the need to ensure sustainable development of Member States through effective policy to protect the environment;

**Recalling further** article 3 of the Islamic Declaration on Sustainable Development, ratified by Islamic Environment Ministers in Jeddah, on 10-12 June 2002, where it names the environment a gift from Allah and calls upon all individuals and communities to take care of it and promote it;

**Taking into account** the adverse effects of severe and long-standing drought and implications of climate change, in the shape of dust and sand storm in certain Member States;

**Further taking into** account the final report of the First Meeting of the Islamic Executive Bureau for Environment which, among other things, calls on Member States competent authorities to redouble efforts and better coordinate actions to meet the new challenges posed by climate change and deterioration of environmental situation including desertification;

**Recalling** Resolution No. 9/37-S&T on Mainstreaming Efforts to Combat the Sand and Dust Storm adopted by the 37<sup>th</sup> session of the Council of Foreign Ministers held in Dushanbe, Tajikistan from 18-20 May 2011;

1. **Expresses** concern over the unprecedented wave of sand and dust tempests and for the considerable losses they have been causing in desert areas in the Member States in both Asia and Africa;

- 2. **Calls** on all the Member States affected in desert areas in Asia and Africa to engage in a conscientious and constructive interaction to resolve this problem in an appropriate manner;
- 3. **Invites** all affected countries in the region to engage into serious and constructive interaction among themselves to address the issue properly;
- 4. **Expresses** its support for developing a collective regional mechanism for awareness raising, early warning and risk management network enabling the affected countries to face the problem in a suitable manner;
- 5. **Calls upon** all international and regional environmental instruments and institutions, including ROPME, to seriously and rapidly address the issue and to mobilize their resources, both technically and financially to assist the affected countries;
- 6. **Invites** the Member States to contribute to the reforestation of desert zones in the OIC Member States, and to take firm measures against the abusive cutting of trees and bushfires;
- 7. **Invites** the OIC Specialized Agencies such as Islamic Development Bank to take all appropriate measures to develop concrete projects for assisting the affected countries enabling them to overcome the disastrous effects of this phenomenon;
- 8. **Decides** to keep the matter under review.

#### RESOLUTION NO. 13/ 38-S&T ON CLIMATE CHANGE COLLABORATION AMONG OIC MEMBER STATES

The Thirty-Eighth Session of the Council of Foreign Ministers (Session of Peace, Cooperation and Development), held in Astana, Republic of Kazakhstan from 26 to 28 Rajab 1432H (28 to 30 June, 2011);

**Recalling** the OIC Ten Year Programme of Action, adopted by the 3<sup>rd</sup> Extraordinary Islamic Summit Conference in Makkah in 2005, that calls upon the OIC member States to coordinate their environmental policies and positions in international environmental fora so as to prevent any adverse effects of such policies on their economic development;

**Further recalling** the Final Communique and Resolution No. 5/11-S&T(IS) adopted by the 11<sup>th</sup> session of the Islamic Summit Conference, held in Dakar, Republic of Senegal, from 13-14 March 2008;

**Bearing in mind** the Islamic Declaration on Sustainable Development, the Jeddah Commitments for Sustainable Development decisions and outcomes of the Islamic Conferences of Environment Ministers including the Tunis Declaration adopted by the 4<sup>th</sup> Islamic Conference of Environment Ministers held in Hammamet, Tunisia, on 5-6 October 2010 addressing the environmental challenges, particularly climate change and its adverse impact on the future of sustainable development in the Islamic world;

**Referring** to the Resolution No. 8/35-S&T on the Implementation of the Bali Action Plan of the United Nations Climate Change Conference adopted by the 35<sup>th</sup> session of the Council of Foreign Ministers and Resolutions No. 4/36- S&T and 4/37-S&T adopted by the 36<sup>th</sup> and 37<sup>th</sup> sessions respectively of the Council of Foreign Ministers;

**Taking into consideration** the provisions of the United Nations Millennium Declaration in which Heads of State and Government resolved to make every effort to ensure the entry into force of the Kyoto Protocol and to embark on the required reduction in emissions of greenhouse gases;

**Further taking into consideration** the provisions of the United Nations Framework Convention on Climate Change which acknowledges that change in the Earth's climate and its adverse effects are common concern of humankind;

**Recognizing** that Climate Change represents an urgent challenge to the security, prosperity, economic and social development of our people and poses major threat to public health, agriculture, food security, livelihood, water security, eco-systems, biodiversity as well as poverty alleviation and disaster management efforts;

**Underscoring** the need for greater cooperation among Member States on issues related to climate change, environmental degradation, sustainable development, and the

development of necessary human, technological and economic resources in order to adapt to and mitigate the impact of climate change;

**Recognizing** the diversity among OIC Member States in terms of their geophysical locations as well as economic and social indicators;

**Reiterating** the need for better coordination of OIC positions in relation to multilateral negotiations on climate change, including 17<sup>th</sup> Conference of Parties of the UNFCCC to be held in Durban, South Africa, from 28 November to 9 December 2011 and the United Nations Earth Summit meeting "Rio+20" to be held at Rio de Janeiro, Brazil in 2012;

**Referring** to the resolutions adopted by the 14<sup>th</sup> General Assembly of the Ministerial Standing Committee on Scientific and Technological Cooperation (COMSTECH) held in Islamabad, Islamic Republic of Pakistan, from 11-13 January 2011, that welcomed the interest of Member States to promote Green Technology programmes to combat climate change;

**Having considered** the report of the Open-ended meeting of experts held at the OIC headquarters in Jeddah on 7-8 May 2011 to examine the concept paper on "Climate Change Collaboration Among OIC Member States" presented by the People's Republic of Bangladesh and inputs thereon received from OIC Member States and institutions:

- 1. **Takes note** of the concept paper on "Climate Change Collaboration on OIC Member States" presented by the People's Republic of Bangladesh and the inputs of other Member States and OIC institutions on the subject;
- 2. **Stresses** the need for urgent action and international cooperation to address climate change in accordance with the principles and provisions of the United Nations Framework Convention on Climate Change, particularly the principles of common but differentiated responsibilities and respective capabilities;
- 3. Acknowledges that for many OIC countries poverty, burden of debt and illiteracy remain to be overriding issues and that those countries have difficulties to combat Climate Change while working towards their development goals; also takes into consideration the special vulnerabilities of the LDCs and Small Islands Developing States (SIDS);
- 4. **Further underscores** the importance of reaching an agreed outcome in the UNFCCC negotiations;
- 5. **Stresses** the need for early operationalization of the Green Climate Fund (GCF) and in this regard early launch of negotiations on the magnitude of allocations and sources of financing for the GCF;

- 6. **Further stresses** the need to accord particular attention to adaptation to climate change and adaptation to response measures as well as transfer of technology and capacity building;
- 7. **Underlines** the need for more in depth consideration and examination by Member States of the relevant issues to facilitate the identification of common elements and coordination of OIC positions in relation to multilateral climate change negotiations; and for this purpose;
- 8. **Decides** to establish a mechanism of regular coordination between the representatives and experts of the OIC Member States on the sidelines of climate change negotiations and such multilateral fora and requests the OIC General Secretariat to transmit the compilation of all relevant documents to such meetings;
- 9. **Requests** the Secretariat to facilitate coordination among OIC countries on climate change related issues;
- 10. **Stresses** the need to work within the OIC framework on practical cooperation in the areas of climate change and environment protection with COMSTECH, the Islamic Executive Bureau for Environment and relevant OIC institutions, including the IDB, ISESCO and SESRIC;
- 11. **Calls upon** Member States and the relevant OIC institutions to focus on programmes for the capacity building of Member States, such as the SESRIC environment capacity-building programme, in order to benefit from funding mechanisms and means available under the UNFCCC and the Kyoto Protocol;
- 12. **Further calls upon** the IDB to support Member States in their efforts in the areas of adaptation and mitigation of the adverse impact of climate change;
- 13. **Requests** the IDB to contribute to the discussions and negotiations under the Transitional Committee established to design the Green Climate Fund;
- 14. **Calls upon** the relevant OIC institutions to collaborate in assessing the level of climate change vulnerabilities of all Member States of the OIC region by undertaking research and modeling activities;
- 15. **Requests** the COMSTECH to collaborate with Member States in the field of technology transfer and clean development mechanism to support their climate change mitigation initiatives;
- 16. **Urges** the General Secretariat to propose a framework of cooperation with the UNFCCC Secretariat;

17. **Requests** the Secretary General to submit a report on implementation of this resolution to the 39<sup>th</sup> session of the Council of Foreign Ministers.
