RESOLUTION No. 1/38-ORG ON

THE RULES GOVERNING OBSERVER STATUS AT THE ORGANIZATION OF THE ISLAMIC CONFERENCE

The Thirty-eighth Session of the Council of Foreign Ministers, (Session of Peace, Cooperation and Development), held in Astana, Republic of Kazakhstan, from 26 to 28 Rajab 1432H (28-30 June 2011 A.D.),

Taking note of Article IV of the amended OIC Charter containing the conditions to be fulfilled to grant Observer Status,

Recalling previous resolutions adopted in this regard, the latest of which is included in the report of the 37th Session of Council of Foreign Ministers,

Taking note of the increasing number of requests for Observer Status at the Organization of the Islamic Conference (OIC),

Convinced that promoting Islamic causes and achieving greater conciliation and understanding between the Organization of the Islamic Conference (OIC) and the non-Member States and international as well as regional organizations is considered a desirable goal,

Taking note, with appreciation, the report of the Secretary General included in Document No. (OIC/CFM-38/2011/ORG/SG.REP.1),

- 1. *Thanks* the Secretary General for the work done by the General Secretariat to prepare a proposal on the criteria for granting Observer Status to States in accordance with the Charter of the Organization, and submit a report thereon to the Group of Experts;
- 2. *Thanks also* the Intergovernmental Group of Experts revising the Draft Rules Governing Observer Status at the OIC for the efforts it deployed in drafting these rules;
- 3. **Approves** the Draft Rules Governing Observer Status at the OIC in accordance with document no. (OIC/4-EGG/2011/DR.OS/REV.5);
- 4. *Requests* the Secretary General to follow up the implementation of this Resolution and to submit a report thereon to the 39th Session of the Council of Foreign Ministers.

RULES GOVERNING OBSERVER STATUS AT THE ORGANIZATION OF THE ISLAMIC CONFERENCE

RULES GOVERNING OBSERVER STATUS AT THE ORGANIZATION OF THE ISLAMIC CONFERENCE

CHAPTER I

SCOPE AND DEFINITIONS

ARTICLE (1)

These Rules are promulgated in implementation of the Provisions of Article 4 of the Charter of the Organization of the Islamic Conference adopted by the 11th Islamic Summit Conference held in Dakar, Senegal on 6-7 Rabie Al Awal 1429 H (13-14 March 2008).

ARTICLE (2)

Definitions:

The terms indicated hereinafter, wherever appearing in the present Rules, shall have the meaning as indicated opposite each of them:

Charter: The Charter of the Organization of the Islamic

Conference.

Organization: The Organization of the Islamic Conference (OIC).

Council: The Council of Foreign Ministers (CFM).

Secretary General: The Secretary General of the OIC.

General Secretariat: The General Secretariat of the OIC.

Chairman: The Chairman of a meeting of the CFM.

Observer: The Observer at the OIC as accepted in accordance

with the provisions of these Rules.

Rules: Rules governing the Observer Status at the OIC.

CHAPTER II CATEGORIES OF OBSERVERS

ARTICLE (3)

Observer status at the Organization of the Islamic Conference may be granted as set forth by Article 4 of the OIC Charter in accordance with these Rules to applicants from:

- (a) Member States of the United Nations eligible for observer status under the provisions of the Charter and wishing to follow the activities of the Organization as Observers
- (b) International and regional intergovernmental organizations eligible for observer status under the provisions of the Charter and wishing to follow the activities of the Organization as Observers.

CHAPTER III CONDITIONS FOR ADMISSION OF OBSERVERS

ARTICLE (4)

The State applying for observer status shall submit the application to the Secretary General, at least 4 months before the convening of the CFM meeting, enclosing a written explanation which shall include the following:

- 1. Statistics as to the percentage of Muslims in its territory compared to the total population and to the adherents of other religions in this State;
- 2. Information on the situation of Muslims in this State and on the adequacy of its legislation in force for the Muslim communities, ensuring them to enjoy their rights on equal basis with the adherents of other religions in this State.

ARTICLE (5)

The State applying for observer status shall commit to protect and promote the civil, political, economic, social and cultural rights, and fundamental freedoms of the Muslim Minorities and Communities holding its nationality on a par with all its other citizens, as provided for in related international agreements.

ARTICLE (6)

The application for Observer Status at the Organization shall include the applicant's commitment to and respect for the principles and objectives of the Charter, and that its conduct shall not be in contradiction with the resolutions, the rules and regulations of the OIC.

ARTICLE (7)

The State applying for observer status shall settle its conflicts with any of the OIC Member States.

ARTICLE (8)

The General Secretariat shall circulate the applications for Observer Status to the Member States at least ninety days before the CFM, upon fulfilling the conditions stipulated above.

ARTICLE (9)

The Council shall consider applications for observer status submitted through the General Secretariat, and decisions by the Council to grant observer status shall be adopted by consensus only.

ARTICLE (10)

The Council may cancel or suspend the Observer Status by consensus only if the observer fails to meet some or all the conditions for obtaining this status. The status may be restored upon the absence of the reasons that led to the cancellation or suspension of the observer status by a decision of the Council.

CHAPTER IV RIGHTS AND OBLIGATIONS

ARTICLE (11)

- (a) After the approval of the meeting, the Chairman of a Meeting, whenever he deems it appropriate, may allow the observer to deliver or distribute a statement in the Plenary Session and to make necessary clarifications if deemed appropriate.
- (b) Observers shall have no right to vote or to sponsor draft resolutions nor to submit proposals or draft resolutions. They shall have no right to submit candidatures in any elections within the OIC framework.
- (c) Subject to the Agreement on the Immunities and Privileges of the OIC, the representatives of an observer at the Organization shall enjoy the immunities and privileges necessary for carrying out their functions and missions. These representatives may also enjoy the facilities provided by the host State of the meeting to the members of participating delegations. Invitees mentioned in Article 13 below may enjoy the same facilities.

- (d) Observers referred to in Article (3) may be invited to attend meetings relating to their field of activity according to the provisions detailed in these rules.
- (e) Observers shall not attend the closed sessions of the Meeting except through an initiative from the Chairman after the approval of the Meeting.
- (f) Observers may participate in the OIC Working Groups Meetings at the request of the Chairmen of these Groups after approval of the Member States.

CHAPTER V GENERAL PROVISIONS

ARTICLE (12)

The Organization shall not bear any financial obligations resulting from the participation of observers in the meetings.

ARTICLE (13)

Representatives from Muslim communities, institutions and personalities from non-Member States whose action, credibility or participation may help promote the objectives of the OIC Charter, Council or Meetings, may be invited to attend the meetings of the Organization as guests on ad-hoc basis after coordination with the host State.

The Secretary General shall circulate, sixty days before the meeting, for consideration by the Member States a list of the aforesaid representatives who may be invited to attend the meetings of the Organization. In the absence of any objection from any Member State, which must be communicated to the Secretariat at least 30 days prior to the meeting, the Secretary General may recommend to the host country of the meeting in question that these representatives be invited as guests on ad-hoc basis.

The Secretary General shall prepare periodic reports on the situation of Muslim minorities and communities living in the country which was granted the observer status.

ARTICLE (14)

These Rules shall not affect the Status of current observers at the time of their adoption. Those observers shall be governed by these new rules upon their approval by the Council.

ARTICLE (15)

These Rules shall come into force as of the date of their approval by the Council.

RESOLUTION NO. 2/38-ORG ON OIC AFFILIATION REQUEST SUBMITTED BY THE INTERNATIONAL ISLAMIC UNIVERSITY IN MALAYSIA

The Thirty-Eight Session of the Council of Foreign Ministers (Session of Peace Cooperation and Development), held in Astana, Republic of Kazakhstan from 26 to 28 Rajab 1432H (28 to 30 June, 2011),

Recalling the objectives and principles enshrined in the Charter of the Organization of the Islamic Conference (OIC) particularly of creating conditions conducive for sound upbringing of Muslim children and youth, and inculcating in them Islamic values through education for strengthening their cultural, social, moral and ethical ideals,

Recalling Article 25 of the Charter of the Organization of the Islamic Conference (OIC), "Affiliated institutions are entities or bodies whose objectives are in line with the objectives of this Charter, and are recognized as affiliated institutions by the Council of Foreign Ministers. Membership of the institutions is optional and open to organs and institutions of the Member States. Their budgets are independent of the budget of the General Secretariat and those of subsidiary organs and specialized institutions,

Recalling Resolution No. 9/14-C on the International Islamic University in Malaysia, adopted by the 14th session of the Islamic Conference of Foreign Ministers which commended the establishment of the International Islamic University in Malaysia and called on member states to sign the documents of its establishment in the framework of cultural cooperation with the Government of Malaysia so that the University can achieve the objectives for which it was established.

Recalling also Resolutions 10/4-C(I.S.) and 2/5-C(I.S.) adopted by the fourteenth and fifteenth sessions of the Islamic Summit respectively which commended the signing of the agreement establishing the University in Malaysia with the OIC and called on he ISF and other OIC Specialized Organs and Institutions to provide all moral, technical and financial assistance to the university,

Having considered the proposal from International Islamic University Malaysia (IIUM);

Recognizing the contributions of the International Islamic University Malaysia towards capacity building and advancement of knowledge in the OIC Member States since its inception:

- 1. **Decides** to accept the request of affiliation of the International Islamic University Malaysia to the Organization of the Islamic Conference, provided such does not involve financial burden to the OIC;
- 2. **Requests** the Secretary General to follow up the implementation of his resolution and present a report thereon to the 39th Session of the Council of Foreign Ministers.

Recalling article 11 of the Ten-year Programme of Action adopted by the 3rd Extraordinary Islamic Summit Conference held in Makkah Al Mukarramah on 5 and 6 Dhul Qaada 1426H (7 and 8 December 2005) on "Reform the OIC through restructuring and consider changing its name, review its Charter and activities..."

Considering that significant work embarked upon by the OIC in comprehensively amending its Charter resulted in preparing a new charter for the Organization,

Aware of the importance of changing the name of the Organization and choosing a new name that better reflects the functions and objectives of the Organization,

Recognizing the importance of preserving the acronym by which the Organization has been known throughout its long history (OIC),

Having considered the report of the Secretary General in this regard,

- 1. **Decides to** change the name of (The Organisation of the Islamic Conference) to (Organisation of Islamic Cooperation);
- 2. **Requests** the Secretary General to follow up the implementation of this resolution and to present a report thereon to the 39th session of the Conference of Foreign Ministers.

RESOLUTION No. 5/38-ORG ON ADOPTING A NEW EMBLEM FOR THE ORGANIZATION OF THE ISLAMIC CONFERENCE

Aware of the importance of the provision of article 7 of the Charter of the Organization of the Islamic Conference which states that: "The Islamic Summit shall deliberate, take policy decisions and provide guidance on all issues pertaining to the realization of the objectives as provided for in the Charter and consider other issues of concern to the Member States and the Ummah,"

Recalling article 8 of the Charter of the Organization of the Islamic Conference which provides that: "The Islamic Summit shall convene every three years in one of the Member States,"

Considering the rapid changes taking place around the world due to the effects of globalization and the emergence of new issues everyday thus constituting challenges to the continuous prosperity and development of the Ummah,

Recognizing the importance of accelerating the frequency of convening the meetings of the Islamic Summit biennially instead of every three years in order to increase the Organization's capacity to respond to the challenges facing the Ummah regarding issues which emerge regularly,

Having considered the report of the Secretary General in this regard,

- 1. **Recommends** to the next Islamic Summit the convening of its session biennially instead of every three years, and to initiate a process of amendment to article 8 in accordance with article 36 of the Charter, following an intergovernmental work that can be carried out by the Senior Official Meeting preparatory to the Summit,
- 2. **Recommends** that the amendment shall not come into effect before the 13th Session of the Islamic Summit.
- 3. **Requests** the Secretary General to follow up the implementation of this resolution and to present a report thereon to the 39th session of the Conference of Foreign Ministers.

RESOLUTION NO. 9/38-ORG ON

REVISION OF THE RULES OF PROCEDURE OF THE MEETINGS OF THE ORGANIZATION OF ISLAMIC COOPERATION

Noting with appreciation the recommendations of the Report No. OIC/IGGE-4/2009/REP.FINAL of the Meeting of the Fourth Inter-governmental Group of Experts on the Review and Rationalization of OIC Agenda Items and Resolutions;

- 1. **Requests** the General Secretariat, taking into account the views of the Member States, to develop a concept paper for the revision of the Rules of Procedure of the OIC Meetings;
- 2. **Requests** the Secretary General to seek the views of Member States on the revision of the Rules of Procedures and submit them to the Member States for their consideration.
- 3. **Decides** to establish an open-ended inter-governmental group of experts whose mission shall be the review of OIC Rules of Procedure.
