**RESOLUTION NO.1/38/POA  
ON THE  
IMPLEMENTATION OF THE OIC TEN-YEAR PROGRAMME OF ACTION  
(TYPOA)**

*The Thirty-eighth Session of the Council of Foreign Ministers (Session of Peace, Cooperation and Development), held in Astana, Republic of Kazakhstan, from 26 to 28 Rajab, 1432H (28-30 June, 2011),*

**Considering** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia on 6 to 7 Dhul Qaidah 1426H (7-8 December 2005),

**Welcoming** the adoption of the OIC Ten-Year Programme of Action (TYPOA) by the third Extraordinary Islamic Summit to meet the challenges facing the Muslim Ummah in the 21<sup>st</sup> Century;

**Re-affirming** the relevance of the TYPOA in providing the Muslim Ummah a forward-looking vision so as to enable the Muslim world to address the challenges of the Twenty-first Century by leveraging on the collective will of the Muslim Ummah and joint Islamic Action.;

**Considering** the call by the Makkah Declaration in its preamble for a Mid-Term Review of the TYPOA;

**Considering** the resolutions No. POA-36/1 of the 36<sup>th</sup> Session of the Council of Foreign Ministers of OIC Member States held in Damascus, Syrian Arab Republic on 23-25 May 2009 and No. 1/37-POA of the 37<sup>th</sup> Session of the Council of Foreign Ministers held in Dushanbe, Republic of Tajikistan on 18-20 May 2010 concerning the Mid-Term Review of the TYPOA;

**Having** regard to the resolution of the 26<sup>th</sup> Session of the OIC Standing Committee for economic and Commercial Cooperation (COMCEC) held in Istanbul, Turkey on 5-8 October 2010;

1. **Takes note**, with appreciation, the outcome of the Mid-Term Review exercise carried out by the OIC Standing Committees i.e. the Standing Committee on Economic and Commercial Cooperation (COMCEC), the Standing Committee on information and Cultural Affairs (COMIAC), and the Standing Committee on Scientific and Technological Cooperation (COMSTECH).
2. **Further notes**, with satisfaction, the progress made in the implementation of the TYPOA during the past five years and commends the efforts of the Secretary General in this regard.

3. **Invites** the Member States to continue their contribution to the implementation of the OIC Ten-Year Programme of Action, and to take full advantage of the opportunities afforded by the Programme and its various projects.
4. **Calls on** all Member States, in accordance with the vision and mandate of the TYPOA, to expedite the signing and ratification of Agreements and Protocols, aimed at fostering joint Islamic action and cooperation within the OIC Member States with a view to preparing the Muslim Ummah to face effectively the challenges of the 21<sup>st</sup> century.
5. **Underlines** the pivotal role of the OIC General Secretariat in the implementation of the TYPOA and appreciates the progress achieved so far through the actions taken by the Standing Committees, OIC General Secretariat, Subsidiary Organs and Specialized and Affiliated Institutions and invites them to exert more concerted efforts for a speedy implementation of the TYPOA and in the same context, pays tribute to the Secretary General for his leadership and distinct contribution in the implementation of this programme.
6. **Also commends** the role played by the OIC subsidiary organs, specialized and affiliated institutions in the implementation of the OIC Ten-Year Programme of Action.
7. **Invites** the Secretary General to follow up the implementation of the present Resolution and report thereon to the 39<sup>th</sup> Session of the Council of Foreign Ministers.
