## RESOLUTION No.1/37-IBO ON THE ISLAMIC OFFICE FOR THE BOYCOTT OF ISRAEL

The Thirty-seventh Session of the Council of Foreign Ministers, (Session of Shared Vision of a More Secure and Prosperous Islamic World), held in Dushanbe, Republic of Tajikistan from 4 to 6 Jumadal Jumadal Thani 1431H, (18-20 May, 2010);

**Inspired by** the principles and objectives enshrined in the Charter of the Organization of the Islamic Conference,

**Mindful of** the existing cooperation and coordination between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States, for the purpose of achieving optimal implementation of the principles and provisions of the Boycott of Israel,

**Based on** all the relevant Islamic resolutions, in particular Res. No. 1/36-IBO adopted by the  $36^{th}$  Session of the Council of Foreign Ministers, held in Damascus, Syrian Arab Republic on 28 Jumada Al-Awwal to  $1^{st}$  Jumada Al-Thani 1430H (23-25 May, 2009),

**Having considered** the report of the Secretary General on the Islamic Office for the Boycott of Israel,

## Decides to:

- 1. Invite the Member States to commit to the implementation of the provisions of the Islamic Boycott of Israel and to consider the legislations, and the rules and regulations governing the boycott action (general principles of the boycott, the Islamic law, the internal regulations of national offices and their periodic meetings) part of their national legislations in force.
- **2. Invite** those Member States that have not yet set up regional Islamic boycott offices in their countries to do so, to designate directors for these offices, and to nominate liaison officers with the Islamic main Office of the Boycott at the General Secretariat.

- **3.** Call on competent authorities in the Member States to provide the needed support to Islamic regional offices in their countries to perform the tasks assigned to them, considering that these offices are the executive tool of the provisions of the boycott.
- **4. Commend** the existing cooperation and coordination between the Islamic Office for the Boycott of Israel at the OIC General Secretariat and the Arab Office for the Boycott of Israel at the General Secretariat of the League of Arab States, for the purpose of achieving optimal implementation of the principles and provisions of the Boycott of Israel
- **5. Stress** the support to the Office for the Boycott of Israel to enable it to perform its duties and tasks aimed at increasing the efficiency of the boycott of Israel in Islamic States.
- **6. Request** the Secretary-General to follow up the implementation of the present resolution and report thereon to the 38<sup>th</sup> Session of the Council of Foreign Ministers (CFM).
