RESOLUTION No. 1/37-AF

**ON THE REPORT OF THE GENERAL SECRETARIAT ON THE
STATUS OF THE ARREARS OF MANDATORY CONTRIBUTIONS OF
THE MEMBER STATES**

The Council of Foreign Ministers in its thirty-seventh session (Session of Shared Vision of a More Secure and Prosperous Islamic World), held in Dushanbe, Republic of Tajikistan from 4th to 6th Jumadu Thani 1431H (18th to 20th May 2010),

Having considered the report of the General Secretariat on the status of the arrears of the mandatory contributions of the member states towards its budgets;

Pursuant to the recommendations of the 38th Session of the Permanent Finance Committee;

1. **Recommends** that the General Secretariat conduct an exhaustive study on the financial position of arrears and to make proposals in this regard to be submitted to the 39th session of the Permanent Finance Committee in 2010 for examination and submission to the 38th Session of the Council of Foreign Ministers.
2. **Urges** the member states to pay their respective mandatory contributions towards the budgets of the General Secretariat and the Subsidiary Organs for the financial year 2010 and, for the defaulting member states, to settle their arrears so as to enable those organs to carry out their tasks.

RESOLUTION No. 2/37-AF

ON THE AUTHORIZATION TO THE 39TH PFC TO APPROVE THE BUDGETS OF 2011 OF THE GENERAL SECRETARIAT OF THE OIC AND ITS SUBSIDIARY ORGANS AS WELL AS ANY FINANCIAL AND ADMINISTRATIVE ISSUES REFERRED TO IT.

The Council of Foreign Ministers in its thirty-seventh session (Session of Shared Vision of a More Secure and Prosperous Islamic World), held in Dushanbe, Republic of Tajikistan from 4th to 6th Jumadu Thani 1431H (18th to 20th May 2010),

Taking into consideration the recommendations of the Senior Officials Meeting Preparatory to the 37th Council of Foreign Ministers on the General Secretariat's request to the 37th CFM to authorize the 39th PFC to approve the proposed budgets of the General Secretariat of the OIC and its subsidiary organs for the financial year 2011 as well as any financial and administrative issues referred to it;

Recalling Financial Regulations of the OIC, according to which the CFM has the authority to decide on the budget and other financial and administrative issues proposed by the PFC;

Taking into Consideration the need to reschedule the convening of the annual CFM meetings to the last quarter of the calendar year due to the change of the OIC financial year to coincide with the Gregorian Calendar;

Decides to grant to the 39th PFC the exceptional mandate of examining and approving, on behalf of the Council, the proposed budget of the General Secretariat of the OIC and its subsidiary organs for the financial year 2011; as well as all administrative and financial issues referred to it. Such a mandate shall not set any precedence for the future.
