RESOLUTION NO.1/37/POA ON THE IMPLEMENTATION OF THE OIC TEN-YEAR PROGRAMME OF ACTION (TYPOA)

The Thirty-seventh Session of the Council of Foreign Ministers (Session of Shared Vision of a More Secure and Prosperous Islamic World), held in Dushanbe, Republic of Tajikistan, from 4 to 6 Jumada al-Thani, 1431H (18-20 May, 2010),

Considering the Declaration of the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia on 6 to 7 Dhul Qaidah 1426H (7-8 December 2005),

Welcoming the adoption of the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21st Century;

Taking Note that the OIC Ten Year Programme of Action provides the Islamic Ummah with a new forward-looking vision that enables the Islamic world to address the challenges of the Twenty-first Century by leveraging on the collective will and Joint Islamic Action;

Underlining the need to ensure sustainable development of Member States through effective policy to protect the environment.

Considering the resolution of the 11th Islamic Summit Conference on Economic Affairs which was held in Dakar, Republic of Senegal on 13-14 March 2008;

Further considering the resolution of the 36th Session of the Council of Foreign Ministers of OIC Member States held in Damascus, Syrian Arab Republic on 23-25 May 2009;

Having regard to the resolution of the 25th Session of the OIC Standing Committee for economic and Commercial Cooperation (COMCEC) held in Istanbul, Turkey on 5-8 November 2009;

1. **Invites** the Member States to continue their contribution to the implementation of the OIC Ten-Year Programme of Action, and Urges them to finalize the establishment of national committees and focal points to implement the Programme, and to provide them with the needed support.

2. **Calls on** all Member States, in accordance with the vision and mandate of the TYPOA, to sign and ratify Agreements and Protocols, aiming at fostering cooperation within the OIC Member States and joint Islamic action with a view of preparing the Muslim Ummah to face effectively the challenges of the 21st century.

3. Urges all Member States as well as all OIC institutions to actively participate in the process of the Mid-Term review of the Programme.

4. **Underlines** the pivotal role of the OIC General Secretariat in the implementation of the TYPOA and appreciates the progress achieved so far through the actions taken by the OIC General Secretariat, Standing Committees, Subsidiary Organs and Specialized and Affiliated Institutions and invites them to exert more concerted efforts for a speedy implementation of the TYPOA and in the same context, pays tribute to the Secretary General for his leadership and distinct contribution in the implementation of this programme.

5.. **Welcomes** the decision of the 36th Session of CFM to organize mid term review meetings in 2010 during the ordinary sessions of the OIC Standing Committees: the Standing Committee on information and Cultural Affairs COMIAC), the Standing Committee on economic and Commercial Cooperation (COMCEC), and the Standing Committee on Scientific and Technological Cooperation (COMSTECH) with a view to undertaking practical review of the implementation of the Ten-Year Programme of Action and to taking necessary measures towards effective and timely implementation of this programme.

6. **Takes note** with appreciation of the decision of the 25th Session of the COMCEC to include the Mid-Term Review of the Ten-Year Programme of Action in the agenda of its 26th Session to be held in Istanbul, Turkey in October, 2010.

7. **Welcomes** the decision of COMIAC and COMSTECH to carry out the Mid-Term Review of the Implementation of the Ten-Year Programme of Action during the year 2010 and prepare reports thereon.

8. **Invites** similarly Subsidiary Organs, Specialized and Affiliated Institutions to, within their mandates, undertake the Mid-Term Review of the implementation of the Ten-Year Programme of Action and prepare reports thereon.

9. **Requests** the General Secretariat to compile the Mid-Term Review reports from Member States, OIC Standing Committees, Subsidiary Organs, Specialized and Affiliated Institutions and propose a draft synthesis report on the outcome of the Mid-Term Review to the next session of the Islamic Commission for Economic, Cultural and Social Affairs (ICECS) for its submission to the 38th Session of the Council of the Foreign Ministers and the 12th Islamic Summit.

10. **Invites** the Secretary General to follow up the implementation of the present Resolution and report thereon to the 38th Session of the Council of Foreign Ministers.
