RESOLUTION No. 1/35-E ON THE ECONOMIC ACTIVITIES RELATED TO THE IMPLEMENTATION OF THE OIC TEN-YEAR PROGRAMME OF ACTION

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

Having considered the report of the Secretary General on the matters;

A. ECONOMIC SITUATION OF THE MEMBER STATES:

<u>Recalling</u> Resolutions Nos.1/10-E(IS) and 8/10-E(IS) adopted by the Tenth Session of the Islamic Summit Conference; Resolutions No.1/34-E adopted by the Thirty-Fourth Islamic Conference of Foreign Ministers;

Having considered the report of the SESRIC on the matter,

- 1. **Urges** the Member States to pursue efforts aimed at strengthening economic and commercial cooperation as well as economic policy coordination among them so as to maximize the complementarities in their economies and avoid further marginalization.
- 2. **Underlines** the need to devise ways and means to minimize the adverse effects of the globalization on the economies of the OIC Member States as well as to enable them to harness opportunities provided by globalization.
- 3. **Calls on** the international community to adopt appropriate measures to ensure that the benefits of globalization are shared by all countries on an equitable basis so as to ensure balanced advantages and obligations of developing countries including OIC Member States.
- 4. Affirms that the private sector in the Member States should play a prominent role in giving impetus to intra-OIC economic and trade relations and invites the Governments of Member States to encourage their businessmen and representatives of the Private Sector to undertake a proactive role in this sphere.

B. ECONOMIC PROBLEMS OF THE LEAST DEVELOPED AND LAND-LOCKED MEMBER STATES:

<u>Recalling</u> Resolutions Nos.5/10-E(IS), 6/10-E(IS), 7/10-E(IS) adopted by the Tenth Session of the Islamic Summit Conference; and Resolutions No. 1/34-E adopted by the Thirty-Fourth Islamic Conference of Foreign Ministers;

<u>Noting with appreciation</u> the efforts made by all development partners including OIC General Secretariat and its Institutions;

Having taken note of the report of the SESRIC,

- 5. **Appeals** to the international community, particularly the developed countries, to fully and expeditiously implement the Programme of Action for 2001-2010 adopted by the Third United Nations Conference on the Least Developed Countries held in Brussels from 14 to 20 May, 2001.
- 6. **Emphasizes** the importance of achieving reductions in the outstanding debt of the Least Developed Countries to sustainable levels through debt-relief measures, in order to help relieve their financial burdens, enhance their credit-worthiness and improve their external financial prospects.
- 7. **Expresses** its appreciation for the Heavily Indebted Poor Countries (HIPCs) debt relief initiative and **calls** for its accelerated implementation in order to enable more eligible countries to benefit from the initiative.
- 8. **Urges** that the approach in the debt settlement should cover all types of debt, including multilateral debt, and all indebted developing countries, and incorporate measures aimed at a once-and-for all reduction arrangement to reduce their debt burden to a scale that would allow them to resume their economic growth and development.
- 9. Welcomes the setting up of a Special Program for the Development of Africa (SPDA) as yet another fundamental step in the implementation of the mandates of he TYPOA, expresses its appreciation for the efforts of the Islamic Development Bank in this regard and thanks to the Government of the Republic of Senegal for hosting the Ministerial Meeting on the SPDA, held in Dakar, on 22-23 January, 2008 and the Secretary General for his continuous support to this programme.
- 10. **Thanks** the Initiative of Turkey on African Development Strategy (ADS) aiming to boost the economic and commercial relations between Turkey and African OIC Member States and help develop their economies.

- 11. **Commends** the decision of the Kingdom of Morocco to cancel the debts of the Least Developed African Countries and the initiative to Council Custom Tarif of the products of Least Developed African Countries to enable them access the Moroccan Market.
- 12. **Recognizes** the necessity to respond effectively to the needs of Land-locked and transit countries so as to allow them to develop their transport infrastructure and road network and called on the developed countries to provide the necessary assistance to promote trade among the various parties.
- 13. Also emphasizes the need to implement the Almaty Programme of Actions, which was adopted at the Untied Nations International Ministerial Meeting of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions of Transit Transport Cooperation, held in August 28-29, 2003, in Almaty, Kazakhstan, to strengthen transit and transport cooperation among Member States of the OIC.

C. ECONOMIC PROBLEMS OF THE PALESTINIAN PEOPLE IN THE OCCUPIED PALESTINIAN TERRITORIES, OF THE SYRIAN CITIZENS IN THE OCCUPIED SYRIAN GOLAN HEIGHTS AND OF THE LEBANESE CITIZENS IN OCCUPIED SOUTH LEBANON AND THE WESTERN BEKKA FORMERLY UNDER OCCUPATION:

<u>Recalling</u> Resolution No.9/10-E (IS) adopted by the Tenth Session of the Islamic Summit Conference; and Resolution No. 3/34-E adopted by the Thirty-Fourth Session of the Islamic Conference of Foreign Ministers;

<u>Believing</u> in the objectives and principles of the OIC Charter aimed at strengthening Islamic solidarity among the Member States, and conforming with mass international will that rejects arbitrary Israeli practices in the occupied Arab territory which lead to deterioration of the economic and social conditions of Arab citizens under the yoke of Israeli occupation, on the one hand, and that supports the establishment of a just and comprehensive peace in the Middle East region based on the (Land-for-Peace principle) UN Security Council Resolutions 242, 338, 425, 1397, 1402 and 1403 as well as the authority of the Madrid Peace Conference, on the other;

<u>Underlining</u> the unfailing efforts exerted by the Palestinian National Authority (PNA) to promote the economic structure; and to renovate what was destroyed by the Israeli aggression and in view of the escalation of the illegal and unlawful expansionist settlement policies of the Israeli government, in the occupied Palestinian territory, including Al-Quds Al-Sharif and the occupied Syrian Golan; and also in view of the

serious implications of this escalation on the existing difficult economic and humanitarian conditions of the Palestinian people in the occupied Palestinian territory and the Syrian citizens in the occupied Golan;

<u>Expressing</u> extreme concern over the grave economic impacts, resulting from the expansionist settlement policy of the Israeli government, on the difficult living conditions of the Palestinian people in the occupied Palestinian territory and those of the Syrian citizens in the occupied Syrian Golan as well as the Arab people in the occupied Arab territory;

- 14. **Invites** all concerned bodies to expedite the extension of the envisaged necessary assistance to help the Palestinian people to establish their national economy, consolidation of their national institutions and to enable them to establish their independent State with Al-Quds Al-Sharif as its capital.
- 15. **Calls upon** the international community to intervene to force Israel to release the Palestinian funds being held up by it and estimated at millions of dollars accruing from taxes and tariffs due to the Palestinian authority and levied by the Israeli government.
- 16. **Calls on** the Member States to continue to make generous contributions to the Al-Quds Fund, the Al-Quds Waqf and Beit Al-Mal of Al-Quds Al-Sharif, particularly in the light of the current conditions in the occupied territories where the infrastructure is being systematically destroyed.
- 17. **Urges** the private sector and investors of the Member States to undertake the execution of the economic, industrial, agricultural and housing programmes in the territories of the Palestinian National Authority with a view to supporting and strengthening the Palestinian national economy.
- 18. Urges the OIC Member States to carry all necessary actions at the international level to exert pressure on Israel to desist from resorting to imposition of the brutal blockades on the occupied Palestinian territory, including Al-Quds Al-Sharif which result in extremely painful economic effects on the Palestinian people and raise the level of unemployment among the Palestinians. It also hampers international efforts aimed at realizing development in the occupied Palestinian territory and the territory of the Palestinian National Authority.
- 19. **Calls on** Member States and the international community to compel Israel to pay the Government of Lebanon reparations for the plight of the Lebanese citizens in Southern Lebanon and the Western Beqaa who suffered Israeli aggressions throughout the occupation that has induced substantial losses and social complications and caused a quasi-permanent paralysis of economic activities in the region.

20. **Calls on** Member States and the international community to extend necessary assistance to the Lebanese citizens in South Lebanon and the Western Beqaa who have been constantly and every day the targets of Israeli aggression throughout the occupation period, thus entailing huge material losses and social hardships leading to a quasi permanent paralysis of the economic activities in the area.

D. ECONOMIC AND SOCIAL LOSSES FOR GREAT JAMAHIRIYA AS A RESULT OF THE SECURITY COUNCIL RESOLUTION NOS. 748/92 AND 883/93:

<u>Recalling</u> Resolutions Nos.11/10-E (IS) adopted by the Tenth Session of the Islamic Summit Conference; and Resolutions No. 6/33-E adopted by the Thirty-third Islamic Conference of Foreign Ministers;

<u>Recalling</u> the relevant resolutions adopted by the various fora of the Organization of the Islamic Conference, the Organization of African Unity, the League of Arab States and the Non-Aligned Movement;

21. **Reaffirms** the importance of paying due attention to this issue with a view to definitively pay reparations to the Libyan Arab people for the losses they have suffered as a result of the sanctions imposed on them pursuant to Security Council Resolutions No.748/1992 and 883/1993.

E. CAPACITY BUILDING FOR POVERTY ALLEVIATION IN THE OIC MEMBER STATES:

<u>Recalling</u> Resolution No.6/10-E(IS) adopted by the 10th Islamic Summit Conference;

<u>Recalling</u> also Resolution No.25/33-E adopted by the Thirty-third Session of the Islamic Conference of Foreign Ministers;

<u>Welcoming</u> the initiative of Malaysia to establish a Capacity Building Programme in the OIC Countries aimed at poverty alleviation in less developed and low income OIC countries;

<u>Stressing</u> the need to identify projects aimed at strengthening capacity-building in human resources development and the development of infrastructures particularly in the areas of health, education, agriculture, science and technology,

- 22. Welcomes the launching of the Capacity-building Programme for OIC countries on 29 March, 2005 in Kuala Lumpur by Dato' Seri Abdullah Ahmad Badawi, Prime Minister of Malaysia, with three projects of the First Phase in Bangladesh, Mauritania and Sierra Leone.
- 23. **Thanks** the Governments of Malaysia and Brunei Darussalam and the IDB for hosting the series of senior officials meetings of the Steering Committee to Establish a Capacity Building Programme for OIC Countries to consider the Programme's contents and its appropriate mechanism.
- 24. **Understands** that participation in the Programme is on a voluntary basis and it is not intended to set up any new fund or institutional structure.
- 25. **Notes** the efforts of the IDB and Malaysia to review the Programme to make it more effective in the future.
- 26. **Calls** upon the Member States to extend all support to the Programme in the spirit of progress and development of the Islamic Ummah.

F. THE ESTABLISHMENT OF THE INTERNATIONAL ZAKAT ORGANIZATION:

<u>Recalling</u> the Dakar Declaration adopted during the 11th Islamic Summit Conference in Dakar, Senegal which acknowledged the need to mobilize Zakat funds;

<u>Reiterating</u> the call from the Chairman of the 11th Islamic Summit Conference to mobilize Zakat funds for poverty alleviation;

<u>Recalling</u> paragraph 100 of the Final Communiqué of the Thirty-third Session of the Islamic Conference of Foreign Ministers held in Baku, Republic of Azerbaijan, on 23-25 Jamadul Awwal 1427H (19-21 June 2006), which calls among others, for establishing the World Zakat Authority;

Recognizing the significance of Zakat as a tool to reduce poverty among Muslims;

<u>Reaffirms</u> the importance of Muslim countries to cooperate in fighting poverty,

- 27. **Expresses** its thanks to the Government of Malaysia for organizing in collaboration with Islamic Chamber of Commerce and Industry the International Zakat Conference in Kuala Lumpur on 28 November 2006, as a step towards the establishment of the International Zakat Organization.
- 28. **Takes** note that the Malaysian authorities are working on finalizing the format of the establishment of the International Zakat Organization.

29. **Requests** the Secretary General to follow up the progress on the establishment of the International Zakat Organization and seek the views of Member States and the International Islamic Figh Academy.

G. COOPERATION IN ENERGIZING TRADE AND INVESTMENT IN COTTON SECTOR:

<u>Recalling</u> Resolution No. 1/34-E adopted by the Thirty-forth Session of the Islamic Conference of Foreign Ministers;

<u>Taking into account</u> the appeal made by the OIC to the international community to assist the Least-Developed Countries to be progressively integrated into the world economy and to strengthen their capabilities to participate in international trade;

<u>Noting with regret</u> that the policy of subsidy practiced by certain developed countries to support their cotton producers results in the fall of the commodity price of cotton in the international market penalizing the poorest cotton producer countries by drastically reducing their export revenues;

- 30. **Underlines** the necessity of taking all possible measures within the OIC to support the least-developed cotton-producer countries in their legitimate demand of securing greater added value in the processing of this product.
- 31. **Express its appreciation** to the Government of the Republic of Turkey, the OIC General Secretariat, the IDB and ICDT for successfully organizing the Second Experts Group Meeting (EGM) on Enhancing Production Efficiency and International Competitiveness in OIC Cotton Producing Countries, held in Izmir, Republic of Turkey, on 28-30 March 2006, and the Third EGM on Cotton, held in Antalya, Turkey, on 9-12 October 2006.
- 32. Endorses the Action Plan for OIC Cotton Producing Countries' Cooperation Development Strategy (2007-2011), which was adopted at the Third Expert Group Meeting on Enhancing Production Efficiency and International Competitiveness in OIC Cotton Producing Countries, held in Antalya, Turkey, on 9-12 October 2006, and approved by the 22nd Session of the COMCEC.
- 33. **Urges** the participating OIC Member States to take active part in the timely implementation of the Action Plan.
- 34. **Requests** the concerned Member States to nominate their focal points and define web-admins operating the Cotton Forum web-site (www.oic-cif.org) for the effective implementation of the Action Plan.

- 35. **Calls** upon the concerned Member States and concerned OIC Institutions to contribute to the updating of the materials contained in the Web Portal by providing all the related data and leads of information on the Cotton Sector.
- 36. **Invites** the General Secretariat of the OIC, IDB, ICDT, SESRIC and ICCI to organize, in collaboration with international and regional organizations concerned, an investment forum comprising the OIC cotton producing countries, financial institutions, textile industries, and research centers with a view to working out concrete projects and proposals for the implementation of the OIC Five Year Cotton Plan of Action.
- 37. Also requests the OIC General Secretariat in collaboration with the IDB, SESRIC, ICCI and ICDT to monitor the implementation of Action Plan and report on them to the annual sessions of the COMCEC and other OIC fora concerned.
- 38. **Thanks** the Republic of Turkey for hosting the OIC Forum on Enhancement and Promotion of Trade and Investment in Cotton Sector which was held in Istanbul, Turkey on 12-13 November 2007.
- 39. **Express** its appreciation to the Government of the Republic of Turkey for hosting the First Meeting of the Steering Committee for the implementation of the OIC Five Year Cotton Plan of Action, which was held in Antalya, Republic of Turkey, on 12 May 2008.
- 40. **Welcomes** the decision of the First Meeting of the Steering Committee for the implementation of the OIC Five Year Cotton Plan of Action to organize the First Meeting of the Project Committee by the IDB in 2008, before the 24th Session of the COMCEC.
- 41. **Requests** the IDB to prepare a Project Proposal Format prior to the First Meeting of the Project Committee and circulate the project format to the Member Countries and related institutions through OIC General Secretariat, and calls upon the concerned Member States, Centers of Excellence and private sector companies to submit project proposals ahead of the Project Committee Meeting.
- 42. Welcomes the initiative of the Nazilli Cotton Research Institute of Turkey, in its capacity as the Coordinator of the Centers of Excellence, to organize and host a meeting of the Centers of Excellence in the second half of 2008, in order to come up with specific project proposals to be implemented in the Member Countries.

43. **Recommends** that the cotton sector should be included in the Capacity-Building Programme of the OIC.

H. ON DEBT RELIEF IN FAVOUR OF AFRICAN COUNTRIES:

<u>Recalling</u> the resolution No.6/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference;

<u>Fully aware</u> of the pressing need for the OIC, its Member States and donor States, to further contribute to the fight against poverty in Africa and to the development of this continent;

<u>Inspired</u>, in this regard, by the Islamic Solidarity and by the relevant provisions of the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference, held in Makkah Al Mukarramah, Kingdom of Saudi Arabia, from 05-06 Dhul Qaada (7-8 December 2005) as an orientation instrument in which we have underlined the importance to be given to this issue;

<u>Considering</u>, in the framework, the appeal made to the donor States to write off bilateral and multilateral debts of OIC Member States "with limited revenues";

44. **Have decided** to urge the donor States, members of the OIC to take measures for debt relief in favour of African countries, with proportions and deadlines taking into consideration the heavy burden this debt constitutes for African economies.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on each item appearing from A to H to the Thirty-Sixth Session of the Council of Foreign Ministers.

RESOLUTION No. 2/35-E ON THE ACTIVITIES RELATED TO THE IMPLEMENTATION OF THE DECISIONS OF THE COMCEC

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

<u>Recalling also</u> the Strategy and Plan of Action to Strengthen Economic and Commercial Cooperation Among the Member States of the OIC, approved by the Tenth Session of the COMCEC and endorsed by the Seventh Islamic Summit Conference.

<u>Recalling</u> the resolutions adopted by Islamic Summit Conference and Islamic Conference of Foreign Ministers.

<u>Recalling</u> the resolutions adopted at the twenty-three previous sessions of the COMCEC initiating effective action in economic cooperation among the Member States;

<u>Also recalling</u> the resolutions of the Ministerial level meetings in different areas of cooperation held under the auspices of the COMCEC;

A. ACTIVITIES OF THE STANDING COMMITTEE FOR ECONOMIC AND COMMERCIAL COOPERATION (COMCEC):

<u>Recalling</u> Resolution No. 1/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No. 2/34-E adopted by the Thirty-fourth Islamic Conference of Foreign Ministers;

<u>Recalling also</u> Resolution No. 8/7-E(IS) of the Seventh Session of the Islamic Summit Conference, held in Casablanca, Kingdom of Morocco, from 11 to 13 Rajab 1415H (13-15 December 1994) which endorsed the Strategy and the Plan of Action;

<u>Noting with appreciation</u> the efforts of the General Secretariat, subsidiary organs, affiliated and specialized institutions of OIC, working in the field of economy and trade, to implement the resolutions of the COMCEC;

<u>Noting with appreciation</u> that the Strategy for Economic and Commercial Cooperation adopted by the COMCEC allows for cooperation among sub-groups of Member States and is based on the principles giving emphasis to private sector, economic liberalization, integration with the world economy, with due respect to the economic, political, legal and constitutional structures of the Member States and their international obligations; <u>Appreciating</u> that, starting with its Eleventh Session, COMCEC serves as a platform where the Ministers of Economy of the Member States could exchange views on current world economic issues;

Having taken note of the report of the Secretary General;

- 1. **Stresses** the need for COMCEC to continue to pay utmost attention to coordination and cooperation among Member States with regard to the membership of new countries that wish to join the World Trade Organization, and to the clarification of positions on the new issues and agreements under consideration within the framework of the WTO with a view to strengthening the negotiating position of these countries at the forthcoming multilateral trade negotiations especially with respect to the built-in agenda and to the new ones.
- 2. **Emphasizes** the need to implement the revised Plan of Action to Strengthen Economic and Commercial Cooperation Among Member States the OIC, in compliance with the principles and operational modalities of the Strategy and the procedures set forth in its chapter on Follow-up and Implementation.
- 3. **Invites** the Member States to host sectoral Expert Group Meetings in priority areas of cooperation in the Plan of Action, such as "Transport and Communications", "Food, Agriculture and Rural Development", "Health and Sanitary Issues", "Energy and Mining" and "Human Resources Development".
- 4. **Requests** the coordinators and the owners of the COMCEC projects to make necessary efforts for early implementation of these projects and also **calls on** all the Member States and OIC Institutions to propose new projects and programmes to enrich the agenda of the COMCEC through the Sessional Committee.
- 5. Welcomes the successful conclusion of the first and second rounds of trade negotiations for establishment of the Trade Preferential System among the Member States of OIC (TPSOIC) which produced the Protocol on Preferential Tariff Scheme (PRETAS) and the TPSOIC Rules of Origin and expressed its appreciation to the Republic of Turkey for hosting these rounds.
- 6. Adopts the TPS-OIC as the basis for reaching the 20 percent intra-OIC trade level set by the Ten-Year Program of Action as well for enhancing and deepening trade liberalization within the OIC Community.
- 7. **Endorses** the target date of January 1st, 2009, taken at the First Meeting of the Ministers of Commerce of the Member States of The Trade Negotiating

Committee on November 24th, 2006, in Istanbul, for the establishment of the Trade Preferential System among the Member States of OIC (TPS-OIC) and **urges** the Member States of the Trade Negotiating Committee to finalize the signature and ratification of the Protocol on Preferential Tariff Scheme (PRETAS) and the TPSOIC Rules of Origin at their earliest convenience in order to make the TPSOIC operational by January 1st, 2009.

- 8. **Invites** the Chairman of the COMCEC and the Secretary General of OIC to coordinate their efforts, with a view to achieve the required number of ratifying countries for the PRETAS and the TPSOIC Rules of Origin, in order to make the TPS-OIC a reality by the target date.
- 9. **Expresses its appreciation to** the Republic of Turkey for hosting a TNC meeting in Turkey on June 17-18 2008, which considered the last preparations undertaken by the TNC Member States before the implementation of the TPSOIC system, and **recommends** a Meeting of the Ministers of Commerce of the Member States of The Trade Negotiating Committee be held in 2008 to review the work of the Trade Negotiating Committee and evaluate the progress towards a fully operational TPS-OIC.
- 10. **Expresses its appreciation** to the COMCEC Coordination Office and the Islamic Centre for Development of Trade (ICDT) for their performance as the Secretariat of the Trade Negotiating Committee and **thanks** the Islamic Development Bank for contributing to the financing of the First and Second Round of the Trade Negotiations launched on April 6th 2004 and November 24th, 2006 respectively.
- 11. Welcomes the State of Qatar, the Kingdom of Saudi Arabia and the Sultanate of Oman as new members of the TNC. It also welcomes the signature by the Kingdom of Saudi Arabia of the Protocol on the Preferential Tariff Scheme (PRETAS) concluded on the margins of the 33rd meeting of the Board of Governors of the Islamic Development Bank held in Jeddah from 2-4 June 2008.
- 12. Notes with appreciation that the 23rd Session of the COMCEC was held from 13-16 November 2007, in Istanbul under the Chairmanship of the President of the Republic of Turkey and the 24th Session of the COMCEC will be held from 20-24 October 2008, in Istanbul and **calls upon** the Member States to effectively and actively participate in this meeting.
- 13. **Underlines** the crucial importance of the active participation of the private sector in economic cooperation among the Member States and **expresses** its appreciation to the Republic of Turkey for hosting the Economic Conference and the Business Forum on the sidelines of the 20th COMCEC and **welcomes**

the offer of the Republic of Turkey to host the Trade Fair and International Business Forum by Turkish Independent Businessmen and Industrialists' Association (MUSIAD) bi-annually as a sideline activity of COMCEC.

- 14. **Recognizes** that the Exchange of Views organized during the annual sessions of the COMCEC would be utilized to coordinate the positions of the Member States vis-a-vis major world economic issues and **welcomes** the initiatives of COMCEC on a new mechanism for the preparation and implementation of the exchange of views sessions. **Also welcomes** the decision taken by the 23th Session of the COMCEC that "improving investment climate" be the theme for the exchange of views at the 24th Session of the COMCEC.
- 15. Notes with appreciation that the 11th Trade Fair of Islamic Countries was successfully organised in Dakar, Republic of Senegal from 21st to 25th November 2007 under the High Patronage of the President of the Republic of Senegal.
- 16. Welcome the offers of the Arab Republic of Egypt and the Republic of Guinea to host the 12th and the 13th editions of the Trade Fair of Islamic Countries.
- 17. **Thanks** the Republic of Turkey for hosting the Experts Group Meeting on Tourism Development in Istanbul, Republic of Turkey, on 9-11 May 2007.
- 18. Welcomes the holding of OIC Forum on Enhancement and Promotion of Trade and Investment in Cotton Sector which was held in Istanbul, Turkey on 12-13 November 2007 and thanks the Republic of Turkey for hosting it and calls upon the Member Countries to support the OIC Cotton Plan of Action and deepen cooperation in this important sub-sector.
- 19. **Thanks** the Republic of Turkey for hosting the 9th Meeting of OIC Standardization Expert Group from 16 to 18 April, 2008 in Ankara with the task of studying and developing OIC Halal Food Standards.
- 20. Welcomes the initiative of the COMCEC to develop cooperation with relevant international organization like ITC, UNCTAD, UNIDO, WTO, FAO, IFAD, etc. with a view to develop specific projects for trade promotion and capacity enhancement in the member countries.
- 21. **Thanks** the Republic of Turkey for hosting the Twenty Fourth Meeting of the Follow-up Committee of the COMCEC in Antalya on 13-15 May 2008.

- 22. **Takes** note that the OIC Task Force to help reach the target level of 20% intra-OIC trade as set out by the OIC Ten Year Program of Action, held its first meeting on May 12, 2008 in Antalya, Turkey.
- 23. **Recognizes** the importance of the international food crisis in the economies of several member states, and **urges** the OIC General Secretariat and its institutions as well as COMCEC to initiate action in dealing with this crisis.
- 24. **Requests** the General Secretariat and IDB to organize a new meeting of Ministers of Agriculture of the OIC Members States with a view of addressing the issue of food security and agricultural development to assist OIC Member States to, inter alia, develop their own agricultural development strategies aiming at achieving food security and **invites** Member States to support this initiative and offer to host the Ministerial Meeting.
- 25. **Further Requests** the OIC General Secretariat in cooperation with IDB and other OIC institutions to study the impacts of food crisis in the Member States and explore the possibility of implementing food security programmes in the OIC Member States.
- 26. Also requests the OIC General Secretariat in cooperation with IDB and other OIC institutions to study the impact of high oil and commodity prices on the economies of Member States with a view to suggesting policy options for possible implementation at both individual and collective levels.
- 27. **Stresses** the importance of supporting financially the national and regional policies for agricultural development, through major investments in this sector including food security, irrigation, the provision of agricultural equipment, fertilizers and pesticides etc.
- 28. **Requests** the OIC General Secretariat to communicate with OISA to prepare a report regarding the obstacles faced in the area of transportation and logistics in the member states and also the policy recommendations in coordination with other OIC institutions to be presented to the 25th Session of the COMCEC.
- 29. **Requests** the member states who did not do so, to sign and ratify the agreements and statutes.

B. STRENGTHENING THE MULTILATERAL TRADING SYSTEM:

<u>Recalling</u> Resolution No.1/11-E (IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No. 3/34-E adopted by the Thirty-fourth Islamic Conference of Foreign Ministers;

<u>Recalling</u> the related decisions of the COMCEC which have the subject on its agenda as a permanent item;

<u>Appreciating</u> the efforts of IDB and ICDT in assisting and appraising the Member States on matters related to WTO.

<u>Recognising</u> that the effective functioning of the multilateral trading system is pivotal in contributing towards enhancing growth and development;

Taking note with appreciation of the reports submitted by IDB and ICDT;

Having taken note of the report of the Secretary General;

- 30. **Calls** on OIC Member States who have acceded to the WTO to support and facilitate negotiations for the accession of the other Member States which have not yet joined the WTO.
- 31. Urges the WTO and its Member States to:
 - i. **facilitate** the accession of all States to the WTO to ensure its universality in decision-making, emphasize the importance of clarity and transparency of membership procedure, and avoid requiring states wishing to adhere to meet unfair requirements or conditions beyond the commitments of member states with equal status on the development scale;
 - ii. **ensure** that the agenda for further negotiations remains focused, balanced and manageable, taking into account the limited resources and the level of development of many developing countries, in particular the LDCs;
 - iii. **rejects** the inclusion of non-trade issues, such as labour and environmental standards, into the work programme of the WTO, given its detrimental effects to the evolution of a just, free and fair trading environment as reiterated by most WTO members;
 - iv. **ensures** the availability of sufficient resources for technical cooperation activities to assist developing countries implement WTO agreements and decisions
 - v. **review** the structure of the decision making process of the WTO to ensure greater transparency of the WTO process and ensuring effective participation of WTO members in this process;

- vi. **ensures** that technical assistance by WTO shall also contribute to capacity building in developing countries, in particular the LDCs.
- 32. **Commends** the IDB and ICDT for its sincere efforts in raising awareness among OIC Member States of the wide-ranging impact of the Uruguay Round agreements on their economies, and in reinforcing the capabilities of Member States, including its negotiating capabilities, preparing them fully for the negotiations in the context of the WTO, and calls on IDB and ICDT to continue in this efforts.
- 33. **Appreciates** also the technical assistance programmes of the Islamic Development Bank to assist Member States which are either member of the WTO or in the process of accession to the Organization.
- 34. **Requests** IDB and ICDT to continue their efforts and submit periodic reports to the COMCEC and related OIC fora.

C. PROMOTION OF COOPERATION AMONG THE STOCK EXCHANGES OF THE OIC COUNTRIES:

<u>Recalling</u> Resolution No.1/11-E (IS) adopted by the Eleventh Session of the Islamic Summit Conference;

Recalling Resolution No. 2/34-E adopted by the Thirty-fourth Session of the Islamic Conference of Foreign Ministers;

<u>Noting that</u> in the context of current world economic situation the OIC member states require developing their economic structures and consolidating economic relations among themselves and with other countries by creating the appropriate climate to attract and stabilize investments;

<u>Taking note with appreciation</u> the study prepared by SESRIC on the establishment of an Islamic Stock Exchange Union;

- 35. Urges Member States to continue to take the necessary steps to mobilize internal resources in the form of stocks and shares and to facilitate the optimal utilization of such resources in profitable investment projects both in public and private sectors.
- 36. **Invites Member States** to press on with undertaking the necessary steps to develop their stock markets through appropriate legislations so as to enable their markets to be open to the outside world facilitating the in-flow of capital

available in foreign markets, while taking into consideration the economic and monetary interests of these States.

- 37. **Urges** Member States to make every possible effort to expand the establishment of private companies facilitating wide subscription of shares among large numbers of individuals;
- 38. **Invites Member States** to set up a comprehensive database on their respective stock exchange and investment regimes and to explore the possibility of concluding regional agreements among themselves to establish links among their stock exchanges;
- 39. Notes with appreciation the creation of a platform for cooperation among the OIC stock exchanges called "Islamic stock exchange forum" as an outcome of the Round Table Meeting on "Promotion of Cooperation among the Stock Exchanges of the OIC Member States" and calls upon the Member States to inform their Stock Exchanges about the Forum and invite them to join it.

D. ESTABLISHMENT OF AN ISLAMIC COMMON MARKET:

<u>Recalling</u> all resolution of the Islamic Summit and Foreign Ministers Conference, the most recent of which were resolutions No.1/11-E(IS) and No.2/34-E;

<u>Also recalling</u> the provision of the OIC Plan of Action to Strengthen Economic and Commercial Cooperation among Member States;

<u>Taking into account</u> that the formation of Islamic Common Market is a long-run process and requires comprehensive studies and at the same time requires its own implementation and follow up arrangements;

Having considered the report of the Secretary General on the matter;

- 40. **Emphasizes** also the need to reinforce economic cooperation establishing free trade zones and common markets among the Member States through their regional groupings as a positive stage towards the ultimate goal of creating an Islamic Common Market.
- 41. **Takes note** of the recommendations contained in the report of the Second Meeting of the Experts Group (EGM), and **requests** the COMCEC to examine the recommendations contained in the report of the EGM, particularly convening the meeting of the relevant working group.
- 42. **Requests** the COMCEC to coordinate the efforts and studies undertaken or to be undertaken in this regard by ICDT or the other relevant OIC institutions

and centres, with a view to taking necessary practical steps to reach the objectives related to the establishment of an Islamic Common Market.

43. Welcomes the efforts undertaken by the COMCEC for the establishment of the Trade Preferential System among the member states of OIC (TPS-OIC) as of January 1st, 2009, as a very concrete and important step for the liberalization of trade among the OIC member countries as well as the ultimate goal of the Islamic Common Market.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on each item appearing from A to D to the Thirty Sixth Session of the Council of Foreign Ministers.

RESOLUTION No. 3/35-E ON THE ACTIVITIES RELATED TO ECONOMIC ASSISTANCE TO MEMBER STATES AND NON-OIC COUNTRIES AND MUSLIM COMMUNITIES

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

A. ECONOMIC ASSISTANCE TO THE REPUBLIC OF AFGHANISTAN:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No.3/34-E adopted by the Thirty Fourth Islamic Conference of Foreign Ministers;

<u>Taking into account</u> that Afghanistan is still facing serious constraints due to more than two decades of war and its aftermath consequences which resulted in the demolition of its economic and social infrastructure;

<u>Taking also into</u> account the participation of the Member States and the Secretary General of the OIC in the Donors Conference held in on 21-22 January 2002 in Tokyo; and in March 2004 in Berlin; and finally 31 January - 1 February 2006 in London;

<u>Expressing</u> its appreciation for the progress made by the Islamic Republic of Afghanistan in the implementation of the strategy and guidelines laid down by the Donors Conferences held in Tokyo 2002, Berlin 2004, and London 2006;

<u>Highly appreciate</u> the Secretary General of the Organization of the Islamic Conference for his valuable efforts made in the political, economic and social sectors of Afghanistan, in particular his initiative to hold OIC Organs' Assistance Conference for the Reconstruction of Afghanistan in Jeddah;

<u>Noting</u> that about 70% to 80% of its economic and social infrastructures have been destroyed during the two decades of war; encourages the Member States to actively participate in the reconstruction of Afghanistan;

<u>Bearing</u> in mind the importance of the voluntary and sustainable repatriation and reintegration of the Afghan refugees and displaced people to their homeland and place of origin;

<u>Recognizing</u> that about 10 million mines were planted in different parts of the country, <u>still</u> taking the lives of thousands of people annually, and disabling many others;

<u>Taking cognizance</u> of the OIC Trust Fund for the assistance of the people of Afghanistan, and the importance of the continuation of its activities;

<u>Noting also</u> that the Government of the Islamic Republic of Afghanistan still needs critical international support and assistance in its efforts at stabilization and reconstruction of the war-ravaged country;

<u>Keeping in mind</u> the 17th meeting of the Council of Ministers (COM) of the Economic Cooperation Organization (ECO) which was held in Herat, Islamic Republic of Afghanistan, on 20 October 2007, aimed at enhancing economic and trade cooperation among the ECO member countries and to achieve sustainable economic growth;

<u>Recalling</u> the Joint Coordination and Monitoring Board (JCMB) meeting, which was held on 5-6 February 2008, in Tokyo, Japan, to reassess the achievement made in the field of service delivery and the fulfillment of the commitment made for the reconstruction of Afghanistan;

Having taken note of the report of the Secretary General;

- 1. **Calls** for a major international effort to provide humanitarian assistance to the Afghan people;
- 2. Urges the Member States who have pledged to contribute to the OIC Trust Fund for the assistance of the people of Afghanistan to fulfill their commitment and further urges all other Member States to donate to this Fund in order to enhance its capacity and ensure the continuation of its activities;
- 3. **Expresses** support to the outcome of the Paris Donors Conference held in 12 June, 2008, to examine donor coordination since 2002, and discuss concrete proposals for better coordination and best practices in support of the implementation of the Afghanistan Compact of the Afghanistan National Development Strategy, under the ownership of the people of Afghanistan;

- 4. **Urges** the OIC Trust Fund for the assistance of the people of Afghanistan to expeditiously implement its commitment to the people of Afghanistan.
- 5. **Urges** Member States, Islamic institutions and international organizations to provide urgent humanitarian assistance to Afghanistan and to the internally displaced Afghans as well as to the existing Afghan refugees in neighboring countries, particularly the Islamic Republic of Pakistan and the Islamic Republic of Iran to ensure their voluntary and sustainable repatriation, reintegration and resettlement in their homeland.

B. ECONOMIC ASSISTANCE TO THE REPUBLIC OF AZERBALJAN:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No.3/34-E adopted by the Thirty Fourth Islamic Conference of Foreign Ministers;

<u>Confirming</u> full solidarity of the Member States of the OIC with the Government and people of Azerbaijan at this very critical time of the country's history;

<u>Referring</u> to the relevant UN Security Council Resolutions regarding this conflict;

<u>Deploring</u> the Armenia-backed aggressive separatism instigated in the Nagorno-Karabakh region of the Republic of Azerbaijan, followed by aggression and occupation by Armenia of about 20 percent of Azerbaijani territories and resulted in violent displacement of almost one million Azerbaijani people from their homes, which, as such, resembles the terrible concept of ethnic cleansing;

<u>Conscious</u> of the fact that economic damage inflicted upon Azerbaijan in its territories currently occupied by Armenia already exceeds US\$ 60 billion;

<u>Welcoming and appreciating</u> the assistance extended by some Member States and OIC relevant bodies, United Nations institutions and international organizations;

Having taken note of the report of the Secretary General;

6. **Appeals** to the Member States, International Community and Islamic Institutions to make available to the Government of Azerbaijan the economic and humanitarian assistance with a view of alleviating the suffering of the Azerbaijani people.

7. **Calls upon** the international organizations to continue to grant humanitarian and financial assistance to Azerbaijan.

C. ECONOMIC ASSISTANCE TO THE REPUBLIC OF CHAD:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No.3/34-E adopted by the Thirty Fourth Islamic Conference of Foreign Ministers

<u>Considers</u> the massive presence of refugees on the Chadian territories on the one hand, and the continued situation of the displaced Chadian population who are living under drastically deplorable conditions on the other hand;

<u>Takes</u> note of the principles and objectives of the OIC Charter and the commitment of the member states to the strengthening of international peace and security.

- 8. **Invites** Member States, Islamic institutions and the international organizations to extend urgent financial and economic assistance to Chad in order to face the multiple problems of refugees and the displaced who are living on its territory and to implement its socio-economic programs.
- 9. **Appeals** to Member States, Islamic institutions and humanitarian organizations to provide the necessary assistance to the population of East Chad.

D. ECONOMIC ASSISTANCE TO THE REPUBLIC OF COTE D'IVOIRE:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No.3/34-E adopted by the Thirty Fourth Islamic Conference of Foreign Ministers;

<u>Considering</u> particularly the decision to create a Special Fund to assist in the reconstruction efforts of the Republic of Cote d'Ivoire;

<u>Considering</u> also the role played by the Republic of Cote d'Ivoire, within the framework of the Organization of the Islamic Conference to establish peace and security in some member countries, and economic stability in the sub-region;

10. **Expresses** its support and solidarity to the people and government of Cote d'Ivoire;

- 11. **Requests** the OIC Secretary General to take appropriate measures required to urgently establish the Special Fund to bring about disarmament, demobilization and reintegration of ex-combatants in the socio-economic fabric as well as enhance post-reconstruction efforts in Cote d'Ivoire;
- 12. **Appeals** to the Member States and the international community to provide the Republic of Cote d'Ivoire with substantial financial and economic support to enable it to redress current difficulties faced by the country;
- 13. **Requests** the OIC Secretary General to establish as soon as possible the Contact Group on Cote d'Ivoire;

E. ECONOMIC ASSISTANCE TO THE REPUBLIC OF GUINEA:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference; and Resolution No.3/34-E adopted by the Thirty Fourth Islamic Conference of Foreign Ministers;

<u>Considering</u> the role played by the Republic of Guinea, within the framework of the Organization of the Islamic Conference, to establish peace and ensure stability in some Member States, victims of armed conflicts;

<u>Considering</u> that the presence of a huge number of refugees from Liberia, Sierra Leone and Cote d'Ivoire constitutes an unbearable burden for the economy of the Republic of Guinea;

<u>Considering</u> the need for the Republic of Guinea to reconstruct its country and ensure the survival of the refugees and their return to their respective countries;

- 14. **Calls** urgently the international community and Member States to provide substantial financial and material assistance to the Republic of Guinea so as to enable it to face this situation created by the aggressions which victimized her and by the presence on its territory of hundred of thousands of refugees most of whom are Muslims.
- 15. **Appeals** to the Islamic Development Bank to increase its assistance to the Republic of Guinea so that it may create the social infrastructures needed for the displaced population and the refugees, and overcome the deterioration of the environment brought about by this massive presence of refugees.
- 16. **Appeals** to the international community and the Member States to provide substantial economic and financial support to the programme of reconstruction of refugees' countries of origin to ensure their effective return to their countries.

F. ECONOMIC ASSISTANCE TO THE REPUBLIC OF LEBANON:

<u>Recalling</u> Resolution No. 2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference;

<u>Recalling</u> Resolution No. 3/34-E adopted by the Thirty-fourth Session of the Islamic Conference of Foreign Ministers;

<u>Recalling</u> the Israeli aggression on Lebanon in the summer of 2006, its consequent damages and losses of life and property, and its repercussions for the political and economic conditions in Lebanon;

<u>Appreciating</u> the efforts exerted by the Government of Lebanon in order to achieve security and stability, extend its sovereignty, under resolution No.1701(2006) of the UN Security Council, over its territories, complete the reconstruction process, and provide the needs of Lebanese citizens in the regions hit by the Israeli aggression;

<u>Taking into account</u> the difficulties faced by the Lebanese citizens resident in the regions hit by the Israeli aggression;

Having considered the report of the Secretary-General on this subject;

- 17. **Expresses its appreciation** to the Member States which promptly provided urgent assistance to Lebanon during the Israeli aggression and **welcomes** the readiness of these countries to continue to provide relief assistance to the victims of the aggression, achieve the reconstruction, and support and develop the Lebanese economy.
- 18. Expresses also its appreciation to the Member States of the Organization of the Islamic Conference (OIC) and its Subsidiary Organs for promptly providing their assistance to Lebanon in the areas of relief of victims and reconstruction, and wekomes the Putrajaya Declaration on the Situation in Lebanon, which was adopted on 3/8/2006 by the Special Meeting of the OIC Expanded Executive Meeting at the Ministerial Level.
- 19. Hails the International Conference to support Lebanon (Paris III) held on 25 January 2007, which was graciously hosted by the French Government; the important results reached there, and the paper on the economic and social reform and development programme submitted by the Lebanese Government to modernize and develop the Lebanese economy, strengthen sustainable development growth rates, and improve the living conditions of all Lebanese people; and expresses its appreciation of the support pledged for Lebanon by the OIC Member States and specialized funds during the conference (Paris III).

- 20. **Condemns** the deliberate Israeli assaults on public facilities and infrastructures in Lebanon and charges Israel with the full responsibility of this aggression and its consequences; charges Israel also with the responsibility of compensating the Republic of Lebanon and Lebanese citizens for the heavy losses inflicted on the Lebanese economy; **condemns also** the persistent Israeli refusal to withdraw from parts of the Lebanese territories, including the Shebaa farms, behind the internationally-recognized Lebanese borders.
- 21. **Condemns also** Israel's refusal to hand over the maps of landmines it planted in the different agricultural and vital areas in the south of Lebanon and the Bekaa Valley as well as its refusal to hand over the maps of cluster bombs it dropped during its aggression in the summer of 2006, which constitute a major threat to the life of citizens and prevent them from going on with their daily lives; **also condemns** Israel for its continued detention of Lebanese people in its prisons.
- 22. **Reiterates** previous resolutions on the need to provide all forms of financial, material, and humanitarian assistance to Lebanon in order to meet its economic, technical, and training needs; and **renews its call on** the OIC Member States and all international and regional organizations to undertake urgent and effective initiatives for the reconstruction of Lebanon in the aftermath of the devastation wreaked by the Israeli occupation.
- 23. **Encourages** Member States to consider ways and means for trade facilitation for Lebanese products.

G. ECONOMIC ASSISTANCE TO THE PEOPLE OF JAMMU AND KASHMIR:

<u>Recalling</u> Resolution <u>2/11-E(IS)</u> adopted by the <u>Eleventh</u> Session of the Islamic Summit Conference and Resolution 3/34-E adopted by the 34" Islamic Conference of Foreign Ministers;

<u>Recalling</u> also all previous resolutions of the Organization of Islamic Conference on assistance to the Kashmiri people, particularly Resolution 23/30-E of the Thirtieth Session of the Islamic Conference of Foreign Ministers;

Expressing deep sympathy to the victims, their families and people of Jammu and Kashmir who suffered huge loss of life and socio-economic and environmental damage from the massive earthquake that struck South Asia on 8 October 2005;

<u>Expressing</u> gratitude for the assistance, contributions and pledges of the international community, particularly the Member States for the relief and rehabilitation efforts for the earthquake victims, which reflect the spirit of Islamic solidarity and cooperation to meet the challenges of unprecedented natural disasters;

<u>Expressing</u> deep appreciation for the assistance extended to the Kashmiris by some Member States and relevant OIC bodies;

Having taken note of the report of the Secretary General:

- 24. **Calls** for expeditiously implementing the recommendations contained in the report of OIC Secretary General's Special Representative for Jammu and Kashmir, particularly the establishment of a Special Trust Fund for the assistance of Kashmiris and focus upon the higher educational needs of the Kashmiri youth through the provision of scholarships to the Kashmiri youth in professional colleges, vocational training and employment generation opportunities.
- 25. **Appeals** to Member States and Islamic Institutions, such as the Islamic Solidarity Fund, Islamic Development Bank and Charitable Institutions, to grant generous humanitarian assistance to the Kashmiri people whose plight has been aggravated by the devastating earthquake of October 2005.
- 26. **Encourages** the international community, particularly donor countries, international financial institutions and relevant international organizations from the Islamic World to continue to provide necessary funds and assistance to support the ongoing rehabilitation and reconstruction work, in the affected areas of Jammu and Kashmir.
- 27. **Appeals** to Member States to contribute, whenever possible, to the rehabilitation of people affected by the earthquake disaster in order to facilitate the economic and social wellbeing since many means of livelihood has been damaged or destroyed.
- 28. Also appeals to Member States and the Islamic Institutions to grant scholarships to the Kashmiri students in different universities and institutions in the OIC countries.

H. ECONOMIC ASSISTANCE TO THE REPUBLIC OF TOGO:

<u>Recalling</u> the relevant resolutions of the Eleventh Islamic Summit Conference (Resolution 2/11-E(IS)), of the 34^{th} Islamic Conference of Foreign Ministers and of the 22^{nd} session of the Standing Committee for Economic and Commercial Cooperation;

<u>Considering</u> the socio-economic difficulties facing the Togolese Republic on account of the smallness of the contribution of its traditional partners who have suspended their assistance from 1992 to 2007;

<u>Taking</u> the measure of the damages suffered by infrastructure such as roads, bridges, electrical and hydraulic networks, as well as basic public services such as schools and hospitals as a result of the devastating floods which have ravaged the northern and southeastern parts of the country in the recent months;

<u>Appreciating</u> the efforts made by the Government of the Togolese Republic and the success achieved in the implementation of the political, economic reforms policy and of the programme on the struggle against poverty;

<u>Recalling also</u> that Togo is listed among the least developed countries;

- 29. **Expresses its** total solidarity with Togo to meet the major challenges it must take up.
- 30. **Expresses also** its appreciation of the assistance extended by some Member States and by the relevant bodies of the Organization of the Islamic Conference.
- 31. **Recognizes** the efforts made by the Government of the Togolese Republic in order to overcome the economic difficulties it is facing and to implement its comprehensive programme of political, economic, and financial reform.
- 32. **Recognizes also** the need for economic and humanitarian assistance to alleviate the impacts of the floods which have devastated the northern and southeastern parts of the country.
- 33. **Calls on** all the Islamic Member States and institutions, in particular the Islamic Development Bank through the Islamic Solidarity Fund for Development to extend economic and financial assistance to the Togolese Republic.

I. ECONOMIC ASSISTANCE TO MEMBER STATES STRICKEN BY DROUGHT AND NATURAL CALAMITIES:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Islamic Summit Conference and Resolution No.3/34-E adopted by the Thirty-Fourth Islamic Conference of Foreign Ministers;

<u>Noting</u> with concern the grave situation caused by natural disasters, drought and desertification, with their damaging effects on economic and social conditions of the affected countries especially in the sectors of agriculture and food, economic and social infrastructures as well as public services and utilities;

<u>Fully aware</u> that afflicted Member States, belonging as they do to the category of the Least-Developed, cannot by themselves bear the growing burden of relief, rehabilitation and reconstruction work;

<u>Recognizing</u> the importance of disaster preparedness and management for mitigating the impacts of natural calamities and the need for continued efforts by the international community to enhance awareness in this regard.

Having considered the report of the Secretary General on the subject;

i) The Republic of Djibouti

<u>Deeply concerned</u> at the recent floods in Djibouti causing an important loss in livestock, as well as serious damage to roads and health establishments thus causing cholera and malaria epidemics;

- 34. **Appeals** to the Member States to provide substantial financial and material support to the Republic of Djibouti for the consolidation of peace, the reconstruction of the country and the implementation of its structural adjustment programme.
- 35. **Calls on** the Member States to assist the Republic of Djibouti in its struggle against the disastrous consequences of the recent drought at both the social and economic levels.

ii) The Republic of Mozambique:

<u>Appreciating</u> the efforts being made by the Government of Mozambique in the implementation programme for eradication of poverty and for economic development;

<u>Regrets</u> the natural disasters which have taken place recently in Mozambique;

- 36. **Appeals** to the Islamic Development Bank, all Islamic Institutions and the International community in general to continue rendering their assistance in order to ensure the socio-economic development of Mozambique.
- 37. **Urges** the developed countries to write off the external debt of Mozambique in the light of its current effort to eradication of poverty.
- 38. **Calls upon** all Member States to continue their support to the implementation of the programme of reconstruction of Mozambique.
- 39. **Expresses deep appreciation** for the assistance extended by some Member States and relevant OIC institutions.
- 40. **Urges** the international community to render assistance for setting up national, sub-regional, regional and international disaster prevention, preparedness and management mechanisms, including early warning systems.

J. ECONOMIC ASSISTANCE TO MEMBER STATES AFFECTED BY REGIONAL WAR, CIVIL INSURGENCE, OR POLITICAL CRISES:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference and Resolution No.3/34-E adopted by the Thirty-forth Islamic Conference of Foreign Ministers;

<u>Taking</u> into account the objectives and principles of the OIC Charter as well as members' commitment to consolidate international peace and security;

<u>Confirming</u> full solidarity of the Member States of the OIC with the Government and people of the affected countries at this very critical time of the country's history;

Having considered the report of the Secretary General on the subject;

i) The Republic of Albania:

- 41. **Expresses** its strong support to the people of Albania beset by major economic difficulties at the present phase of their transition towards a market economy.
- 42. Urges OIC Member States, Islamic Institutions and International Organizations to grant generous economic assistance to Albania so that the Government of Albania may successfully implement its development programme.

ii) The Republic of Guinea Bissau:

<u>Noting</u> the political and military situation that Guinea Bissau experience since June 7, 1998 until recently and its consequences on the economic activities of the country, namely the loss of agricultural and export products, the mass displacement of the population and the devastation of the basic socio-economic infrastructure, such as schools, dispensaries, hospitals, markets, residential areas, etc;

- 43. **Urges** Member States and the International Community to provide Guinea Bissau with urgent aid to facilitate the reintegration of its people in active life.
- 44. **Appeals** to Member States and to OIC institutions to participate in the rehabilitation and economic revival programme of Guinea Bissau.

iii) The Kyrgyz Republic:

<u>Expressing</u> its understanding of the situation which has arisen in the Kyrgyz Republic after attainment of independence and sovereignty and taking into consideration the economic difficulties of the transitional period to the free market economy;

- 45. **Appeals** to all Muslims and Islamic financial institutions to be generous and to contribute to the process of overcoming the economic difficulties experienced by Kyrgyz Republic either on bilateral basis or through multilateral and regional organizations so as to enable Kyrgyz Republic to fulfill its economic programme.
- 46. **Appeals also** to the Islamic Development Bank to increase its financial and technical assistance to Kyrgyz Republic.

iv) The Republic of Somalia:

<u>Deeply concerned</u> at the critical situation in Somalia and expressing the desire for early restoration of peace and order in that sister Member country;

<u>Concerned</u> at the adverse economic effects of the serious drought being experienced by the Republic of Somalia;

47. **Urges** OIC Member States, to provide material and other assistance on an emergency basis to Somalia to end the human suffering in this Muslim country.

v) The Republic of Sierra Leone

<u>Expressing appreciation</u> for the sustained concern and interest of the leaders of the West African Sub-region, for peace to prevail in the Republic of Sierra Leone;

<u>Expressing appreciation</u> for the assistance rendered by the Kingdom of Saudi Arabia and the State of Kuwait, the Islamic Republic of Iran, the Arab Republic of Egypt and other friendly nations for the donations of food items, clothing and medicines for the refugees and displaced inhabitants of Sierra Leone;

<u>Considering</u> that the armed conflict in Sierra Leone caused considerable damage to life and property and for several years disrupted all economic activities particularly in the Mining, Agriculture and Industrial sectors, resulting in substantial loss of revenue to Government and the private sector;

- 48. **Appeals** to the Member States and the international community to urgently extend substantial financial and material assistance to the Republic of Sierra Leone so as to enable its people to undertake the much needed process of rehabilitation, reconstruction and resettlement of returnees and displaced inhabitants of about 1.5 million.
- 49. **Urges** the OIC Trust Fund for Sierra Leone to continue to facilitate the flow of much-needed financial assistance to Sierra Leone in order to expedite its post-conflict recovery.
- 50. **Requests** the Secretary-General to use his good offices to accelerate the process of approval for projects already identified for Sierra Leone.

vi) The Republic of Tajikistan:

<u>Deeply concerned</u> at critical situation which Tajikistan has faced in the light of 5 years of bloody civil war resulted in the death, injury spread of infectious diseases such as tuberculosis and diarrhea and displacement of thousands of people as well as destruction of its economic and social infrastructures;

Noting the return of about 200 thousands Tajik refugees to their homeland which necessitates a great financial and technical support;

51. **Appeals** to all members and Islamic financial institutions to make their generous contributions to the process of overcoming the economic difficulties experienced by Tajikistan either on bilateral basis or through multilateral and regional organizations so as to enable Tajikistan to fulfill its rehabilitation programmes.

52. **Urges** the Islamic Development Bank to increase its financial and technical assistance to Tajikistan.

vii) The Republic of Yemen:

<u>Taking into consideration</u> the economic difficulties faced by the Republic of Yemen and the loses incurred in the tourism sector in the aftermath of the events of September 11, 2001 in New York;

<u>Appreciating</u> the efforts made and success achieved by the Government of the Republic of Yemen in implementing the Economic Reforms Policy and the Fight-Against-Poverty Programme;

<u>Taking into consideration</u> the heavy burdens borne by the Yemeni Government to provide shelter for groups of refugees from neighbouring African countries;

- 53. **Expresses** its appreciation for the efforts of Yemeni Government in overcoming its economic difficulties and the implementation of the Comprehensive Programme of Administrative and Financial Reform and the Fight-Against-Poverty Programme;
- 54. **Reiterates its call** to the Member States as well as other international and regional organizations to provide all forms of economic assistance to the Yemeni Government to support its efforts in implementing administrative and financial reform programmes with a view to alleviating the heavy burden resulting from hosting refugees from poor neighbouring states; thanks the states that fulfilled their pledges to donate to the Republic of Yemen at the Donor's Conference in London, at the forefront of which is the Kingdom of Saudi Arabia and other states of the Gulf Cooperation.

viii) The Republic of Uganda:

<u>Aware</u> that the Government of the Republic of Uganda is currently experiencing serious strain on its meager resources as a result of the presence of refugees from neighboring countries who flock into the country; and recognizing that Uganda is offering asylum to large numbers of refugees whose number will increase if the state of unrest continues to escalate; and also to assist in alleviating the suffering of the internally displaced people in response to the joint appeal by the World Food Programme and the Government of Uganda.

<u>Recognizing</u> the efforts of the Government of Uganda at resettling internally displaced persons and attaining the reconstruction and development of Northern Uganda,

- 55. **Invites** Member States, Islamic institutions and international organizations to grant urgent financial and economic assistance to Uganda so that it may cope with the refugee problems and other related consequences.
- 56. **Further invites** Member States to support the Government of Uganda in implementing the Priority Rehabilitation and Development Programme of Northern Uganda and other economic and cultural programmes.
- 57. **Expresses deep appreciation** for the assistance extended by some Member States and relevant OIC institutions.

K. CONTINUOUS ASSISTANCE TO THE SAHELIAN MEMBER STATES:

<u>Recalling</u> Resolution 2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference and Resolution 3/34-E adopted by the Thirty-Fourth Islamic Conference of Foreign Ministers;

<u>Noting with concern</u> the difficult situation of the Sahelian Member States affected by drought;

<u>Expressing its appreciation</u> to the OIC Member States that have contributed to the financing of the first programme of assistance to the Sahelian Member States;

<u>Having also taken note</u> of the special emergency aid programme of US\$50 million which was initiated by the Islamic Development Bank in favour of the Sahelian Member States;

<u>Recalling</u> the Resolution of the 6th Islamic Summit Conference deciding to establish a special OIC/IDB/CILSS Programme for Sahel;

Expressing appreciation for the mission undertaken by the Secretary General of the Organization of the Islamic Conference to visit African countries affected by drought, namely Chad, Burkina Faso, Mali, Gambia, Senegal and Niger during 24-31 March, 2005;

Expresses its appreciation to the Kingdom of Saudi Arabia for its continuous support to the Sahelian Member States affected by drought;

- 58. **Calls for** the effective implementation of the OIC/IDB/CILSS Programme for the Sahel.
- 59. **Urges** Member States, that could do so and that have not yet contributed to this programme and have not initiated a separate programme, to contribute to the financing of the Programme.
- 60. **Reaffirms** the solidarity of the Islamic Ummah with the peoples of the Sahel.

L. ECONOMIC ASSISTANCE TO NON-OIC COUNTRIES AND MUSLIM COMMUNITIES:

<u>Recalling</u> Resolution No.2/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference and Resolutions No.3/34-E adopted by the Thirty-fourth Islamic Conference of Foreign Ministers;

<u>Guided</u> by the principles and objectives of the OIC Charter which lay stress on the common objectives and destiny of the peoples of the Ummah, as well as their commitment to consolidate international peace and security;

Having examined the report of the Secretary General:

i) Bosnia and Herzegovina:

<u>Recalling</u> the previous resolutions adopted by the OIC expressing full solidarity of the Member States with the Government and people of Bosnia and Herzegovina;

- 61. **Appeals** to Member States, Islamic institutions and other donors to make generous donations to enable full implementation of the IDB programme aimed at providing humanitarian assistance to the Government and people of Bosnia and Herzegovina for the reconstruction of the country and to work for the preservation of the Islamic identity of the Muslim inhabitants of Bosnia.
- 62. **Urges upon** the International Community to take efficient measures to ensure the rehabilitation and reconstruction of Bosnia and Herzegovina and humanitarian assistance relating to return of the refugees and displaced people to their homes by means of OIC Trust Fund for Bosnia and Herzegovina.
- 63. **Requests** the OIC Member States to direct the biggest part of their assistance for reconstruction of Bosnia and Herzegovina to the regions inhabited by Muslims of Bosnia and Herzegovina.
- 64. **Commends** the building of several houses and the provision of support to farmers by the Bosnia Reconstruction Fund and thanks the States that have provided assistance to the Fund namely, Qatar, the United Arab Emirates and Malaysia.

ii) Chechniyan People:

<u>Recalling</u> the concerns and support expressed at the Seventh Islamic Summit Conference held in Casablanca (Kingdom of Morocco) in December 1994 regarding the situation in Chechnya which has deteriorated again in 1999; <u>Referring</u> to the call to all Member States made by His Excellency S.Mohammad Khatami, **Former** President of the Islamic Republic of Iran, Chairman of the Eighth Islamic Summit for a rapid humanitarian assistance to the people and refugees and displaced people of Chechnya and its readiness to assist in coordination of this effort;

Expressing deep concern over the plight of Muslim refugees and displaced people of Chechnya and humanitarian and material losses resulting from the Chechnya Crisis in 1999;

- 65. **Calls on** all Member States, Islamic Philanthropist Institutions and appeals to the international community to urgently provide generous humanitarian assistance to the people and refugees of Chechnya.
- 66. **Recommends** to all Member States to encourage their relevant institutions, NGOs and individuals to provide humanitarian assistance for people and refugees of Chechnya.
- 67. **Expresses deep appreciation** for the assistance provided by Member States and relevant OIC bodies.
- (iii) Kosovo:

Expressing concerns over the Kosovo Muslim community;

68. **Calls on** OIC Member States, Islamic Institutions and International Organizations to provide necessary economic assistance to Kosovo Muslim community.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on each item appearing from A to L to the Thirty Sixth Session of the Council of Foreign Affairs.

RESOLUTION No. 4/35-E

ON THE ACTIVITIES RELATED TO OTHER MINISTERIAL CONFERENCES AND FORA IN THE ECONOMIC SECTORS

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

Recalling the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

A. COOPERATION IN THE FIELD OF TOURISM:

<u>Recalling</u> relevant resolutions of the Islamic Summit and Foreign Ministers Conferences, the most recent of which were resolutions No. 3/11-E (IS) and No.4/34-E;

Also recalling the provision of the OIC Plan of Action to Strengthen Economic and Commercial Cooperation among Member States in which tourism identified as a priority area for cooperation;

<u>Taking note</u> of the resolutions on "Tourism Development" adopted by the Second Islamic Conference of Tourism Ministers (ICTM), held in Kuala Lumpur on October 10-13, 2001; the Third ICTM, held in Riyadh on 6-9 October 2002; the 4th ICTM, held in Dakar, on 28-30 March 2005, and the Fifth ICTM, held in Baku, on 11-12 September 2006.

Having taken note of the report of the Secretary General;

- 1. **Thanks** the Republic of Senegal and the Republic of Azerbaijan for hosting the Fourth and Fifth Sessions of the Islamic Conference of Tourism Ministers in Dakar, Senegal, and in Baku, Azerbaijan, in March 2005, and in September 2006, respectively.
- 2. **Invites** Member States and OIC Institutions to fully implement the Resolutions and Decisions of the Fifth Session of the ICTM.
- 3. **Appreciates** the offer of the Syrian Arab Republic to host the Sixth Session of the ICTM from June 29 to July 2, 2008 in Damascus, and invites the Member States to actively participate in the Conference.
- 4. Takes note of the Coordination Meeting between the representatives of the Syrian Arab Republic and the OIC General Secretariat preparatory to the Sixth Session of the ICMT took place on 7th and 8th May 2008, in Damascus.

- 5. Welcomes the offer of the Islamic Republic of Pakistan and the Islamic Republic of Iran to host ministerial-level tourism related events in their countries.
- 6. **Thanks** the Republic of Turkey for hosting the Experts Group Meeting on Tourism Development in Istanbul, Republic of Turkey, on 9-11 May 2007.
- 7. **Takes note** of the Strategic Plan for Tourism Development in OIC Member States, finalized by the 2nd Experts Group Meeting on Tourism Development, and planned to be presented to the 6th ICTM, to be held in Damascus in 2008, with a view to adopting and submitting it to the 24th COMCEC, for final approval.
- 8. **Thanks** the Republic of Azerbaijan for hosting the International Scientific Conference on "Role of Tourism in the Economies of OIC Countries" in Baku, on 21-22 June 2007.
- 9. Thanks the Islamic Centre for Development of Trade for its efforts to organize a Tourism Fair, in cooperation with the Islamic Development Bank and the Islamic Chamber of Commerce and Industry, in Member States, once every two years, and welcomes in this connection the offers of the Republic of Lebanon, the Arab Republic of Egypt, Syrian Arab Republic and Islamic Republic of Iran to host the Second, Third, Fourth and Fifth Tourism Fairs in 2008, 2010, 2012 and 2014, respectively and calls upon the Member States to actively participate in the Tourism Fairs.
- 10. **Calls upon** Member States and OIC institutions to render financial and technical support to the regional project on "Sustainable Tourism Development in a Network of Cross-Border Parks and Protected Areas in West Africa".
- 11. **Thanks** the UNWTO, the Korean International Cooperation Agency (KOICA) and the ST-EP Foundation for financing the feasibility study of the project on "Sustainable Tourism Development in a Network of Cross-Border Parks and Protected Areas in West Africa".
- 12. **Takes note** of the proposal of the Islamic Chamber of Commerce and Industry to organize in future on a regular basis Private Sector Forum on Tourism.
- 13. **Thanks** the Kingdom of Saudi Arabia for hosting and organizing the International Conference on Tourism and Traditional Crafts in Islamic Countries and associated activities, held in Riyadh, from 16 to 23 Shawwal 1427 H (7-14 November 2006), in collaboration with the Research Center for Islamic History, Arts and Culture (IRCICA).

- 14. **Thanks** the Kingdom of Saudi Arabia for hosting and organizing the First Tourism Forum, held in Riyadh, on 30 October 1 November 2007, in collaboration with the ICCI.
- 15. **Thanks** the Republic of Azerbaijan for hosting the OIC Forum for Silk Road Tour Operators, held in Baku, Azerbaijan, on 14-15 April 2008.
- 16. **Thanks** the Republic of Azerbaijan for hosting the OIC Conference on "Religious and Health Tourism: Organization of Spiritual and Physical Recreation", held in Nakhchevan, Republic of Azerbaijan, on 20-22 May 2008.
- 17. **Thanks** the Islamic University of Technology (IUT) for organizing the Seminar on Development of E-Tourism Technology in Islamic Countries, in cooperation with the Republic of Azerbaijan, as a current Chairman of the 5th ICTM, held at the IUT headquarters in Dhaka, Bangladesh, on 1-3 April 2008, and **appreciates** IDB for contributing to the financing of this Seminar.

B. THE DAKAR/PORT-SUDAN RAILWAY LINE PROJECT:

Recalling the resolution No.5/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference;

<u>Referring</u> to the recommendations of the Islamic Conference Foreign Ministers held in Baku, Republic of Azerbaijan, on 22-23 June 2006;

<u>Reiterating</u> the economic and social feasibility of the projected railway line between Port-Sudan and Dakar, given the already existing infrastructure as demonstrated in the provisional economic and social feasibility study prepared by the Sudanese Railway Authority's Planning and Systems Department on linking the African States all along the proposed railway line:

- 18. **Decides** to set up a committee whose membership shall include General Secretariat of the OIC, the Islamic Development Bank and representatives of the States to be crossed by the proposed railway line between Dakar and Port-Sudan (i.e. Sudan, Chad, Niger, Nigeria, Mali, Burkina Faso, and Senegal) to start the project's implementation steps. **Further decides** to include the Republic of Djibouti, Republic of Guinea, Republic of Cameroon, Republic of Uganda and The Gambia in the feasibility study of the Railway line.
- 19. **Express** its appreciation to the Government of the Republic of Sudan for its initiative in submitting the project and preparing the primary feasibility study.

- 20. **Decides** to incorporate the Port-Sudan/Dakar railway line in the agenda of the coming meetings of the Ministerial Council, and requests the Secretary General to cooperate with the Committee set up under para (1) of the present resolution and to report on progress achieved in this project.
- 21. **Appreciates** the initiative of the OIC Secretary General to implement the Railway project by proposing to convene the first meeting of the Committee with the participation of concerned Member States at the earliest.
- 22. Welcomes the offer of the Republic of Sudan to host the First Ministerial Meeting of the Member States to be crossed by the proposed railways line identified in preliminary report and invites other countries interested in this project to participate in this Meeting.
- 23. **Decides** to include the project on Dakar/Port-Sudan Railways Line in the project list of the COMCEC in order to coordinate closely monitor the implementation of the project.

C. THE WORLD ISLAMIC ECONOMIC FORUM (WIEF):

<u>Recalling</u> the provision of the OIC Ten-Year Programme of Action to face the Challenges of the Twenty-First Century adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al Mukarramah, which called upon Member States to implement the related Chapters of the Plan of Action for Strengthening Economic and Commercial Cooperation among the OIC Member States;

<u>Realizing</u> the need for Government and business leaders as well as eminent thinkers to meet and discus ideas, brainstorm issues and develop solutions for tie betterment of the world in general and the Muslim business community in particular;

Taking note that the World Islamic Economic Forum has been convened annually in OIC Member States after evolving from the OIC Business Forum in 2005;

- 24. **Commends** the efforts by private sector in the Islamic World for the establishment of the World Islamic Economic Forum Foundation which seeks to promote business partnerships and economic cooperation among Muslim entrepreneurs and companies within and beyond the OIC Member States as well as to promote understanding and dialogues between Muslims and non-Muslims.
- 24. Welcomes with appreciation the hosting by the State of Kuwait of the 4th World Islamic Economic Forum in the period from 29 April 1 May 2008, with the participation of international important personalities, in particular the Islamic World, and welcomes the Kuwait Declaration issued at the Forum.

- 26. **Expresses** its appreciation to the Government of Indonesia for its generous offer to host the Fifth World Islamic Economic Forum and calls upon all OIC Member States to participate in the Forum.
- 27. **Thanks** the Government of Malaysia for the establishment of the WIEF Secretariat and welcomes the appointment of Tan Sri Ahmad Fuzi Abdul Razak as its First Secretary General.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on each item appearing from A to C thereon to the Thirty-Sixth Session of the Council of Foreign Ministers.

RESOLUTION NO. 5/35-E ON THE ACTIVITIES OF THE OIC INSTITUTIONS

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

A. ACTIVITIES OF THE OIC SUBSIDIARY ORGANS IN THE FIELD OF ECONOMIC AND TRADE:

<u>Recalling</u> Resolution No.4/11-E (IS) of the Eleventh Session of the Islamic Summit Conference;

<u>Recalling</u> Resolution No.5/34-E adopted by the Thirty-fourth Session of the Islamic Conference of Foreign Ministers on the activities of the Subsidiary Organs of the OIC, namely, the Statistical Economic and Social Research and Training Centre for Islamic Countries (SESRIC), Ankara, and the Islamic Centre for Development of Trade (ICDT), Casablanca;

<u>Appreciating</u> the increasing number of joint activities among the OIC organs and agencies;

<u>Expressing its appreciation</u> at the role played by the subsidiary organs in the implementation of the Plan of Action to Strengthen Economic and Commercial Cooperation among Member States and the OIC Ten-Year Programme of Action;

Having taken note of the report of the Secretary General;

i. Activities of the Statistical, Economic and Social Research and Training Centre for Islamic Countries (SESRIC).

<u>Having taken note with satisfaction</u> of the activity report submitted by the Statistical, Economic and Social Research and Training Centre for Islamic Countries, and the change of the acronym of the Centre from (SESRTCIC) to (SESRIC);

1. **Commends** the role the Centre is playing through active contributions to the implementation of the Plan of Action to Strengthen Economic and Commercial Cooperation among Member States and the OIC Ten-Year Programme of Action, as well as the various resolutions of the COMCEC and Ministerial Conferences.

- 2. Lauds the SESRIC for the highly instructive technical reports and studies it presented on the most prominent items of the economic agenda of the annual sessions of the COMCEC, the Islamic Commission and other OIC Ministerial Conferences and meetings and calls upon the Member States to endeavour to implement the recommendations and project proposals contained in these reports and studies.
- 3. Takes note with satisfaction the active contributions made so far by the SESRIC relating to the implementation of the OIC Ten-Year Programme of Action, particularly in the area of poverty alleviation and **urges** the Member States to actively and effectively participate in the work of the Centre in this area by closely following up the recommendations and project proposals contained in Centre's documents and studies on this vital area, and **encourages** the Centre to implement poverty alleviation projects for the benefit of the Member States, as and when found feasible.
- 4. Lauds the Centre for the highly instructive reports it prepared on poverty alleviation and food security in the Member States of Sub-Saharan Africa as a preliminary contribution to the special programme for the development of Africa stipulated by the OIC Ten-Year Programme of Action and commends the SESRIC activities on improving the agriculture productivity in the Member States, in particular the Centre's initiative for increasing the productivity of cassava and the potential of cassava processing in some Member States in Sub-Saharan Africa that could be used as a model for poverty alleviation and food security in other member countries in the region.
- 5. **Commends** the highly constructive efforts made by the Centre, in its capacity as the coordinator institution of the exchange of views sessions of the COMCEC, for the preparation and implementation of the 23rd exchange of views session of the COMCEC under the theme "Micro-Credit Financing and Poverty Alleviation in Member States", **lauds** the Centre for the highly instructive report it presented to the said session on the outcome of the workshop it organised on the said theme, which adopted a set of recommendations and brought together a number of project proposals to be implemented by the Member States, and **encourages** the Centre to continue its work on this vital area for the benefit of the Member States.
- 6. **Commends** the SESRIC for the quality and relevance of the training programmes, courses and seminars it organises on various subjects of current interest to the Member Countries, particularly the continuous statistical capacity building training courses which the Centre organises for the benefit of the National Statistical Organisations (NSOs) of the Member States and **urges** the Member States to contribute to and benefit from these and other technical cooperation activities of the Centre.

- 7. **Expresses** its appreciation for the highly useful statistical databases maintained and publications produced by the SESRIC and **calls upon** all Member States to regularly provide the Centre with their statistical data and information online using the facilities of the Centre's website in order to enhance the mechanism of collection of the official and up-to-date statistical data and information by the Centre.
- 8. **Encourages** the Centre to intensify contacts and cooperation with international and regional institutions particularly those working in the framework of the United Nations and others, such as Bretton Woods institutions.
- 9. **Urges** the Member States, which have not done so thus far, to settle their regular mandatory contributions to the budget of the Centre, and to act for the settlement of their arrears, if any, at the earliest.
- 10. **Expresses its appreciation and thanks** to the Government of the Republic of Turkey, the host country of the Centre, for its generous granting of a highly valuable piece of land in the diplomatic city in Ankara in order to build a new headquarters building for the Centre, and for its promise to make a financial contribution towards the construction of the said building, and **invites** the other Member States to contribute towards this end in order to facilitate the completion of the construction at an early date.

ii. Activities of the Islamic Center for the Development of Trade (ICDT).

<u>Having taken note with satisfaction</u> the activity report submitted by the Islamic Center for the Development of Trade (ICDT).

- 11. **Commends** the role which the ICDT are playing each in their respective fields.
- 12. **Lauds** the ICDT for the highly instructive reports and studies they presented on the most prominent items of the economic agenda of the Commission and encourages them keep on their excellent performance in this respect.
- 13. **Commends** the ICDT for the quality and relevance of the training workshops and seminars they organize on various subjects of current interest to the Member Countries.
- 14. **Expresses** its appreciation for the usefulness of the statistical publications produced by the ICDT, and **calls upon** all Member States to respond to the statistical questionnaires they circulate to them to collect the official and up-to-date information and data.

- 15. **Expresses** its appreciation to ICDT for the valuable work carried out in the fields of its specialisation in order to implement the "Ten Year Programme of Action to Meet the Challenges Facing the Islamic Ummah in the 21st Century", adopted by the 3rd OIC Extraordinary Summit Conference, notably the objective aiming at enhancing the share of intra-OIC trade in the global trade of Member States by 20% in 2015.
- 16. **Commends** the role played by the COMCEC Coordination Office and ICDT in the management of the Secretariat of the Trade Negotiating Committee under the framework Agreement on Trade Preferences System among the OIC Member States.
- 17. **Commends** the ICDT for holding the 11th Trade Fair of Islamic Countries in Dakar, Republic of Senegal from 21st to 25th November 2007 and other specialised fairs, exhibitions and businessmen forums in various sectors of high trade potential among OIC Member States.
- 18. **Takes note with satisfaction** the active contributions made by the ICDT to the implementation of the OIC Plan of Action as well as the various resolutions of the COMCEC and various Ministerial Conferences.
- 19. Urges the Member States to actively and effectively participate in the work of these organs and expeditiously respond to the questionnaires circulated by them, and closely follow up their documents and studies so as to achieve maximum benefit from these organs in the area of economic cooperation among the Member States.
- 20. **Encourages** these organs to intensify contacts with international and regional institutions particularly those working in the framework of the United Nations and others, such as Bretton Woods institutions and to benefit from the studies and reports produced by these institutions.
- 21. Urges the Member States, which have not done so thus far, to settle their regular mandatory contributions to the budgets of these bodies, and to act for the settlement of their arrears, if any, at the earliest in view of the current financial difficulties being faced by these organs.
- 22. Notes that the Member States are to benefit from the special services offered by the subsidiary organs, above and beyond the tasks assigned to them in their work programmes, on a contractual basis.
- 23. Calls upon OIC institutions to participate actively in the Sessional Committee Meetings for consultation on a regular basis concurrently with the annual sessions of the COMCEC and Islamic Commission for Economic, Cultural

and Social Affairs, in order to enhance the existing collaboration among OIC institutions, avoid duplication and monitor the progress of the programs assigned to each institution and learn from their respective experiences.

24. Urges Member States to consider, when nominating their representatives to the Board of Directors of these organs, persons who are experienced in the activities of the organs, and **expresses** the strong desirability of setting up conditions for selection of such representative to those meetings.

B. ACTIVITIES OF THE OIC SPECIALIZED INSTITUTIONS AND ORGANS:

The Islamic Development Bank (IDB)

<u>Recalling</u> Resolution No. 4/11-E (IS) of the Eleventh Islamic Summit Conference; and Resolution No.5/34-E of the Thirty-fourth Islamic Conference of Foreign Ministers;

<u>Having taken note</u> with appreciation of the report on the activities and operations of the Islamic Development Bank Group;

Having taken note also of the report of the Secretary General in this regard:

- 25. **Expresses** its full satisfaction at the devotion and efficiency with which the IDB President and his staff are running this institution to ensure its good performance, as it continues to make an invaluable contribution for fostering economic development and social progress of member countries and communities.
- 26. **Commends** the IDB on the steps taken to implement the OIC Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held at Makkah Al-Mukarramah on 7-8 December 2005 concerning: the establishment of the Poverty Alleviation Fund, the Increase in the IDB capital; and the establishment of the ITFC.
- 27. **Extends** thanks to the Member States which have announced their contributions to the resources of the Poverty Alleviation Fund, with special appreciation to the Custodian of the Two Holy Mosques, King Abdullah Ibn Abdulaziz Al Saud of Saudi Arabia for the generous contribution of 1 billion US Dollars in favor of this Fund; and the State of Kuwait, the Islamic Republic of Iran, the Republic of Algeria and the State of Qatar who announced a contribution of US\$ 300 million, US\$100 million, US\$50 million respectively to the fund; and **urges** all the Member States, which have not yet done so, to announce their generous financial contributions in favor of this Fund.

- 28. **Take Notes** of the decision of the Board of Governors of the IDB to change the name of the Poverty Alleviation Fund to the Islamic Solidarity Fund for Development, during the 32nd Board of Governors meeting in Dakar Senegal on 29-30 May 2007.
- 29. Welcomes the launching of Islamic Solidarity Fund for Development (ISFD) in Dakar, Senegal on 30th May 2007, by President Abdulaye Wade of Senegal, at a special session convened at the margin of the IDB's 32nd Board of Governors Meeting.
- 30. The Conference expresses its concern over the wide gap between the initially targeted Capital of the Islamic Solidarity Fund for Development (ISFD) of US\$ 10 billion and the contributions of US\$ 1.6 billion which have so far been announced by 31 of the 57 OIC Member States. The Conference appeals to the Member States to make substantial contributions commensurate with their financial and economic capabilities to reach the full US\$ 10.0 billion capital of the Fund by end of 2009, and at least US\$ 6.0 billion by the end of 2008 in order to enable the Fund to implement its programme.
- 31. **Thanks** the OIC Secretary General, the IDB President and the President of the Republic of Senegal for conducting high level missions to OIC Member States for resource mobilization for the Fund.
- 32. Notes with satisfaction that ITFC has commenced its business operations on 1st Muharram 1429H (10th January 2008), with a declared capital of US\$3 billion and a subscribed capital of US\$750 Million, and calls upon business community in member states to benefit from ITFC financing programmes and services.
- 33. **Appreciates** the signing of the Agreement on the establishment of the International Islamic Trade Finance Corporation (ITFC) by 47 Member States, as well as by 8 financial institutions, and appeals to the signatory states and financial institutions to expeditiously ratify the Agreement.
- 34. **Commends** the IDB for taking necessary measures to ensure a substantial increase in the its authorized, subscribed, and paid-up capital, so as to enable it to strengthen its role in providing financial support and technical assistance to OIC member countries, as per the decision taken by the Board of Governors of the Islamic Development Bank at its 31st meeting (Kuwait, 30-31 May 2006) to achieve a substantial increase in the authorized and subscribed capital of the IDB in accordance with a decision taken at the Third Extraordinary Session of the Islamic Summit Conference (Makkah, 7-8 December 2005).

- 35. **Invites** the Member States which have not yet done so to subscribe to the second general capital increase of the IDB.
- 36. Welcomes with appreciation the recently launched IDB Statistical Capacity Initiative (IDB-STATCAP) which primary objective is to assist Member Countries to build and strengthen their statistical capacities and provide technical assistance for development of human resource and institutional framework in the area of statistics as well as financing for physical and statistical infrastructure and regular statistical operations.
- 37. **Commends** the IDB on the steps taken to implement the Resolutions of the 10th Islamic Summits on Preparation of the Ummah for the 21st Century; and **Expresses** its appreciation of the efforts made by the IDB in the related Task Forces on Intra-OIC Trade, Training, Health and Illiteracy Eradication, and urges the Member States and relevant bodies of the OIC to combine their efforts with those of the Task Forces concerned.
- 38. Welcomes the decision taken by the IDB's Board of Governors at its 27th Meeting held in Ouagadougou (October 2002) for issuing a Declaration on IDB Group Cooperation with Africa. The Declaration reaffirmed the Bank's commitment to the Least Developed Member Countries (LDMCs), in within the framework of New Partnership for Africa's Development (NEPAD).
- 39. **Further takes note** that under this Declaration the Bank pledged a development assistance financing package for Sub-Saharan Member Countries of US\$2 billion over the 5-year period, starting from 1424H (2003-2004) in areas such as social sector, transport, trade, micro-finance and related capacity building measures by the end of the Year 1428H (5th Year of the Declaration), the total utilized amount reached US\$ 2.40 billion (i.e., 19% of the targeted amount).
- 40. **Welcomes** with appreciation the IDB's efforts for developing of a Five-Year Special Programme for the Development of Africa (SPDA) within the framework of the Islamic Solidarity Fund for Development (ISFD), for supporting development and poverty alleviation in Africa.
- 41. **Further notes with satisfaction** that the report of this SPDA was submitted after incorporating the views and observation made by the Ministers of Economy and Planning of African OIC Member States, during the Ministerial Meeting held in Dakar, Republic of Senegal, from 22 23 January 2008.
- 42. **The Conference welcomes** with satisfaction the orientations of the SPDA which put priority on the fight against poverty, based on a dual approach that aims, on the one hand, at satisfying the most basic needs of the population

by way of programs geared towards achieving the MDGs through concessional financing provided by the ISFD, and, on the other hand, at accelerating growth by supporting income generating economic infrastructures and development programs through more conventional financing.

- 43. **Notes with satisfaction** the efforts taken by the Bank's towards the promotion of Intra-OIC trade, including signing Memorandum of Understanding (MOUs) with the Government of Malaysia (in its capacity as Chairman of the 10th Session of the Islamic Summit) and Turkey (within the framework of the Turkish Government's Africa Development Strategy launched in 2003).
- 44. **Thanks** IDB for contributing to the financing of the First and Second Round of Meetings of the Trade Negotiations within the framework of the Agreement on Trade Preferential System (TPS-OIC) among the Islamic Countries.
- 45. **Appreciates** also the technical assistance programmes of the IDB to assist Member States which are either members of the WTO or in the process of accession to the Organization, and the role of the Bank in organizing consultative meetings; and **Commends** IDB for its efforts in providing technical assistance to enhance the capacity-building of the OIC Member States in human resources development and institutional sectors such as organizing trade policy courses, seminars, symposiums and workshops on the main topics and providing specific direct technical assistance to the OIC Member States.
- 46. **Expresses satisfaction** that the IDB has successfully carried out the mandate given by COMCEC in organizing Consultative Meetings for Member States (from 1996 up to present) in order to enable the Member States exchange views and coordinate their stands on issues of common interest in order to prepare for the WTO ministerial meetings and coordinate their positions regarding the issues raised in the Agenda items.
- 47. **Expresses** appreciation for efforts of IDB to make arrangements for preparatory meetings prior to WTO ministerial meetings for consultations and exchange of views among Member States; also **commends** IDB's support to Member States in their efforts to effectively participate in multilateral trade negotiations and its continued provision of technical and financial assistance to Member States in the matters related to WTO.
- 48. **Thanks** the IDB for organizing in Geneva (February & December 2007, as well as February 2008), consultative meetings of the Permanent Missions of the OIC Member Countries accredited to the WTO -for exchange of views on the status of the Doha Round on Trade Negotiations, and to discuss possible ways forward.

- 49. **Thanks** the IDB for its initiative to provide debt relief to the Member States in the framework of the international initiative to alleviate the debt burden of the Highly Indebted Poor Countries (HIPC).
- 50. **Appreciates** the effort made by IDB to continue allocating US\$ 1 billion from its ordinary capital resource (OCR) to ITFC and urges member states, banks and financial institutions of member countries to support the effort of ITFC to secure necessary additional funds for its trade financing activities.
- 51. Notes with satisfaction the efforts of the Islamic Corporation for the Insurance of Investment & Export Credit (ICIEC) in encouraging the flow of foreign investment to the OIC Member Countries and promoting their exports to all the globe; and **urges** the OIC Members who have not yet joined or accomplished their membership requirements to do so expeditiously, in order to benefit from its services.
- 52. **Expresses** appreciation for IDB efforts to accord preferential treatment to companies and contractors from Member States in the implementation of projects financed by the Bank and calls upon IDB to intensify its efforts in this field.
- 53. Underlines the role played by the IDB in facilitating the implementation of the Capacity Building Program for Poverty Alleviation in the OIC member states with four pilot projects having been identified under phase one of the Programme (Capacity Building for the Development of Fisheries Sector in Bangladesh; Capacity Building in Planning, Negotiating and Management for Exploitation of Oil and Mineral Resources in Mauritania; Capacity Building in Palm Oil Industry, Livestock Breeding and Animal Faltering Technology in Sierra Leone; and Capacity-building in small enterprise and micro-finance development for the Tsunami survivors in Nanggroe Aceh Darussalam in Indonesia), with a total cost of nearly US\$31 million.
- 54. **Expresses its appreciation** for the efforts in the establishment of the World Waqf Foundation, and **urges** the Member States to cooperate with it for advancing the Waqf affairs towards enhancing its economic and social role.
- 55. **Notes with satisfaction** the efforts of the IDB in providing support to the member states facing natural disasters, drought and desertification, especially in the areas of agriculture and food, rehabilitation, economic and social infrastructures as well as public services and utilities.
- 56. **Thanks** the IDB for initiating a programme for the development of Cotton and Textiles industries in its member countries, financing the OIC capacity building activities in the area of cotton (visit of experts from certain

Member Sates to prepare specialized studies on cotton First & Second Expert Group Meetings on Enhancing Production Efficiency and International Competitiveness in the Cotton Producing Member States, the Forum on Energizing Trade Investment in the Cotton Sector, as well as the Forum on Enhancement & Promotion of Trade and Investment in Cotton sector among the OIC member Countries), as well as incorporating the cotton issue within the framework of its technical assistance programmes on WTO related matters.

57. **Commends** the work of the Inter-organizational Technical Working Group (ITWG) established by the OIC General Secretariat and the Islamic Development Bank to follow-up the implementation of the OIC Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held at Makkah Al-Mukarramah on 7-8 December 2005.

C. ACTIVITIES OF THE OIC AFFILIATED INSTITUTIONS IN THE FIELD OF ECONOMIC AND TRADE COOPERATION:

<u>Recalling</u> Resolution No. 4/11-E(IS) adopted by the Eleventh Session of the Islamic Summit Conference and Resolution No.5/34-E of the Thirty-fourth Session of the Islamic Conference of Foreign Ministers;

<u>Having taken note</u> of the activities of the Islamic Chamber of Commerce and Industry (ICCI) and the Organization of the Islamic Shipowners' Association (OISA);

Expressing its appreciation for the role played by the affiliated institutions in the elaboration and implementation of the Plan of Action to Strengthen Economic and Commercial Cooperation among Member States;

<u>Appreciating</u> the role played by these two institutions in their respective fields of action;

i. Activities of the Islamic Chamber of Commerce and Industry (ICCI).

<u>Having considered</u> the report on the activities of the Islamic Chamber of Commerce and Industry,

<u>Appreciating</u> the major role undertaken by the ICCI to reinforce economic and trade cooperation among private sector.

<u>Welcoming</u> the 10-Year Work Plan of ICCI and proposal to prepare feasibility studies on projects in the areas of transportation, food security, infrastructure, gas and energy in collaboration with COMCEC Coordination Office and relevant OIC institutions and circulate them among member states prior to the COMCEC meetings.

- 58. **Appeals** to the Member States for their support and encourages their National Chambers of Commerce and Industry to actively take part in the ICCI projects which are aimed for strengthening economic cooperation.
- 59. **Welcomes** the ICCI projects and supports it as the principal representative of the private sector in the OIC Member States.
- 60. **Takes note** of the work have been done by the World Zakat Authority and the World Public Institution for Waqfs.
- 61. **Appreciates** the decision of the Ninth OIC Standardization Expert Group to cooperate with the ICCI on the issue of OIC Halal Food as a principal representative of the private sector in the OIC Member States.
- 62. Welcomes the steps taken by the ICCI in favour of the open visa for the members of the OIC Business Owners Union (BOU) and urges the Member States to sign the relevant agreement.
- 63. Urges the economic entities in all OIC Member States to participate in the proposed companies such as the International Islamic Company for Exploration of Investment Opportunities & Promotion of Intra-Trade (FORAS), Business Owners Union (BOU), Al-Emmar Bank, Company for Development of Infrastructure, Company for Recruitment and Employment of Labor, Company for Promotion of Inter-Islamic Tourism and other such companies acting for the expansion of trade exchange among Islamic States; and **invites** the OIC governments to welcome the establishment of these companies and their branches and to facilitate procedures for them.
- 64. **Thanks** the State of Qatar for hosting the Third Forum for Businesswomen in Islamic Countries in collaboration with ICCI under the kind patronage of H.H Sheikha Mozah Bint Nasser Al-Missned, spouse of H.H. the Emir of Qatar on the theme of "Micro-Credit Financing.... the way forward for economic prosperity" from 13-15 January 2008. The Forum was attended by more than 300 delegates from 45 member countries and international institutions. The Committee also took note the offer of Arab Republic of Syria for hosting the Fourth Forum.
- 65. **Thanks** to the Government of Uganda for hosting the 12th Private Sector Meeting under OIC Business Forum in Kamapala from 16-18 June, 2008 in collaboration with ICCI and Uganda National Chamber of Commerce and Industry and invites the Member States to encourage their private sector to actively particpate.

ii. Activities of the Organization of Islamic Shipowners Association (OISA).

- 66. **Expresses** thanks to the Custodian of Two Holy Mosques and the Government of the Kingdom of Saudi Arabia for extending consistent support to the Islamic Shipowners' Association, giving donations and hosting its Headquarters.
- 67. Also expresses thanks to the Government of the Kingdom of Saudi Arabia for allowing the setting up of the Headquarters of the Bakkah Shipping Company (BASCO) in Jeddah.
- 68. **Thanks** the Government of Dubai (State of the United Arab Emirates) for hosting the 29th Joint Meeting of the Executive Committee and the 21st Meeting of the General Assembly in Dubai, for registering the Bakkah Shipping Company without intermediary or local sponsor, for giving the company 100% ownership right, for providing it with a free piece of land at a convenient location, and for registering the branch of the Islamic Protection and Indemnity Club (a non-profit insurance company) in Dubai.
- 69. **Welcomes** the establishment of the Bakkah Shipping Company and calls on the shipping companies, private sector and individuals in the Member States to support the Company in its effort to serve the Muslim Ummah.
- 70. **Appreciates** the Government of the Islamic Republic of Iran for extending its support to the Islamic P&I Club enabling it to operate and offering adequate coverage within the Iranian jurisdiction with the minimum legal restriction.
- 71. **Commends** the initiative of the OISA Executive Committee, the Board of Trustees of the Islamic P&I Club (Islamic Protection and Indemnity Club) and the Iranian Shipping Companies, especially the National Iranian Tanker Company for their joint efforts and contributions in having the Islamic P&I Club to be under the umbrella of the Islamic Shipowners' Association.
- 72. **Invites** Member States and their maritime companies to register their ships with the Islamic P&I in Qeshm Island in Islamic Republic of Iran, in order the Club meet the level of the existing International P&I Clubs and also to encourage the treatment of the ships under cover of the Club on equal footing with national ships at the Member States seaports; and **urges** all the ports authorities of the Member States to cooperate and offer all supports and facilities to the acceptance of Islamic P&I Club covers ad certificate of entries issued by the Club, and **further urges** the insurance companies in the Member States to facilitate all kind of services to Islamic P&I Cub in accordance with support of the Club covers.

- 73. Welcomes the creation of the Cooperative Information System at the General Secretariat of the Organization of Islamic Shipowners' Association (OISA) in Jeddah to serve the shipping companies in OIC Member States.
- 74. **Urges** the Member States, which have not yet done so, to sign the Statute of the Islamic Shipowners' Association.
- 75. **Appeals** to the Member States to continue to extend their support and assistance to the OISA.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on each item appearing from A to C to the Thirty-Sixth Session of the Council of Foreign Ministers.

RESOLUTION N0. 6/35-E ON ''SUSTAINABLE TOURISM DEVELOPMENT IN A CROSS-BORDER NETWORK AND PROTECTED AREAS IN WEST AFRICA''

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the resolution on Tourism Development of the 5th Islamic Conference of Tourism Ministers held in Baku in the Republic of Azerbaijan in September 2006;

<u>Recalling</u> the relevant provisions of the Plan of Action of the Organisation of the Islamic Conference (OIC) for strengthening economic and Commercial Cooperation and the COMCEC's resolutions relating to the project on the ""Sustainable Tourism Development in a Cross-Border Network and Protected Areas in West Africa"; which gathers nine Member States of the OIC: Benin, the Gambia, Guinean Guinea Bissau, Mali, Mauritania, Niger, Senegal and Sierra Leone.

<u>Taking into</u> account the interest given by H.E. Prof. Dr.Ekmeleddin Ihsanoglu, the Secretary General of the Organisation of the Islamic Conference (OIC) to the Implementation of this project and which has appointed the Islamic Centre for Development of Trade (ICDT) to ensure the coordination of this project on behalf of the OIC.

<u>Considering</u> the importance of this project for sustainable Development of Tourism, poverty alleviation and protection of environment in West Africa;

- 1. **Reaffirms** its support to the regional project on the creation of a Network of Cross-Border Parks and Protected Areas in West Africa submitted by the above nine OIC Member States.
- 2. **Expresses** its thanks to the Republic of Guinea for the efforts it has exerted to coordinate and follow up this Project
- 3. **Expresses** its thanks to the Republic of Korea and the World Tourism Organisation and ST-EP Foundation for having graciously supplied a financial contribution to work out the Feasibility study of this project;
- 4. **Notes with satisfaction** that ICDT is performing with a great efficiency the coordination of the project committee at the level of the OIC in cooperation with SESRIC;
- 5. **Calls** on IDB Group to extend its financial assistance for the implementation of the project.

6. **Expresses** its satisfaction at the progress achieved in the implementation of this project, notably the launching of the feasibility study.

Requests the Secretary General to follow up on the implementation of this resolution, and to submit a report thereon to the 36th Session of the Council of Foreign Ministers.

RESOLUTION NO. 7/35-E THE DEVELOPMENT OF INTERNATIONAL HALAL STANDARD

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the OIC Ten-Year Programme of Action which calls for the promotion of endeavours for institutionalised and enhanced cooperation between OIC and regional and international institutions working in the economic and commercial fields;

<u>Realising</u> that the International Halal industry provides a catalyst to increase intra OIC trade, in line with the objective to enhance trade relations among the OIC Member States;

<u>Acknowledging</u> the increased awareness and demand for Halal products by the global Muslim community,

- 1. Welcomes the convening of the 3^{rd} annual World Halal Forum, which was held in Kuala Lumpur, Malaysia on 12 13 May 2008.
- 2. **Commends** the convening of the 9th meeting of the OIC Standardisation Expert Group held in Ankara, Republic of Turkey on 16 18 April 2008 and **welcomes** the decision of the meeting to accept the offer by the Islamic Chamber of Commerce and Industry (ICCI) to host the 10th meeting in Jeddah, Kingdom of Saudi Arabia in 2009.
- 3. **Commends** the ongoing efforts to develop an OIC Halal Standards, in particular regarding certification and accreditation among OIC Member States.
- 4. **Welcomes** the contribution of RM15 million by the Government of Malaysia over the next 3 years for the funding support of the operating cost of The International Halal Integrity Alliance, a non-profit organisation with the objective to promote and enhance international collaboration amongst national halal authorities.
- 5. Welcomes the offer by the Malaysian Government to extend technical assistance to OIC Member States and the Muslim Minorities in the non-OIC member states in the areas of Halal Certification, Technical Know-How and Standards Development. And **appreciates** the plans of the Islamic Chamber of Commerce and Industry as the principal representative of the private sector in OIC Member States with regard to values, Halal, and quality control.

6. **Invites** Member States to avail the generous offer made by the Malaysian Government and support the efforts by the ICCI

Requests the Secretary General to follow-up on the implementation of this resolution, and to submit a report thereon to the Thirty-Sixth Session of the Council of Foreign Ministers.

RESOLUTION NO.8/35-E ON THE FOOD SECURITY OF THE MEMBER STATES OF THE ORGANIZATION OF THE ISLAMIC CONFERENCE

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Referring to</u> the current international food crisis resulting from the increase in the prices of basic food commodities;

Expressing its concern over the repercussions of this crisis on the developing countries and the Least Developed Countries (LDCs) and their ability to secure the basic food requirements of their citizens as well as the possible ramifications of this crisis in terms of precipitating future famines in different areas and regions worldwide;

<u>Recalling</u> every human being's right to unfettered access to food and freedom from hunger, which is a right enshrined in human rights covenants, particularly the Universal Declaration of Human Rights (UDHR); the International Covenant on Economic, Social, and Cultural Rights (ICESCR); the Universal Declaration on the Eradication of Hunger and Malnutrition (UDEHM); and the Rome Declaration on World Food Security (DWFS);

<u>Asserting</u> that the continued rise in the cost of basic food commodities has an adverse impact on achieving the Millennium Development Goals (MDGs); contributes to exacerbating the rate of poverty; and impedes development plans, particularly in developing countries and LDCs;

<u>Recalling</u> the OIC Ten-Year Programme of Action (POA) adopted by the 3rd Extraordinary Session of the OIC Summit Conference held in Mecca Al-Mukarramah, on 7-8 December 2005;

<u>Welcoming</u> with appreciation the initiative of **His Highness** the Emir of the State of Kuwait to establish the Fund for Decent Living in the Islamic States during the 4th World Islamic Economic Forum, hosted by Kuwait in the period from 29 April – 1 May 2008 and at which Kuwait donated US\$ 100 Million to the Fund with a view to supporting the initiative to provide urgently basic food products to the needy, to contributing to the programme to increase the production of agricultural products, and the cooperating with similar initiatives in the world; and <u>calling</u> on Member States and other donor bodies to contribute to the Fund.

<u>Appreciating</u> the efforts of the Secretary General to address the food security issue in the OIC Member States;

- 1. **Calls on** the Member States to unite their efforts in order to tackle the crisis engendered by steep prices of basic food commodities and **urges** them to coordinate their action so as to exchange expertise/experiences and information on the measures taken by each member state at the national level in order to face this crisis.
- 2. **Reaffirms** the importance of cooperation among the Member States in order to launch joint agricultural projects aimed at increasing their agricultural production, vertically and horizontally; whether this be through investments, transfer of expertise, or provision of agricultural land.
- 3. **Urges** Muslim financing institutions, particularly the Islamic Development Bank (IDB) and the Poverty Alleviation Fund (PAF), to step up their contributions to the funding of agricultural projects in the Member States.
- 4. **Encourages** the Member States to work towards increasing trade exchanges amongst themselves in the field of basic food commodities, provided the Member States that have a surplus of agricultural production give priority in their exports to other Member States in need of such products.
- 5. **Calls on** the Member States to give a special priority to following up the issue of vital fuel so as to evolve a united position that helps to allay the adverse impact of the increased consumption of food commodities in the production of fuel on global food security.
- 6. **Calls on** the Member States to consult regularly according to their positions in the World Trade Organization (WTO) negotiations, particularly with reference to agricultural issues, including especially the trade-disfiguring collective subsistence, in order to reach results that can help in achieving global food security as well as protecting the interests of developing countries, especially Net-Food Importing Countries (NFICs).
- 7. **Emphasizes** the importance of cooperation among the Member States on increasing coordination with international finance institutions, particularly the International Monetary Fund (IMF) and the World Bank, as well as coordination with the United Nations agencies concerned, including the Food and Agriculture Organization (FAO); the International Fund for Agricultural Development (IFAD); and the United Nations Development Programme (UNDP).

- 8. **Calls on** developed countries and international financing institutions to increase their urgent assistance to countries affected by the crisis due to the rise of prices of basic food commodities.
- 9. Also calls on international institutions and developed countries to redouble their official assistance and technical support to the agricultural sectors of developing countries in such a way as to help increase agricultural production in these countries.
- 10. **Requests** the Secretary General to organize a Meeting of Food and Agricultural Ministers of the OIC to address the current international food crisis and achieving food security in Member States.

Requests the Secretary-General to follow up the implementation of this Resolution and submit a report thereon to the Thirty-Sixth Session of the Council of Foreign Ministers and also to the COMCEC.

RESOLUTION NO.9/35-E ON THE NEW ECONOMIC PARTNERSHIP FOR THE UMMAH

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action adopted by the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah on 7-8 December, 2005;

<u>Recalling also</u> the different high level and COMCEC meetings and resolutions adopted thereon in the field of economic cooperation among the OIC Member States;

Noting with appreciation the high level debate on the theme "New Economic Partnership for the Ummah" held during the Eleventh Session of the Islamic Summit Conference, as well as the Thirty First Session of the Islamic Commission on Economic, Cultural and Social Affairs;

Having taken note of the report of the Secretary General;

- 1. **Thanks** the Government of the Republic of Senegal for initiating this new debate on the Economic Partnership for the Ummah;
- 2. **Emphasizes** the need to foster a comprehensive partnership in the field of economy within the Ummah;
- 3. **Requests** the General Secretariat of the OIC in collaboration with the relevant institutions of the OIC to prepare a report on the New Economic Partnership within the Ummah, in line with the OIC Ten-Year Programme of Action and taking into account the efforts made by the Member States, private sector and OIC institutions to be submitted to the next session of the Council of Foreign Ministers for its consideration.

Requests the Secretary General to follow up the implementation of this resolution and submit a report on it to the Thirty-Sixth Session of the Council of Foreign Ministers of the Organization of the Islamic Conference.

RESOLUTION NO.10/35-E ON INFRASTRUCTURE DEVELOPMENT

The Thirty Fifth Session of the Council of the Foreign Ministers of the Organization of the Islamic Conference (Session of Prosperity and Development), held in Kampala, Republic of Uganda, from 18 to 20 June, 2008,

<u>Recalling</u> the Ten-Year Programme of Action of the Organisation of the Islamic Conference;

<u>Recalling</u> the Declaration of the 11th Session of the Islamic Summit Conference, held in Dakar in 2008, that recognized the importance of infrastructure development;

<u>Conscious</u> of the critical role that infrastructure plays in efforts at enhancing competitiveness, regional cooperation, alleviating poverty, promoting investment and intra-OIC trade as well as unlocking bottlenecks to development;

<u>Aware</u> of the additional challenges faced by OIC Least Developing Countries and landlocked countries in transforming their economies as a result of poor infrastructure;

<u>Recognizing</u> the commendable efforts made the OIC and its member states in alleviating poverty, promoting investment, intra-OIC trade and development;

- 1. **Welcomes** the establishment of the Islamic Solidarity Fund for Development, the Special Development Programme for Africa and the Fund for Decent Living in the Islamic States and other development assistance initiatives;
- 2. **Encourages** all Member States to provide financial support for the implementation of infrastructure development projects in areas such as transport, energy, ICT, agriculture, food product, education and health to the LDCs;
- 3. **Requests** the IDB to provide appropriate support to efforts at implementing infrastructure development projects in OIC Member States;
- 4. **Requests** the Secretary General to organize an Experts Group meeting to study possibilities for cooperation in infrastructure development in the sectors of transport and energy in OIC Member countries and make recommendations to the Ministers responsible.

Requests the Secretary General to submit a report on the implementation of this resolution to the Thirty-Sixth Session of the Council of Foreign Ministers.
