RESOLUTION NO. 1/29-ORG

ON UPDATING THE MEMORANDUM OF UNDERSTANDING BETWEEN THE ORGANIZATION OF THE ISLAMIC CONFERENCE (OIC) AND THE UNITED NATIONS ENVIRONMENT PROGRAMME (UNEP)

The Twenty-ninth Session of the Islamic Conference of Foreign Ministers (Session of Solidarity and Dialogue), held in Khartoum, Republic of the Sudan, from 14 to 16 Rabi-ul-Thani, 1423H (25-27 June, 2002),

Recalling the Memorandum of Understanding concluded between the Organization of the Islamic Conference and the United Nations Environment Programme (UNEP) on 28 May 1990;

Aware of the importance of cooperation in the field of preserving the environment;

Taking note of the report of the Secretary General on the matter;

Cognizance of the importance of the representation of Member States in the various international posts and **having taken note** of the candidatures submitted by the Member States in this respect;

Decides to support and back the following:

1. **Nomination** of the Republic of Tunisia for membership of the Council of the International Authority for the Seabed, Group E.
2. **Renomination** of the Republic of Tunisia for membership of the International Telecommunications Union for the period 2002-2004.

3. **Renomination** of Dr. Abdelfattah Omar (from the Republic of Tunisia) for membership of the UN Commission for Human Rights for the period 2003-2006.
4. **Renomination** of Mr. Mohsen Belhaj Omar (from the Republic of Tunisia) for membership and chairmanship of the International Civil Service Commission for the period 2003-2006.
5. **Renomination** of the State of Qatar for membership of the Human Rights Commission for the period (2004-2006) in elections due to take place during the 59th Session of the Economic and Social Council (ECOSOC) in May 2003.
6. **Renomination** of the State of Qatar for non-Permanent Membership of the UN Security Council for the period (2006-2007) in elections to be held during the 60th Session of the UN General Assembly in 2005.
7. **Renomination** of the Republic of Algeria for membership of the Council of the International Telecommunications Union in elections due to be held in September 2002 in Marrakech.

The Twenty-ninth Session of the Islamic Conference of Foreign Ministers (Session of Solidarity and Dialogue), held in Khartoum, Republic of the Sudan, from 14 to 16 Rabi-ul-Thani, 1423H (25-27 June, 2002),

Recognizing the importance of cooperation between the Organization of the Islamic Conference and the Community of Sahel-Saharan States;

Being keen on strengthening links between the Member States of the two Organizations;

1. **Decides** to approve the Draft Cooperation Agreement between the Organization of the Islamic Conference and the Community of Sahel-Saharan States.
2. **Requests** the Secretary General to follow up implementation of this resolution and submit a report thereon to the Thirtieth Session of the Islamic Conference of Foreign Ministers.

RESOLUTION NO. 7/29-ORG

ON THE NOMINATION OF THE HIGH COMMISSIONER FOR HUMAN RIGHTS

The Twenty-ninth Session of the Islamic Conference of Foreign Ministers (Session of Solidarity and Dialogue), held in Khartoum, Republic of the Sudan, from 14 to 16 Rabi-ul-Thani, 1423H (25-27 June, 2002),

Taking into consideration the objectives of the OIC Charter, and the Cairo Declaration on Human Rights in Islam, that call for the promotion, encouragement and respect of human rights and basic freedoms for all proceeding from the tolerant values and preaching of Islam, the UN Charter, the Universal Declaration on Human Rights and other related instruments;

Referring to the fact that the post of the UN High Commissioner for Human Rights will be vacant on 12 September 2002, and taking due account of the fact that this post, according to the geographical distribution of nomination will be given to the Afro-Asian Group.

In view of the importance of that post to the OIC Member States, some of whom have applied for it.

DECIDES:

1. **To urge** the Islamic States of Asia and Africa to coordinate their efforts to present a candidate commonly agreed upon.

2. **To Request** the Member States to strive to muster all support in favour of that candidate at all levels.

3. **To request** the Islamic Group in New York and the Islamic Group in Geneva to take all appropriate measures for implementing that decision.
