Considering the importance accorded by the Islamic countries to the presence of an Islamic State representing them on the UN Security Council;

Taking note of the decision of the Syrian Arab Republic to submit its candidacy to occupy a non-permanent seat on the Security Council allocated to the states of the Asian Group for the period 2002/2003;

Recalling resolution 3/9-ORG (IS) of the Ninth Islamic Summit Conference to support and assist this candidacy;

Taking note of the resolution No. 4503/DA 84/C2, adopted by the Council of the Foreign Ministers of the League of Arab States, dated 11 September 1985, to support this candidacy; as well as the decision of the Asian Group adopted in its meeting held in New York on 23 October 2000, to support and assist this candidacy;

1. Decides to support and assist the candidacy of the Syrian Arab Republic to occupy a non-permanent seat on the UN Security council for the period 2002/2003, in the elections due to be held during the 56<sup>th</sup> Session of the UN General Assembly in the Fall of 2001.

2. Invites the Member States to conduct the necessary contacts in order to exhort other states to support this candidacy.

Taking note of the decision of the State of Qatar to submit its candidature to the non-Permanent Seat on the UN Security Council reserved for the Asian States Group for the period 2006-2007;

Recalling resolution No.2/9-ORG(IS) of the Ninth Islamic Summit Conference to support this candidature;

1. Decides to support and assist the candidature of the State of Qatar for a non-Permanent Seat on the UN Security Council for the period 2006-2007 during the elections to be organized alongside the Sixtieth Session of the UN General Assembly in the autumn of 2005.

2. Calls on the Member States to conduct the necessary contacts to urge the other States to support this candidacy.
