15-18 RABIUL AWAL 1420H (28 JUNE - 1 JULY 1999)

- 1. The Administrative and Financial Affairs Committee of the 26th Session of the Islamic Conference of Foreign Ministers (Session of Peace and Partnership for Development) met in Ouagadougou, Burkina Faso from 15 to 18 Rabiul Awal 1420H (28 June to 1 July 1999) to examine the agenda items submitted to it by the Conference.
- 2. The Committee formed its Bureau from among Member States in the same way as the Bureau of the Plenary Session.
- 3. The meetings of the Committee were chaired by His Excellency Ambassador Mamadou Serme, Secretary General for Foreign Affairs of Burkina Faso.
- 4.The Chairman opened the proceedings with an address in which he welcomed the delegation of Member States and the Representatives of the General Secretariat. He wished them a pleasant stay in Burkina Faso and called on the assistance and cooperation of the delegations to facilitate the work of the Committee.
- 5.The Committee examined the agenda items pertaining to it and agreed to refer the following draft resolutions, it has adopted, to the plenary session for approval:

Draft Resolution on the Report of the 27th Session of the Permanent Finance Committee;

Draft Resolution on the adoption of the budgets of the General Secretariat and Subsidiary Organs for the financial years 1998/99 and 1999/2000;

Draft Resolution on housing rent for the official staff of the General Secretariat's Bureaus abroad;

Draft Resolution on splitting up the Department for Administrative and Financial Affairs of the General Secretariat into two departments;

Draft Resolution on amendments to the personnel regulations of the Organization of the Islamic Conference.

6.The Committee recommended that the determination of the term of office of the Assistant Secretaries General be examined at the 28th Session of the Permanent Finance Committee

and that the General Secretariat should prepare a comprehensive working paper containing the criteria and conditions for fixing the term of office of the Assistant Secretaries General.

- 7.The Committee took cognizance of the status of Member States' accumulated arrears of contributions to the budgets of the General Secretariat and Subsidiary Organs. In this respect, it recommended that Member States be urged to promptly settle their arrears so that the General Secretariat can fulfil its commitments and carry out the tasks assigned to it.
- 8.At the end of its deliberations, the Committee expressed its deep appreciation and gratitude to the Government of Burkina Faso for generously hosting this Conference and providing excellent services to ensure the success of the Conference.
- 9. The Committee expressed its thanks to its Chairman for his excellent conduct of the proceedings and for the wisdom he demonstrated, which greatly contributed to the success of the meetings.
- 10. The Committee extended its thanks to the General Secretariat for the clarifications and efforts it has made, which also contributed to the success of the proceedings.

ON COVERING HOUSE RENT FOR THE OFFICIAL STAFF OF THE GENERAL SECRETARIAT'S BUREAUS ABROAD.

The Twenty-sixth Session of the Islamic Conference of Foreign Ministers (Session of Peace and Partnership for Development) held in Ouagadougou, Burkina Faso, from 15 to 18 Rabiul Awal 1420H (28 June - 1 July 1999),

Pursuant to Article (44-3) of the OIC Personnel Regulations;

Having considered the report of the Twenty-seventh Session of the OIC Permanent Finance Committee, which was held in Jeddah, Kingdom of Saudi Arabia from 20 to 24 Shawal 1419H (16-20 February 1999),

Decides that:

The General Secretariat shall, on an exceptional basis, cover the house rent for the official staff of the OIC bureaus abroad (New York and Geneva), provided that the rental amount shall be fixed through a decision issued by the Secretary General on the basis of the average rents applicable in New York and Geneva, both known for their high cost of living.



RESOLUTION NO. 4/26-AF

ON THE DIVISION OF THE DEPARTMENT OF FINANCIAL AND ADMINISTRATIVE AFFAIRS OF THE GENERAL SECRETARIAT INTO TWO DEPARTMENT

The Twenty-sixth Session of the Islamic Conference of Foreign Ministers (Session of Peace and Partnership for Development) held in Ouagadougou, Burkina Faso, from 15 to 18 Rabiul Awal 1420H (28 June - 1 July 1999),

Pursuant to Rule 7 of the Internal Rules of the General Secretariat;

Having taken cognizance of the report of the Twenty-seventh Session of the OIC Permanent Finance Committee which was held in Jeddah, Kingdom of Saudi Arabia from 20 to 24 Shawal 1419H (16 - 20 February 1999);

Decides:

- 1.To divide the Department for?Financial and Administrative Affairs into two separate departments.
- 2. The Department of Financial Affairs shall deal with all the financial matters of the General Secretariat in accordance with paragraphs 1 and 2 of Article Seven of Rule V of the General Secretariat's Internal Rules.
- 3. The Department of Administrative Affairs shall assume the functions stipulated in paragraphs 3 to 9 of Article 7 of Rule V of the General Secretariat's Internal Rules.

- 4. The Department of Financial Affairs and the Department of Administrative Affairs shall cooperate and coordinate their action on all administrative and financial matters.
- 5. The present decision shall not entail any additional financial burdens and shall be implemented within the limits of the General Secretariat's budget.



RESOLUTION NO. 5/26-AF

ON THE INTRODUCTION OF AMENDMENTS TO THE PERSONNEL REGULATIONS OF THE ORGANIZATION OF THE ISLAMIC CONFERENCE

The Twenty-sixth Session of the Islamic Conference of Foreign Ministers (Session of Peace and Partnership for Development) held in Ouagadougou, Burkina Faso, from 15 to 18 Rabiul Awal 1420H (28 June - 1 July 1999),

In accordance with Article 6, paragraph 2 of the OIC Charter concerning observance of the principle of equitable geographic distribution;

In compliance with the principle of equal opportunity for Member States and with a view to attracting fresh competencies;

Having considered the report of the Twenty-seventh Session of the OIC Permanent Finance Committee, which was held in Jeddah, Kingdom of Saudi Arabia from 20 to 24 Shawal 1419H (16-20 February 1999)?;

Decides:

- 1.To cancel the fourth (4) paragraph of Article 13 of the OIC Personnel Regulations which excludes staff occupying the posts of D.1 from the Seven-year service limit.
- 2.To amend article 13-2 of the OIC Personnel Regulations, which will read as follows: "Recruitment to the Principal Posts (D.1 and D.2) shall be by designation for a four year period, including the probationary period. After the initial period of four years, the contract may be renewed on a yearly basis up to a maximum of seven years to be counted as of the date of entry on duty. No official of the principal category (in question) may be appointed from the General Secretariat to the subsidiary organs or vice-versa, once the seven-year period has elapsed".
- 3.Not to conclude any new contract with officials currently, serving at any subsidiary organs and having exhausted the statutory period stipulated in article 13-2 of the Personnel Regulations and having received their end-of-service allowance, after expiry of their current contracts.
- 4.To expand Grade A-4 of the Administrative Category of Article 10-3 of the OIC Personnel Regulations from 10 steps to 16 steps, as follows:
