### **Report of Administrative and Financial Affairs Committee**

The Administrative and Financial Affairs Committee of the Eighteenth Islamic Conference of Foreign Ministers met in Riyadh, Kingdom of Saudi Arabia from 7 to 8 Sha'ban 1409H (14-15 March 1989) to examine the Agenda items referred to it by the Conference.

The Committee meetings were chaired by H. E. Mr. Usama Jaafar Faqeih, Under Secretary of Ministry of Finance for International Economic Cooperation (Kingdom of Saudi Arabia).

The Committee bureau was formed as follows:

The Representative of the Kingdom of Saudi Arabia as Chairman.

The Representative of the Republic of Mali, Malaysia and Palestine as Vice-Chairmen.

Representative of the Hashemite Kingdom of Jordan as Rapporteur.

The Chairman opened the proceedings with a statement in which he welcomed the delegations and wished them a pleasant stay in the Kingdom of Saudi Arabia, and highlighted the importance of the meeting which was held under the umbrella of Islamic Solidarity and Fraternity.

He sought the assistance and cooperation of the delegations to facilitate his task, in a positive atmosphere of true Islamic brotherhood, sincere determination to endeavour for achieving the noble objectives of Islamic solidarity. The following recommendations and draft resolutions emerged from the Committee's debates:

#### I. TENTH REPORT OF THE FINANCE CONTROL ORGAN ON THE FINAL ACCOUNTS OF THE GENERAL SECRETARIAT AND ITS SUBSIDIARY ORGANS FOR THE FINANCIAL YEAR ENDING ON 30 JUNE, 1988

After examining this Report, the Committee recommended that it be adopted, and directed the General Secretariat and its Subsidiary Organs to comply with the observations made therein to implement them, and to rectify any mistakes or overspending and set things in the right direction.

#### II. BUDGETS OF THE GENERAL SECRETARIAT AND ITS SUBSIDIARY CENTRES AND ORGANS FOR THE FINANCIAL YEAR 1988-89

Having considered the report of the 19th Session of the OIC Permanent Finance Committee on the proposed budgets for financial year 1988-89, the Committee recommended that they be adopted as stipulated in Resolution No. 2/18-AF.

During the deliberations the Committee called upon the General Secretariat and its Subsidiary Centres and institutions to make serious efforts to rationalize expenditure and comply with the prevailing financial regulations and instructions in implementing these budgets.

#### III. RATES OF CONTRIBUTIONS

After an indepth discussion the Committee was of the view that such an important issue requires further study, and urged the Member States to provide the necessary data to Ankara Centre to enable it to complete the study, to be submitted to the Open Ended Specialised Technical Committee for review. The recommendations of the Specialised Committee should be submitted to the 19th Islamic Conference of Foreign Ministers through the Permanent Finance Committee.

The Representatives of four Member States expressed the reservations of their countries on their current rates of Contributions as approved by the 15<sup>th</sup> ICFM.

#### IV. RECOVERY OF ARREARS OF CONTRIBUTIONS

The Committee expressed its deep concern at the mounting arrears of contributions and recommended that the Secretary General - in consultation with the Chairman of the current

session - be requested to examine this phenomenon, to propose appropriate solutions thereto and to submit a report on the question to the 19th Islamic Conference of Foreign Ministers.

#### V. DRAFT PENSION PLAN FOR OIC GENERAL SECRETARIAT PERSONNEL AND REPORT OF THE INTER-GOVERNMENTAL EXPERTS COMMITTEE ON REVIEW OF THE OIC PERSONNEL AND FINANCIAL REGULATIONS

After discussion and deliberations, the Committee was of the view that the Pension Plan should be assigned to the Intergovernmental Experts Committee to be studied with the Personnel and Financial Regulations of the Organization and its Organs.

The Committee also recommended renewal of the mandate of the Experts Committee to enable it to finalise its work and forward its final report and Draft Regulations to the General-Secretariat for transmission to Member States for their comments, and to subsequently submit them to the Nineteenth Islamic Conference of Foreign Ministers for approval.

It called upon the General Secretariat to convene the next meeting of the Inter-Governmental Experts Committee within the next three months.

#### VI. REPORT OF THE EXPERTS COMMITTEE ON THE FUNCTIONING OF THE ORGANISATION OF THE ISLAMIC CONFERENCE.

The Committee considered the report of the Experts Committee on the functioning of the OIC and its subsidiary organs and specialised institutions and expressed its appreciation of the efforts made by the Experts Committee in this regard.

Following thorough discussion, the Committee recommended the adoption of the recommendations and proposals contained in the Report of the Committee with regard to the restructuring and classification of the Subsidiary Organs, Specialised Organs and affiliated institutions.

The Committee reiterated the need for coordination between the General Secretariat and the Organs mentioned above and urged implementation of the proposed measures for strengthening coordination between them. It also urged the adoption of suitable steps to ensure efficient performance of the Organization and its various organs and to achieve rationalization of expenditure.

At the conclusion of the proceedings the Committee expressed its sincere thanks and appreciation to the Government of the Custodian of the Two Holy Mosques for the generous hospitality and excellent arrangements for the Conference. It also expressed its thanks to the Members of the Bureau and the personnel of the General Secretariat for their commendable efforts.

Having examined the Tenth Report of the Finance Control Organ on the Final Accounts of the General Secretariat and the Subsidiary Organs for the financial year ending 30th June, 1988.

Having considered the recommendations of the Nineteenth Session of the Permanent Finance Committee on the report of the Finance Control Organ.

1. Approves the Tenth Report of the Finance Control Organ.
2. Directs the General Secretariat and the Subsidiary Organs to comply with the observations contained therein and to implement them; and also to correct any errors or over expenditure and set things right.

**RESOLUTION NO. 2/18-AF**

**ON THE REPORT OF THE NINETEENTH SESSION OF THE PERMANENT FINANCE COMMITTEE AND THE BUDGET OF THE OIC GENERAL SECRETARIAT AND SUBSIDIARY AND AFFILIATED CENTRES & ORGANIZATIONS FOR THE YEAR 1988/1989.**

The Eighteenth Islamic Conference of Foreign Ministers (Session of Islamic Fraternity and Solidarity), held in Riyadh, Kingdom of Saudi Arabia, from 6-9 Shaban, 1409H (13-16 March, 1989),

Having reviewed the recommendations of the 19th Session of the Permanent Finance Committee for the financial year 1988/89;

1. Approves the recommendations of the Nineteenth Session of the Permanent Finance Committee and entrusts the General Secretariat and the Subsidiary Organs to implement them.

2. Approves the budget of the General Secretariat of the Organization of the Islamic Conference and its subsidiary organs for the financial year 1988/89 provided they are totally financed by mandatory contributions of Member States at the rates of assessment approved by the Fifteenth Islamic Conference of Foreign Ministers, as follows:

- General Secretariat US\$ 6,707,523
- Islamic Foundation for Science, Technology & Development (IFSTAD). SR. 4,125,000
- Islamic Fiqh Academy US\$ 1,255,000
- Statistical, Economic and Social Research and Training Centre for Islamic States Ankara. US\$ 1,800,000
- Islamic Centre for Technical and Vocational Training and Research Dhaka. US\$ 1,800,000
- Research Centre for Islamic History, Art and Culture, Istanbul. US\$ 1,550,000
- International Commission for The Preservation of the Islamic Cultural Heritage, Istanbul. US\$ 600,000
- Islamic Centre for Development of Trade - Casablanca. US\$ 1,000,000

3. Calls on Member States that have not as yet paid their contributions to the General Secretariat and the Subsidiary Organs to acquit themselves of their obligations and regularly pay their contributions in time.

4. Urges the General Secretariat and its Subsidiary Organs to exert serious efforts to rationalize expenditure and abide by the financial rules and regulations set for the implementation of these budgets.

### **RESOLUTION NO. 3/18-AF**

#### **ON THE PROPOSED REVISED SCALE OF CONTRIBUTIONS OF MEMBER STATES TO THE BUDGET OF THE OIC GENERAL SECRETARIAT AND THE SUBSIDIARY ORGANS**

The Eighteenth Islamic Conference of Foreign Ministers (Session of Islamic Fraternity and Solidarity), held in Riyadh, Kingdom of Saudi Arabia, from 6-9 Shaban, 1409H (13-16 March, 1989),

Having Reviewed the study submitted by the Ankara Centre on the proposed revised scale of contributions of Member States to the budgets of the OIC General Secretariat and the Subsidiary Organs;

Having reviewed the recommendations of the Nineteenth Sessions of the Permanent Finance Committee on the above-mentioned proposals and noting that the matter requires more comprehensive statistical information and data on Member States;

1. Entrusts the General Secretariat and the Ankara Centre to conduct further study on the matter and to collect latest relevant statistical information and data from Member States to enable them to complete the required study as soon as possible and communicate it to Member States for consideration and comments.

2. Reiterates the necessity of implementing Resolution No. 10/17-AF on commissioning an open-ended specialized technical committee to review the study to be prepared by the General Secretariat and the Ankara Centre and to make appropriate recommendations on the subject to be submitted subsequently to the Nineteenth Islamic Conference of Foreign Ministers through the Permanent Finance Committee.

3. Decides that pending approval of the study, contributions of Member States shall be assessed on the basis of the prevailing scale as approved by the Fifteenth Islamic Conference of Foreign Ministers.

#### **RESOLUTION NO. 4/18-AF**

#### **ON THE ARREARS OF CONTRIBUTIONS TO THE BUDGET OF THE OIC GENERAL SECRETARIAT AND SUBSIDIARY AND AFFILIATED CENTRES & INSTITUTIONS**

The Eighteenth Islamic Conference of Foreign Ministers (Session of Islamic Fraternity and Solidarity) held in Riyadh, Kingdom of Saudi Arabia, from 6 to 9 Sha'ban 1409H (13-16 March, 1989),

Aware of the important role played by the Organization of the Islamic Conference through the General Secretariat and the subsidiary organs, for consolidating Islamic Solidarity and cooperation and for defending Islamic causes;

Taking note of the report of the Secretary General on the financial condition of the OIC General Secretariat and its subsidiary organs;

1. Expresses deep concern over the financial difficulties of the General Secretariat and its Subsidiary Organs due to the delay in payment of contributions by some Member States, a situation that hinders the implementation of the activities entrusted to them;

2. Urges the Member States concerned to settle their financial obligations regularly.

3. Entrusts the Secretary General in consultation with the Chairman of the current 18th Islamic Conference of Foreign Ministers with the implementation of this resolution and to report thereon to the 19th Islamic Conference of Foreign Ministers.

4. Entrusts the Permanent Finance Committee with the task of studying the problem of accumulation of arrears of contributions of most of the Member States with a view to suggesting appropriate solutions to solve that problem and report thereon to the Nineteenth Islamic Conference of Foreign Ministers.

#### **RESOLUTION NO. 5/18-AF**

## **ON THE REPORT OF THE INTER-GOVERNMENTAL EXPERTS COMMITTEE ON THE REVIEW OF THE STAFF RULES AND REGULATIONS AND THE FINANCIAL REGULATIONS OF THE OIC GENERAL SECRETARIAT AND SUBSIDIARY ORGANS**

The Eighteenth Islamic Conference of Foreign Ministers (Session of Islamic Fraternity and Solidarity), held in Riyadh, Kingdom of Saudi Arabia, from 6-9 Shaban, 1409H (13-16 March, 1989),

Recalling the provisions of Resolution No.3/15-AF adopted by the Fifteenth Islamic Conference of Foreign Ministers establishing an Inter-Governmental Experts Committee to consider the draft Administrative and Financial Regulations of the OIC General Secretariat and its Subsidiary Organs;

1. Decides to extend the mandate of the Inter-Governmental Experts Committee in order to enable it to complete the study on the draft Staff Rules and Financial Regulations and to submit its report and the drafts to the General Secretariat.
2. Calls upon the General Secretariat to convene the next meeting of the Inter-Governmental Experts Committee within the next three months so that it may complete its study on the draft Administrative and Financial Regulations as well as consider the establishment of a Retirement Scheme for its personnel, the General Secretariat shall circulate the final report to Member States for consideration before its submission to the Nineteenth Islamic Conference of Foreign Ministers for adoption and implementation.

### **RESOLUTION No. 6/18-AF**

## **ON THE FUNCTIONING OF THE ORGANIZATION OF THE ISLAMIC CONFERENCE AND ITS SUBSIDIARY ORGANS, SPECIALIZED AND AFFILIATED INSTITUTIONS**

The Eighteenth Islamic Conference of Foreign Ministers (Session of Islamic Fraternity and Solidarity), held in Riyadh, Kingdom of Saudi Arabia, from 6-9 Shaban, 1409H (13-16 March, 1989),

Recalling previous resolutions of the Organization of the Islamic Conference, particularly resolution 12/17-AF adopted by the Seventeenth Islamic Conference of Foreign Ministers, on the functioning of the organization of the Islamic Conference and its subsidiary institutions, organs and centers;

Taking cognizance of the Report of the Fourth meeting of the Intergovernmental Experts Committee entrusted with the task of studying that matter, which was held in Jeddah, Kingdom of Saudi Arabia from 23 to 24 Rajab, 1409H (1-2 March, 1989);

Decides the following:

First: Strategy of joint Islamic action:

1. To entrust the Secretary General with the task of formulating a conception on ways and means of implementing a comprehensive strategy for joint Islamic action on the basis of the Declaration of Makkah Al-Mukarramah and the Economic Plan of Action adopted by the

Third Islamic Summit Conference, and other relevant resolutions adopted by the Islamic Conferences of Kings and Heads of State and Government, and Islamic Conferences of Foreign Ministers, it being understood that this conception would include a proposal for priority programmes in all sectors of joint Islamic action, together with a proposal for the appropriate tasks to be carried out in this context by the General Secretariat and OIC subsidiary organs and affiliated institutions.

2. The Secretary General in carrying out this task, shall seek the assistance of executive officials of OIC subsidiary organs and institutions, and the governmental experts whom he may select from among Member States.

3. The Secretary General shall submit his conception and proposals on ways and means of implementing the strategy for joint Islamic action and distribution of tasks among the General Secretariat and the OIC subsidiary organs and affiliated institutions to the Standing Committees set up by the Third Islamic Summit Conference held in Makkah Al Mukarramah, in order to ascertain their views, each within its field of competence.

4. The Secretary General shall submit a report regarding this matter to the Nineteenth Islamic Conference of Foreign Ministers.

Second: Structural Reforms.

1. The General Secretariat and OIC Subsidiary Organs and affiliated institutions shall carry out the tasks assigned to them by the Islamic Conferences of Kings and Heads of State and Government and to find ways and means to ensure rationalization of their activities and for creation of favourable conditions for their promotion.

2. The following is the classification of OIC Subsidiary organs, specialized and affiliated institutions:

**a) Subsidiary Organs:**

These are established within the framework of the Organisation of the Islamic Conference in accordance with a resolution adopted by the Islamic Conference of Kings and Heads of State and Government or the Islamic Conference of Foreign Ministers. Member States shall automatically become members of these organs and their budgets shall be approved by the Islamic Conference of Foreign Ministers.

**b) Specialized Organs:**

These are established within the framework of the Organization of Islamic Conference in accordance with a resolution adopted by the Islamic Conference of Kings and Heads of State and Government of the Islamic Conference of Foreign Ministers. Membership to these organs shall be optional and open to OIC Member States. Their budgets are independent of the budget of the General Secretariat and those of the subsidiary organs and are approved by their respective legislative bodies as stipulated in their Statutes.

**c) Affiliated Institutions:**

These group together entities or moral persons. Membership to this institutions is optional and open to institutions and organs of OIC Member States. Their budgets are independent of the budget of the General Secretariat and those of subsidiary and specialised organs. They were established under the auspices of the Islamic Conferences of Heads of State and Government or the Islamic Conference of Foreign Ministers. Affiliated institutions may be granted observer status by virtue of a resolution of the Islamic Conference of Foreign



Ministers. They may obtain voluntary assistance from the subsidiary and specialized organs as well as from Member States.

3. In accordance with the classification approved in Article 2 mentioned above:

**a) The subsidiary Organs are the following:**

- Statistical, Economic and Social Research and Training Centre for Islamic States (Ankara).
- Islamic Centre for Development of Trade (Casabalanca).
- Research Centre for Islamic History, Art and Culture(Istanbul).
- International Commission for the Preservation of the Islamic Heritage (Istanbul).
- Islamic Centre for Technical and Vocational Training and Research (Dhaka).
- Islamic Foundation for Science, Technology and Development, (Jeddah).
- Islamic Fiqh Academy (Jeddah).
- Islamic Solidarity Fund and its Waqf (Jeddah).
- Al-Quds Fund (Jeddah).

**b. The following are considered Specialized Organs:**

- The Islamic Development Bank (Jeddah).
- Islamic Educational Scientific and Cultural Organisations (Rabat).
- International Islamic News Agency (Jeddah).
- Islamic States Broadcasting Organization (Jeddah).
- Islamic Committee for International Crescent (Benghazi).

**c. The following are affiliated institutions:**

- The Organization of Islamic Capitals (Makkah Al-Mukarama).
- Islamic Shipowners Associations (Jeddah).
- Islamic Chamber of Commerce Industry and Commodity Exchange (Karachi).
- International Association of Islamic Banks (Cairo).
- Islamic Cement Association (Ankara).
- Sports Federation of Islamic Solidarity Games (Riyadh).
- World Federation of International Arab Islamic Schools (Jeddah).

Three: Internal Restructuring of the General Secretariat and its Subsidiary Organs and Coordination Between them and the Specialised and Affiliated Institutions.

1. Priority shall be given to strengthening and invigorating the subsidiary as well as specialised organs and affiliated institutions which are already functioning. Priority is given to the implementation of Resolution No.11/14-AF, adopted by the Fourteenth Islamic Conference of Foreign Ministers which stipulates that no new organ: shall be set up, and to postpone the establishments of Organs already approved but not yet functional which require financing from the OIC or whose activities duplicate the function of any existing Organ.

2. The OIC shall retain the subsidiary organs referred to in Chapter two para (3-a) above.

3. The Islamic Commission for Economic Cultural and Social Affairs, without prejudice to the provisions of paragraphs (7,8,12) of this Chapter, in addition to the functions constitutionally stipulated, shall assume the functions of a joint general assembly for all subsidiary organs. It shall be responsible for examining the economic, cultural and social programmes of activities pertaining to the General Secretariat and subsidiary organs and shall submit its recommendations to the Islamic Conference of Foreign Ministers. The Budgets of the General Secretariat and Subsidiary Organs shall continue to be examined by the Permanent Finance Committee.

4. Due account shall be taken of the need to ensure full coordination between the Islamic Commission for Economic Cultural and Social Affairs and the Permanent Finance Committee, particularly with regard to the drawing up of the budgets of the General Secretariat and subsidiary organs. The Secretary General shall ensure that the meetings of the Islamic Commission for Economic, Cultural and Social Affairs and that of the Permanent Finance Committee are held in a manner to fulfil this objective.

5. In selecting the members of the administrative, consultative or scientific Boards of the subsidiary organs, it shall be observed that they belong to Member States, and are competent and experienced in the field of the specialization of the subsidiary organs to which they are appointed. The principle of equitable geographical distribution shall also be observed as far as possible.

6. The Secretary General shall appoint the Director General of each subsidiary organ in consultation with the administrative or consultative or scientific board of the organ in question for a period of four years to be renewable only once.

7. The Islamic Fiqh Academy shall retain its present status in view of the particular nature of its work.

8. The International Islamic Commission for Economic, Cultural and Social Affairs shall retain its present status.

9. The Al Quds Fund and its Waqf shall retain their present status.

10. The Islamic Development Bank shall retain its present functions and its administrative executive and deliberative organs in view of the nature of its work.

11. The Islamic Educational, Scientific Organization (ISESCO) shall maintain its specialised institution and Cultural status as a specialized institution.

12. The Islamic Committee for International Crescent shall maintain its present status in view of the special nature of its work.

13. The International Islamic News Agency (IINA) and the Islamic States Broadcasting Organization (ISBO) shall be amalgamated to become the Islamic Communications Centre.

14. The fifth paragraph of the statute of the Islamic Solidarity Fund shall be amended as follows:

"The OIC General Secretariat shall carry out the administrative tasks needed for the functioning of the Fund under the supervision of the Permanent Council, while ensuring the full autonomy of the Fund's resources meant for consolidation of the Islamic Soidarity Fund and its Waqf. The General Secretariat shall bear the administrative expenses from the particular budget and within the limit of its staff cadre".

15. The Secretary General is requested to:

a) take the necessary measures to ensure that each internal set-up shall perform its duties, in accordance with the internal rules of the OIC General Secretariat.

b) define the duties and responsibilities of the Assistant Secretaries General for activation and coordination, each within his field of competence.

c) adopt scientific and practical policies for the appointment of personnel with a view to minimize operational expenditure and in keeping with the status of the OIC as an international organization.

d) directs the General Secretariat as well as subsidiary organs to rationalize expenditures, budgets for programmes and develop an effective new system for the collection of contributions.

16. Mandates the Secretary General to consider the possibility of reducing the number of posts of Assistant Secretaries General and similar posts; in terms of salaries with a view to rationalizing expenditures and submit thereon proposals to the Nineteenth Islamic Conference of Foreign Ministers.

17. To call upon the seven-member Expert Committee to hold a meeting as soon as possible to complete its study on the unified administrative, financial and auditing Systems of the General Secretariat and its subsidiary organs and submit its recommendations to the Nineteenth Islamic Conference of Foreign Ministers for approval of the final version of the unified systems.

18. To extend the mandate of the Committee of experts on functioning of OIC and its organs to consider other issues of coordination and cooperation which have not been covered by this resolution.

#### IV. Coordinating organs:

1- The General Secretariat shall establish a body for following up and coordinating activities between the General Secretariat, subsidiary organs, specialized and affiliated institutions staffed by employees of the General Secretariat provided that the establishment of such a body shall not entail new financial commitments.

2- The Secretary General shall convene an annual meeting for consultation and coordination between the activities of the General Secretariat and those of the Subsidiary and specialised organs; heads and Directors of these institutions shall attend the meeting to be presided by the Secretary General.

The Secretary General shall regularly submit a report on the subject to the Islamic Conference of Heads of States or Governments and an annual report to the Islamic Conference of Foreign Ministers.

#### V. Implementation of this resolution:

The Chairman of the Islamic Conference of Foreign Ministers assisted by the Secretary General shall follow up the implementation of this resolution and submit a progress report to the Islamic Conference of Foreign Ministers.
