RESOLUTION No. 1/46-AF

ON THE REPORT OF THE GENERAL SECRETARIAT ON THE FINANCIAL STATUS OF THE ARREARS OF MANDATORY CONTRIBUTIONS OF THE MEMBER STATES

The Forty- Sixth Session of the Council of Foreign Ministers, (Session: 50 Years of Islamic Cooperation: Roadmap For Prosperity And Development), held in Abu Dhabi, State of United Arab Emirates 24-25 Jumadah Al-Thani 1440 H (1-2 March 2019),

<u>Having considered</u> the report of the General Secretariat on the financial status of the arrears of the mandatory contributions of the member states towards its budgets;

<u>Pursuant to</u> the recommendations of the previous Sessions of the Permanent Finance Committee;

- 1. Urges the member states to pay their respective mandatory contributions towards the budgets of the General Secretariat and the Subsidiary Organs and, for the defaulting member states, to settle their arrears so as to enable the OIC institutions to carry out their mandated tasks.
- **2. Urges** the defaulting Member States to engage closer contacts with the General Secretariat to establish between them a workable mechanism and arrangements based on incentive measures offered that would to the eventual settlement of their respective Arrears.
- **3. Requests** the Secretary General of the OIC to report on status of the Arrears and the result of the incentive measures in the 47 Session of the CFM.

RESOLUTION No. 2/46-AF

ON THE AUTHORIZATION TO THE 48th PFC TO APPROVE THE BUDGETS OF 2020 OF THE GENERAL SECRETARIAT OF THE OIC AND ITS SUBSIDIARY ORGANS AND THE IPHRC

The Forty- Sixth Session of the Council of Foreign Ministers, (Session: 50 Years Of Islamic Cooperation: Roadmap For Prosperity And Development), held in Abu Dhabi, State of United Arab Emirates 24-25 Jumadah Al-Thani 1440 H (1-2 March 2019),

Recalling Financial Regulations of the OIC, according to which, the CFM has the authority to decide on the budget and other financial and administrative issues proposed by the PFC;

<u>Taking into Consideration</u> the fact that the last quarter of the financial year is the most appropriate time to submit the proposed annual budgets in with the new OIC financial year which coincides with the calendar years;

<u>Taking into consideration</u> the recommendations of the Senior Officials Meeting Preparatory to the 46th CFM on the General Secretariat's request to the latter to authorize the 48th PFC to approve the proposed budgets of the General Secretariat of the OIC and its subsidiary organs and Independent Permanent Human Rights Commission (IPHRC) for the financial year 2020;

- 1. **Decides** to grant an exceptional mandate to the 48th PFC to examine and approve, on behalf of the Council, the 2020 proposed budgets of the General Secretariat of the OIC and its Subsidiary Organs and the IPHRC.
- 2. **Requests** the OIC General Secretariat to convene the 48th PFC on 16-18 April 2019.
