Resolution 1/46-POA on

OIC-2025: Programme of Action

The Forty- Sixth Session of the Council of Foreign Ministers, (Session: 50 Years Of Islamic Cooperation: Roadmap For Prosperity And Development), held in Abu Dhabi, United Arab Emirates 24-25 Jumadah Al-Thani 1440 H (1-2 March 2019),

Referring to the objectives and principles enshrined in the Charter of the Organization of Islamic Cooperation (OIC);

Recalling the Declaration of the Third Extraordinary session of the Islamic Summit Conference (Makkah Al-Mukarramah, 7-8 December 2005) adopting the OIC Ten Year Programme of Action which concluded in December 2015;

Further recalling the Final Communique and the Declaration of the 13th Islamic Summit Conference (Istanbul, 14-15 April 2016) adopting the OIC-2025 as the Programme of Action for the current decade 2016-2025 presenting a comprehensive agenda for cooperation and partnership in various priority areas;

Appreciating the first Progress Report for the period 2016-17 giving out implementation status of programmes and activities as outlined in the updated Implementation Plan 2016-2025 presented to the 45th session of the Council of Foreign Ministers (Dhaka, 5-6 May 2018);

Further appreciating the steps taken during 2018 by the General Secretariat as well as all other organs and institutions in the OIC system as part of the on-going efforts to ensure effective implementation of the Programme of Action;

Having considered the report of the Secretary General and **taking note** of the second Progress Report for the period 2017-18 reflecting continued positive trend in the implementation of the OIC-2025;

- 1. Calls upon the Member States, all organs and institutions in the OIC system, relevant international and regional organisations and UN specialized agencies to undertake all necessary measures for effective implementation of the Programme of Action;
- 2. Invites the Member States to encourage relevant national authorities to indicate their interest in specific programmes and projects they wish to undertake independently or collectively in pursuit of the goals, programmes and activities of the OIC-2025. In this regard, the General Secretariat shall coordinate with the national authorities, OIC institutions and the international partners and harmonize proposals, where necessary, to match the national priorities with the agreed goals of the OIC-2025. A coordination meeting of relevant stakeholders shall be convened to concretize the specific proposals received from the member states;

- 3. Requests the Secretary General to organize mid-term review of the implementation of the OIC-2025 involving member states in the framework of the Committee of Permanent Representatives (CPR) and all relevant OIC institutions and organs in 2020 with a view to assessing the impact of its programmes and activities towards the realization of the approved goals and objectives; the relevant sections of the mid-term review of the implementation of the OIC-2025 will be subject to comprehensive review by the COMCEC, COMSTECH and COMIAC at their sessions in 2020;
- 4. **Requests** the Secretary General to coordinate with the relevant OIC organs and institutions including the Standing Committees and prepare annual progress report on the implementation of the OIC-2025 for the year 2019;
- 5. **Further requests** the Secretary General to report on the implementation of this resolution to the 47th session of the Council of Foreign Ministers for consideration.
