RESOLUTION 1/47-POA ON OIC-2025: PROGRAMME OF ACTION

The Forty-Seventh Session of the Council of Foreign Ministers of the Organization of Islamic Cooperation (United Against Terrorism for Peace and Development) held in Niamey, Republic of Niger, on 27-28 November 2020 (12-13 Rabi al Thani 1442H).

Reaffirming the objectives and principles enshrined in the Charter of the Organization of Islamic Cooperation (OIC);

Recalling the Declaration of the Third Extraordinary session of the Islamic Summit Conference (Makkah Al-Mukarramah, 7-8 December 2005) adopting the OIC Ten Year Programme of Action which concluded in December 2015;

Further recalling the Final Communique and the Declaration of the 13th Islamic Summit Conference (Istanbul, 14-15 April 2016) adopting the OIC-2025 as the Programme of Action for the current decade 2016-2025 presenting a comprehensive agenda for cooperation and partnership in various priority areas;

Bearing in mind the Final Communique of the 14th Islamic Summit Conference (Makkah Al-Mukarrama,31 May 2019) underlining the need for greater involvement and ownership of the member states through mainstreaming of the OIC programmes and activities in their national priorities;

Appreciating the Progress Report for the period 2017-18 giving out implementation status of programmes presented to the 46th session of the Council of Foreign Ministers (Abu Dhabi, 1-2 March 2019);

Further appreciating the steps taken during 2019 by the General Secretariat as well as all other organs and institutions in the OIC system as part of the on-going efforts to ensure effective implementation of the Programme of Action;

Having considered the report of the Secretary General and **taking note** of the Progress Report for the period 2018-19 reflecting impressive growth in the number of programmes and activities undertaken in the context of the OIC-2025;

- 1. Calls upon the Member States, all organs and institutions in the OIC system, relevant international and regional organisations and UN specialized agencies to undertake all necessary measures for effective implementation of the Programme of Action;
- 2. **Further calls upon** the member states to continue encouraging the relevant national authorities to indicate their interest in specific programmes and projects they wish to undertake independently or collectively in pursuit of the goals, programmes and activities of the OIC-2025. In this regard, the General Secretariat shall coordinate with the national authorities, OIC institutions and the international partners and harmonize proposals, where necessary, to match the national priorities with the agreed goals of the OIC-2025;
- 3. **Takes note** that the General Secretariat in cooperation with the SESRIC is preparing a comprehensive mid-term review document, "Road to 2025: Gains, Challenges and

Opportunities" and **requests** the member states, relevant institutions and organs including the standing committees namely COMCEC, COMSTECH, and COMIAC to actively take part in this process with a view to taking stock of the progress in realizing the agreed goals and objectives, and accelerating the same in the remaining years till 2025; **also requests** the General Secretariat to organize an intergovernmental expert group meeting with the participation of all relevant stakeholders namely the member states, relevant OIC institutions and organs, including the Standing Committees, for thoroughly considering the above-mentioned review document.

- 4. **Requests** the Secretary General to coordinate with the relevant OIC organs and institutions including the standing committees and prepare annual progress report on the implementation of the OIC-2025 for the year 2020;
- 5. **Further requests** the Secretary General to report on the implementation of this resolution to the 48th session of the Council of Foreign Ministers for consideration.
