### RESOLUTION 1/48-POA ON OIC-2025: PROGRAMME OF ACTION (POA)

The Forty-Eighth Session of the Council of Foreign Ministers of the Organization of Islamic Cooperation (Session of Partnering for Unity, Justice and Development) held in Islamabad, Islamic Republic of Pakistan, on 22 – 23 March 2022 (19-20 Shabaan 1443H).

**Reaffirming** the objectives and principles enshrined in the Charter of the Organization of Islamic Cooperation (OIC);

**Recalling** the Declaration of the Third Extraordinary Session of the Islamic Summit Conference (Makkah Al-Mukarramah, 7-8 December 2005) adopting the OIC Ten Year Programme of Action which expired in December 2015;

**Further recalling** the Final Communique and the Declaration of the 13<sup>th</sup> Islamic Summit Conference (Istanbul, 14-15 April 2016) adopting the OIC-2025 POA as the Programme of Action for the current decade (2016-2025) presenting a comprehensive agenda for cooperation and partnership in various priority areas;

**Bearing in mind** the Final Communique of the 14<sup>th</sup> Islamic Summit Conference (Makkah Al-Mukarramah, 31 May 2019) underlining the need for greater involvement and ownership of the OIC-2025 POA by the Member States through mainstreaming of the OIC programmes and activities in their national priorities;

**Appreciating** the Progress Report for the period 2018-2019 highlighting the implementation status of programmes presented to the 47<sup>th</sup> Session of the Council of Foreign Ministers (Niamey, 27-28 November 2020);

**Further appreciating** the steps taken during 2021 by the General Secretariat as well as all other organs and institutions in the OIC system as part of the on-going efforts to ensure effective implementation of the Programme of Action;

**Having considered** the report of the Secretary General and **taking note** of the Progress Report for the period 2019-2021 reflecting impressive growth in the number of programmes and activities undertaken in the context of the OIC-2025 POA;

- 1. **Calls upon** the Member States to undertake all necessary measures for effective implementation of the Programme of Action through domesticating the goals in their respective national socio-economic development programmes;
- 2. **Calls upon** all organs and institutions in the OIC to coordinate their actions for the effective implementation of the OIC-2025 POA;
- 3. **Further calls upon** the Member States to continue encouraging the relevant national authorities to undertake specific programmes and projects in pursuit of the goals, programmes and activities of the OIC-2025 POA. In this regard, the Member States are invited to regularly submit reports on the implementation of the OIC-2025 POA, so as to

have them included in the OIC annual progress report on the implementation of the OIC-2025 POA.

- 4. **Welcomes** the organization by the Arab Republic of Egypt, throughout 2022 in Cairo, of a series of climate change impact mitigation and disaster risk reduction capacity-building workshops and training sessions for the Member States, in line with goal 2.5.2 under priority 5 "Environment, Climate Change and Sustainability" of the OIC-2025 POA.
- 5. Takes note with appreciations of the efforts of the General Secretariat, in cooperation with the SESRIC, in preparing a comprehensive Mid-Term Review Document, entitled "*Road to 2025: Gains, Challenges and Opportunities*" and endorses the recommendations of the Intergovernmental Expert Group Meeting held at the General Secretariat Headquarters, on 27-28 December 2021 to consider the Mid-Term Review Document.
- 6. **Calls upon** the Member States to provide SESRIC with necessary appropriate data and information in a timely fashion, relevant to the goals and objectives of the OIC-2025 POA.
- 7. **Urges** the General Secretariat in cooperation with SESRIC to proceed with a comprehensive update of the Mid-Term Review Document to be finalized early 2023 for consideration of the Member States and subsequent submission to the 49<sup>th</sup> Session of the Council of Foreign Ministers.
- 8. **Requests** the Secretary General to coordinate with the relevant OIC organs and institutions, including the Standing Committees, the implementation of the Programme of Action and continue submitting progress reports on the implementation of the said programme on annual basis;
- 9. **Further requests** the Secretary General to report on the implementation of this Resolution to the 49<sup>th</sup> Session of the Council of Foreign Ministers for consideration.
