**RESOLUTION No. 1/40-AF**  
**ON THE REPORTS OF THE 40<sup>TH</sup> SESSION OF THE PFC**  
**AND THE 34<sup>TH</sup> SESSION OF THE FCO**

*The Council of Foreign Ministers in its fortieth session*  
*(Session of Dialogue of Civilizations, Factor for*  
*Peace and Sustainable Development), held in Conakry, Republic of*  
*Guinea, from 06 to 08 Safar 1435H (09<sup>th</sup> – 11<sup>th</sup> December 2013),*

**Having considered** the report of the 42<sup>nd</sup> Session of the Permanent Finance Committee (PFC),

**Having considered** the report of the 34<sup>th</sup> Session of the Finance Control Organ concerning the closing accounts of the General Secretariat and its subsidiary organs for the financial year 2012, and the replies of the General Secretariat and the subsidiary organs on the observations made in this respect,

**Pursuant to** the recommendations of the 42<sup>nd</sup> Session of the Permanent Finance Committee;

- 1. Adopts** the report of the 42<sup>nd</sup> Session of the Permanent Finance Committee (PFC),
- 2. Adopts** the whole report of the 34<sup>th</sup> Session of the Finance Control Organ (FCO) after reviewing the responses and clarifications of the General Secretariat;
- 3. Request** the General Secretariat and its subsidiary organs to abide with the recommendation and observations of FCO in its 34<sup>th</sup> report specially on:
  - i) Transfer of the surplus resulting from an increase of resources over expenditures in the closing accounts of previous years to the Reserve Account.
  - ii) Appointments of staff members in line with the rules and regulations of the OIC by informing vacancies to all Member States. The recruitment should respect the criteria of geographical distribution, competence and the proportion of contributions of Member States; and the General Secretariat shall inform Member States which submitted applications of their candidates about the final decision taken.
- 4. Approves** the decision of the PFC to add a new chapter on the FCO reports entitling “Compliance Assessment”, which aims at providing the Member

States on a report on compliance of the General Secretariat and the Subsidiary Organs with the FCO recommendations.

5. **Requests** the General Secretariat to carry out a comprehensive study on staff members of the General Secretariat and its subsidiary organs, to re-structure the recruitment of personnel, which would give a clear picture on considering equitable geographical distribution, competence and the proportion of contributions of Member States criteria; and to submit its report to the 43rd PFC session.

  - b. The new chapter of rules to the existing Financial Regulations of the OIC to govern the OIC Humanitarian Affairs Department Field Operations.

1. **Adopts** the budget of the General Secretariat and its subsidiary organs for the Financial Year 2014 in accordance with financial rules and regulations of the OIC, and as follows:

  - f) **Islamic University of Technology (IUT), Dhaka - 4,464,000 USD.**
  - g) **Islamic Center for Development of Trade (ICDT), Casablanca - 2,415,000 USD.**
