ON THE
IMPLEMENTATION OF THE OIC TEN-YEAR PROGRAMME OF ACTION
(TYPOA)**

The Thirty-sixth Session of the Council of Foreign Ministers (Session of Enhancing Islamic Solidarity), held in Damascus, Syrian Arab Republic, from 28 Jumada Al-Awal to 1st Jumada Al-Thani, 1430H, (23-25 May 2009);

Considering the Declaration of the Third Extraordinary Session of the Islamic Summit Conference held in Makkah Al-Mukarramah, Kingdom of Saudi Arabia on 6 to 7 Dhul Qaidah 1426H (7-8 December 2005),

Welcoming the adoption of the OIC Ten-Year Programme of Action (TYPOA) to meet the challenges facing the Muslim Ummah in the 21st Century;

Taking Note that the OIC Ten Year Programme of Action provides the Islamic Ummah with a new forward-looking vision that enables the Islamic world to address the challenges of the Twenty-first Century by leveraging on the collective will and Joint Islamic Action;

Underlying the need to ensure sustainable development of Member States through effective policy to protect the environment.

Considering the resolution of the 11th Islamic Summit Conference on Economic Affairs which was held in Dakar, Republic of Senegal on 13-14 March 2008;

Further considering the resolution of the 35th Conference of Foreign Ministers of OIC Member States, held in Kampala, Uganda on 18-20 June, 2008;

1. **Underlines** the pivotal role of the OIC General Secretariat in the implementation of the TYPOA and appreciates the progress achieved so far through the actions taken by the OIC General Secretariat, Standing Committees, Subsidiary Organs and Specialized and Affiliated Institutions and **invites** them to exert more concerted efforts for a speedy implementation of the TYPOA and in the same context, pays tribute to the Secretary General for his leadership and distinct contribution in the implementation of this programme.

2. **Calls upon** the Member States to contribute to the implementation of the TYPOA through their full political, moral and financial support and **invites** the Member States to establish national committees and national focal points for the implementation of the OIC Ten-year Program of Action.

3. **Calls on** all Member States, in accordance with the vision and mandate of the TYPOA, to sign and ratify Agreements and Protocols, aiming at fostering cooperation within the OIC Member States and joint Islamic action with a view of preparing the Muslim Ummah to face effectively the challenges of the 21st century.

4. Decides to organize mid term review meetings in 2010 during the ordinary sessions of the OIC Standing Committees: the Standing Committee on Information and Cultural Affairs (COMIAC) , the Standing Committee on Economic and Commercial Cooperation (COMCEC), and the Standing Committee on Scientific and Technological Cooperation (COMSTECH) with a view to undertaking practical review of the implementation of the Ten-Year Programme of Action and to taking necessary measures towards effective and timely implementation of this programme.

5. **Invites** the Secretary General to follow up the implementation of the present resolution and report thereon to the 37th Session of the Council of Foreign Ministers.
